Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mission Bio, Inc. Retirement Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Mission Bio, Inc. Retirement Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

A. General

The Plan is a defined contribution plan that was established by Mission Bio, Inc. (the “Company”) to provide benefits to eligible employees, as defined in the Plan document. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

B. Administration

The Company designated Empower Trust Company, LLC as trustee and their affiliate, Empower Retirement Services as third-party administrator.

C. Eligibility

Substantially all employees of the Company are eligible to participate in the Plan. Plan entry is upon commencement of employment.

D. Participant Contributions

Participants may contribute a specific percentage or dollar amount up to 100% of pretax annual compensation, or Roth deferrals, as defined in the Plan document and within the annual dollar limit set by the Code. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants who make pre-tax contributions to the Plan receive an equivalent reduction in taxable compensation.

E. Company Contributions

The Company may make discretionary matching contributions as defined in the Plan and approved by the Board of Directors. No employer contributions were made for the year ended December 31, 2024.

F. Participant Accounts

Each participant’s account is credited with the participant’s contributions, rollover contributions, Company contributions and an allocation of Plan earnings or losses and expenses. Participants may direct their investments among a diversified menu of core investment funds offered under the Plan. Assets of the Plan are invested based solely on participant directions.

The contributions of participants who decline to make an investment election are invested in the Vanguard target retirement fund that is appropriate for the individual’s age and projected date of retirement.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

G. Vesting and Forfeitures

Participants are immediately 100% vested in their accounts under the Plan.

H. Expenses

Investment fund operating expenses, brokerage, administrative and trust fees are charged directly to the investment funds and are thereby factored into each investment fund as a reduction of investment return. Participant loan administration and benefit payment processing costs are charged directly to participants. Other costs incurred for administering the Plan may be paid by the Plan or the Company.

I. Payment of Benefits

Normal retirement age under the Plan is 65. Participants are eligible for benefits upon attainment of age 59 ½, retirement, disability or termination of service. A participant's benefit under the Plan is equal to his or her account balance. Benefits are payable in a lump sum. The accounts of terminated participants valued at \$7,000 or less who do not make an affirmative election concerning distribution of their accounts may be distributed by the plan administrator in accordance with applicable provisions of the Code.

J. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's vested account balance, bears interest at a rate equal to 1% above the prime rate and must be repaid to the Plan within a five-year period, unless a loan is used for the purchase of a principal residence in which case the term can be extended. Principal and interest are paid ratably through payroll deductions. The participant note outstanding at December 31, 2024 carries an interest rate of 5.25% with a maturity through October 2051. The participant note receivable is measured at the unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on terms of the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded when settled and interest and dividend income is recorded when received. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

C. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

D. Payment of Benefits

Benefits are recorded when paid.

E. Risks and Uncertainties

Investments include a variety of securities that are exposed to various investment risks such as interest rate, market, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - PARTY-IN-INTEREST TRANSACTIONS

Certain investments held by the Plan are managed by the trustee and its affiliate. Purchases and sales of these investments and payment of expenses to Plan service providers from Plan assets are considered party-in-interest transactions under ERISA. Such transactions are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 4 - INCOME TAX STATUS

The Company adopted a prototype plan that has received a favorable opinion letter from the Internal Revenue Service stating that the form of the Plan qualifies under applicable provisions of the Code. The Company believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation of investments, dividends and interest for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC.

NOTE 6 - FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value as follows: Level 1 refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2 refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3 refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified based on the lowest level of input that is significant to the fair value measurement.

Mutual funds are valued at the daily closing price reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

NOTE 8 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 15, 2025, the date on which the financial statements were available to be issued. There are no material subsequent events that require recognition or additional disclosure in the Plan's financial statements.
