Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Central Storage & Warehouse LLC 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Central Storage & Warehouse LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note H to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

NOTE A | SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of the Central Storage & Warehouse LLC 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General*

The Plan was adopted January 1, 2022, and restated effective September 1, 2024. It is a defined contribution plan and a profit sharing 401(k) plan under Section 401(k) of the Internal Revenue Code covering all eligible employees of Central Storage & Warehouse LLC (Plan Sponsor).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. *Administrative Fees*

Total administrative expenses paid by the Plan were \$20,350 and \$17,545 for the years ended December 31, 2024 and 2023, respectively.

3. *Contributions*

Participants may elect to contribute a percentage of their compensation to the Plan up to the maximum amount allowable under the current Internal Revenue Code. In addition to the participants' contributions, the Plan Sponsor matches participants' deferrals. The Plan Sponsor provided a safe-harbor match equal to 100% of the first 3% and 50% of the next 2% of eligible compensation contributed by participants to the Plan. The Plan Sponsor's safe-harbor matching contributions totaled \$296,053 and \$267,969 for the years ended December 31, 2024 and 2023, respectively .

Additionally, the Plan Sponsor made an elective profit-sharing contribution to the Plan totaling \$526,304 and \$461,028 for the years ended December 31, 2024 and 2023, respectively.

4. *Participant Accounts*

Each participant's account is credited with the participant's contribution, Plan Sponsor's contributions, and an allocation of Plan earnings. Plan earnings are allocated to each of the participants at the end of the day based on the individual participant's balances at the beginning of the day as a percent of the total participants' beginning balances. Forfeitures may be used to offset employer contributions to the Plan. Total forfeitures were \$21,306 and \$3,635 for the years ended December 31, 2024 and 2023, respectively. The Company offset employer contributions with forfeitures of \$6,248 and \$-0- for the years ended December 31, 2024 and 2023, respectively. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

5. *Vesting*

Participants are immediately 100 percent vested in the participant's contributions. The Plan Sponsor's safe-harbor matching contributions and elective profit-sharing contributions vest over a 6-year period.

6. *Payment of Benefits*

On termination of service, death, disability, or retirement, a participant may receive a lump sum amount equal to the value of the participant's interest in his or her account. A participant that terminates employment whose account balance is less than \$5,000 will receive a distribution of their account. In-service withdrawals of all or a portion of the participant's vested account balance are also permitted upon the participant's attainment of age 59 ½. Under certain conditions, participants may receive a hardship distribution.

7. *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 and to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participants' accounts and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the plan administrator. Interest rates range from 4.25 percent to 9.50 percent. Principal and interest are paid ratably through payroll deductions.

The Plan deems all participant notes receivable to be fully collectible; therefore, no allowance for uncollectible accounts is required. Participant notes receivable are treated as distributions when they are determined to be uncollectible.

8. *Use of Estimates*

Management uses estimates and assumptions in preparing financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported revenues and expenses. Actual results could vary from the estimates that were used.

9. *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

10. *Income Tax Status*

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS), stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

11. *Subsequent Events*

Management has evaluated subsequent events for recognition and disclosure in the financial statements through August 22, 2025, which is the date the financial statements were available to be issued. No subsequent events required recognition or disclosure.

NOTE B | INVESTMENTS

The Plan's investments are participant directed and held by a trust company. Participants may direct their contributions into any of the investment options offered by the Plan. Investment option changes and transfers may be made by the participants on a daily basis.

NOTE C | RISKS AND UNCERTAINTIES

Investments, in general, are inherently subject to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that a change in the value of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and statements of changes in net assets available for benefits.

NOTE D | FAIR VALUE MEASUREMENT

The Plan follows the fair value measurement guidance for financial assets and financial liabilities. The guidance defines fair value, establishes a framework for measuring value, and expands disclosure about fair value measurements. In addition, the guidance permits an entity to measure eligible financial instruments and other items at fair value. The Plan has not made any fair value elections.

Fair value is defined to be the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. A three-level hierarchy has been established for fair value measurements based upon the inputs to the valuation of an asset or liability as follows:

- Level 1 - Valuation is based on quoted prices for identical assets and liabilities in active markets.
- Level 2 - Valuation is derived from inputs, other than quoted prices included in Level 1, which are observable for the asset or liability either directly or indirectly. Investments classified as Level 2 are generally valued by benchmarking model-derived prices to quoted market prices and trade data for identical or comparable securities. The significant inputs used in this approach include interest rates, prepayment timing, yield spreads, maturities, credit losses, and credit ratings of the securities.
- Level 3 - Valuation is derived from unobservable inputs that are not corroborated by market data.

The fair value of mutual funds is equal to the net asset value of the funds multiplied by the number of shares held by the Plan, primarily using quoted market prices. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan invests in a collective trust, which provides for various investment options. Fair values of the collective trust are reported to the Plan based on the NAV of the units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.
