### **Note 1: Description of Plan**

The following description of the SMTBNY 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The plan is a defined contribution plan and profit sharing plan covering a majority of the employees of the Sumitomo Mitsui Trust Bank, Limited (the "Company"). Sumitomo Mitsui Trust Asset Management Americas, Inc. was added as a participating employer to the Plan effective April 1, 2020. The Plan does not have service and age requirements as criteria for participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Retirement Committee oversees governance of the Plan. The Retirement Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### **Eligibility**

Eligible employees include all employees of the Company, who are not leased employees, nonresident aliens and/or expatriates.

#### **Contributions**

Participants may contribute up to 80% of compensation (as defined) each plan year through payroll deductions, subject to certain IRS limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan. The plan currently offers various mutual funds as investment options for participants' contributions to the plan, which are generally not subject to federal, state and local income taxes until withdrawn by the participant from the Plan. The Plan allows Participants to make Roth 401(k) contributions that are includable in the participants' gross income. The Plan includes an auto-enrollment provision whereby, all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 10% percent of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. The Company matches up to 50% of the first 6% of compensation (as defined) contributed by a participant. Matching contributions totaled \$947,001 for the plan year ended December 31, 2024.

The Company may make discretionary contributions to the Plan for the benefit of eligible participants employed by the Company as of December 31, 2024. The Company provided for a contribution of \$1,198,565 for the year ended December 31, 2024. The contributions were equal to 3% of eligible compensation. The Company made this contribution to the Plan in January 2025.

### **Note 1: Description of Plan** (Continued)

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their voluntary 401(k) and Roth contributions plus actual earnings thereon. Vesting in the remainder of their accounts, including the profit sharing contributions, is based on years of credited service. A participant is 50% vested after two years, 75% vested after three years and is fully vested after four years of credited service.

#### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%. The loan interest rate, determined monthly, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes Fund. All loans must be repaid within 5 years unless it is for the purchase of a principal residence in which case the loan repayment period may not extend beyond 10 years from the date of the loan.

#### **Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, hardship distributions from the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

#### **Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$42 and \$116, respectively. These accounts will be used to reduce future Plan contributions or to pay administrative expenses of the Plan in accordance with the plan document. During the year ended December 31, 2024, employer contributions were reduced by \$179,897 from forfeited nonvested accounts.

#### **Funding**

The Plan funds the employee and employer contributions on a semi-monthly basis.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

All administrative expenses of maintaining the Plan are paid by the Company, with the exception of administrative costs incurred for the processing of Participant loans. These costs are borne by the Participant requesting the loan. Expenses that are paid by the Company are excluded from these financial statements. Investment management expenses are netted against investment returns and are included in net appreciation in fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through August 25, 2025, which is the date the financial statements were available to be issued.

### **Note 3: Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

### Note 3: Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end investment companies that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the investment will sell for an amount different than the reported NAV.

### Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan.

### Note 5: Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan sponsor has agreed to bear all of the administrative costs associated with the Plan for the year ended December 31, 2024, with the exception of administrative costs incurred for the processing of participant loans. These costs are borne by the participant requesting the loan.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Plan contributions.

Upon termination, the Retirement Committee may take necessary steps to have the assets of the Plan distributed among participants, or the Retirement Committee may elect to continue the Plan and make distributions in accordance with the Plan instrument.

### **Note 7: Tax Status**

The Plan has elected to rely on the favorable opinion letter issued to volume submitter plan provider (Fidelity Management & Research Co.) as permitted by Revenue Procedure 2002-6. In addition, the plan administrator believes that the plan is designed, currently being operated and in compliance with applicable requirements of the IRC, and therefore, qualified, and the related trust exempt from taxation.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Users of these financial statements should be aware that the financial markets' volatility may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

### **Note 1: Description of Plan**

The following description of the SMTBNY 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The plan is a defined contribution plan and profit sharing plan covering a majority of the employees of the Sumitomo Mitsui Trust Bank, Limited (the "Company"). Sumitomo Mitsui Trust Asset Management Americas, Inc. was added as a participating employer to the Plan effective April 1, 2020. The Plan does not have service and age requirements as criteria for participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Retirement Committee oversees governance of the Plan. The Retirement Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### **Eligibility**

Eligible employees include all employees of the Company, who are not leased employees, nonresident aliens and/or expatriates.

#### **Contributions**

Participants may contribute up to 80% of compensation (as defined) each plan year through payroll deductions, subject to certain IRS limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan. The plan currently offers various mutual funds as investment options for participants' contributions to the plan, which are generally not subject to federal, state and local income taxes until withdrawn by the participant from the Plan. The Plan allows Participants to make Roth 401(k) contributions that are includable in the participants' gross income. The Plan includes an auto-enrollment provision whereby, all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 10% percent of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. The Company matches up to 50% of the first 6% of compensation (as defined) contributed by a participant. Matching contributions totaled \$947,001 for the plan year ended December 31, 2024.

The Company may make discretionary contributions to the Plan for the benefit of eligible participants employed by the Company as of December 31, 2024. The Company provided for a contribution of \$1,198,565 for the year ended December 31, 2024. The contributions were equal to 3% of eligible compensation. The Company made this contribution to the Plan in January 2025.

### **Note 1: Description of Plan** (Continued)

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their voluntary 401(k) and Roth contributions plus actual earnings thereon. Vesting in the remainder of their accounts, including the profit sharing contributions, is based on years of credited service. A participant is 50% vested after two years, 75% vested after three years and is fully vested after four years of credited service.

#### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%. The loan interest rate, determined monthly, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes Fund. All loans must be repaid within 5 years unless it is for the purchase of a principal residence in which case the loan repayment period may not extend beyond 10 years from the date of the loan.

#### **Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, hardship distributions from the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

#### **Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$42 and \$116, respectively. These accounts will be used to reduce future Plan contributions or to pay administrative expenses of the Plan in accordance with the plan document. During the year ended December 31, 2024, employer contributions were reduced by \$179,897 from forfeited nonvested accounts.

#### **Funding**

The Plan funds the employee and employer contributions on a semi-monthly basis.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

All administrative expenses of maintaining the Plan are paid by the Company, with the exception of administrative costs incurred for the processing of Participant loans. These costs are borne by the Participant requesting the loan. Expenses that are paid by the Company are excluded from these financial statements. Investment management expenses are netted against investment returns and are included in net appreciation in fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through August 25, 2025, which is the date the financial statements were available to be issued.

### **Note 3: Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

### Note 3: Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end investment companies that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the investment will sell for an amount different than the reported NAV.

### Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan.

### Note 5: Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan sponsor has agreed to bear all of the administrative costs associated with the Plan for the year ended December 31, 2024, with the exception of administrative costs incurred for the processing of participant loans. These costs are borne by the participant requesting the loan.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Plan contributions.

Upon termination, the Retirement Committee may take necessary steps to have the assets of the Plan distributed among participants, or the Retirement Committee may elect to continue the Plan and make distributions in accordance with the Plan instrument.

### **Note 7: Tax Status**

The Plan has elected to rely on the favorable opinion letter issued to volume submitter plan provider (Fidelity Management & Research Co.) as permitted by Revenue Procedure 2002-6. In addition, the plan administrator believes that the plan is designed, currently being operated and in compliance with applicable requirements of the IRC, and therefore, qualified, and the related trust exempt from taxation.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Users of these financial statements should be aware that the financial markets' volatility may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.
