Note 1 - Plan Description

The following brief description of the MGC, Inc. 401(k) Plan (the Plan) is provided for general information only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Max Grigsby Company, Inc. (the Company and the plan administrator) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was initially adopted by the Company on September 1, 1997 and has since been amended and restated. Empower Trust Company, LLC serves as the asset custodian of the Plan. The plan administrator is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance. TI-TRUST, Inc. serves as the Plan's trustee.

Eligibility

Participation in the Plan is available for all eligible employees of the Company, as defined, who are at least 21 years of age, and have completed one year of service. Eligible employees may participate in the Plan on the first day of each plan quarter coinciding with or following the date at which the employee meets the eligibility requirements. The Plan includes a savings feature designed to permit the employees and the Company to contribute to the Plan, at amounts allowable under Section 401(k) of the Internal Revenue Code (IRC).

Contributions

Upon meeting eligibility requirements, employee pre-tax contributions are made to the Plan by electing to defer a percentage of their compensation in an amount equal to but not less than 1% and not more than 18%, subject to the maximum limits allowed by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan also accepts rollover contributions from other qualified plans or individual retirement accounts.

The Company makes employer matching contributions equal to 50% of the participant's contribution, excluding catch-up contributions, not to exceed 2% of compensation on a payroll-by-payroll basis. The Company may also make discretionary nonelective contributions on behalf of eligible employees. For the year ended December 31, 2024, the Company did not make nonelective contributions.

Vesting and Forfeitures

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in Company contributions is based on years of service. A participant's interest in Company contributions begins at 20% after one year of service and increases 20% for each additional year of service until the employee is 100% vested after five years. Regardless of the vesting schedule, participants become fully vested upon death, normal retirement or disability.

There were \$185 and \$174 of forfeited non-vested amounts available at December 31, 2024 and 2023, respectively. Forfeitures are used to reduce future matching contributions. For the year ended December 31, 2024, \$1,562 of forfeitures were utilized to reduce matching contributions.

Participant Accounts

Upon enrollment in the Plan, a participant may direct the asset custodian with regard to the investment of his or her account balance. Participants may change their investment options daily.

Each participant's account is credited with the participant's contributions, the Company's contributions, plan earnings and losses, and charged with certain transactional fees.

Notes Receivable from Participants

Notes receivables from participants are loans to participants secured by the vested portion of their accounts. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance during the preceding 12 months, or 50% of their account balances. A participant may not have more than two loans outstanding at any time. Interest rates are based on the prime rate plus 1%. Principal and interest are generally repaid through payroll deductions. Loan terms are limited to five years unless for the purchase of a principal residence, in which case the term may be extended to 10 years.

Benefit Payments

Distributions may be made to participants or their beneficiaries upon termination of employment, retirement, disability or death, as applicable. In-service distributions are allowed for participants who have reached the age of 59½. Additionally, hardship withdrawals may be made to active participants who have demonstrated financial need, subject to the provisions of the Plan. Distributions from the Plan may be paid in the form of a lump sum distribution or installment payments for participants subject to lifetime required minimum distributions. Upon withdrawal from the Plan or termination of employment, participants with an account balance of \$1,000 or less shall receive an automatic lump sum distribution from the Plan. Withdrawals from the Plan may be subject to income taxes on contributions and income earned.

Note 2 - Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of the investments includes realized gains and losses on investments bought and sold during the year, as well as unrealized gains or losses on the investments held at the end of the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023, as the notes are collateralized by the participant's account balance. In general, notes receivable from participants are placed into default in the calendar quarter following the quarter in which no payment on the note is made, and such defaults are recognized as distributions based upon the terms of the plan document when a distributable event has occurred.

Benefit Payments

Benefits paid to participants or beneficiaries are recorded when paid.

Administrative Expenses

Loan fees and certain other transactional fees are paid by the participant. Administrative expenses not paid by the Company are charged to and paid by the Plan.

Excess Contributions Refundable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

Risks and Uncertainties

The Plan provides for investments in mutual funds. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and may impact participants' account balances and the amounts reported in the financial statements.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and the disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Subsequent Events

The plan administrator evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 3, 2025, which is the date the financial statements were available to be issued.

Note 3 - Information Certified by the Plan's Asset Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from Empower Trust Company, LLC as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that all of the information provided is complete and accurate. Information included in the financial statements and the accompanying notes to the financial statements as to investments, notes receivable from participants, investment income, interest income on notes receivable from participants, and all of the related information in the supplemental schedule of assets (held at end of year), is presented in reliance solely upon these certifications.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements, the accompanying notes to the financial statements and the supplemental schedule of assets (held at end of year).

Note 4 - Fair Value Measurements

GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Note 6 - Federal Income Tax

The pre-approved plan document received an opinion letter from the IRS dated June 30, 2020, stating that it was in compliance with the applicable requirements of the IRC. The pre-approved plan document has since been amended; however, the plan administrator believes that the Plan, through its adoption of the pre-approved plan document, is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Party-in-Interest Transactions

The Plan engages in transactions with participants related to notes receivable, which are party-in-interest transactions with respect to the Plan. These transactions are covered by an exemption from the "prohibited transactions" provisions of ERISA and the IRC.

Note 8 - Nonexempt Transactions

As disclosed in the supplemental Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, there were unintentional delays in remitting \$8,823 of participant contributions and \$1,732 of participant loan repayments to the Plan. Lost earnings on these untimely remittances of \$130 were remitted to the Plan during 2025.
