We have performed audits of the financial statements of Capsa Solutions, LLC 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 – DESCRIPTION OF PLAN

The following description of the Capsa Solutions, LLC (the “Company”) 401(k) Savings Plan (the “Plan”), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering employees of the Company who have completed 90 consecutive calendar dates of service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Each year, participants may contribute a maximum dollar amount as determined by the Internal Revenue Service (IRS). For 2024, the maximum dollar amount was \$23,000. Eligible participants who have attained age 50 prior to the close of a Plan year are also eligible to make a catch-up contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Employees are automatically enrolled at a 6% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a number of investment options in mutual funds, collective trusts, pooled separate accounts, and a guaranteed investment contract managed by Principal Financial Group. The Company, on a discretionary basis, contributes a matching amount as a percentage of the amount a participant contributes to the Plan. For the year ended December 31, 2024, the discretionary match was 50% of the first 6% deferred by the employee. Contributions are subject to certain limitations. During 2024, the Company contributed \$769,358 to the Plan.

Participant Accounts: Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contribution and Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are immediately vested in their contributions, rollovers and employer matching contributions plus actual earnings thereon.

Funding Policy: The Plan is funded through participant contributions, discretionary employer matching contributions, and investment earnings. The employer does not have a fixed funding obligation. Contributions are intended to provide benefits to participants in accordance with the terms of the Plan and are deposited with the trustee as soon as practicable after being withheld from payroll. The Plan does not guarantee any specific benefit level and benefits are limited to the value of the participant’s vested account balance at the time of distribution.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Participants may have one loan outstanding at a time with up to two loans permitted in a 12-month period. Loan terms range from 1 to 5 years or up to a reasonable period of time for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear interest at a reasonable rate determined by Plan Administrator by reviewing the interest rates charged for similar types of loans by other lenders. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: If a participant’s employment ceases as a result of normal retirement, death, or disability, the participant or the participant’s beneficiaries, are entitled to receive the entire contents of the account. Participants will receive benefits in a single lump sum. In certain circumstances, participants may make “hardship withdrawals” as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Administrative Expenses: The costs of administering the Plan are paid for by the Company with the exception of fees charged by the trustee of the Plan, which are paid for by the Plan and are reflected in the financial statements as administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation: The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Risks and Uncertainties: The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations, liquidity, and credit risks, as well as risks associated with ongoing global events. Due to the risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in market values, interest rates, or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Benefit Payments: Benefit payments are recorded when paid.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America required the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

NOTE 3 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2 – Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 – Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The following are descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of its investments.

Mutual Funds – The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (level 1 inputs).

Pooled Separate Accounts – The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers which is available to current investors via the Employer website or when Plan participants access their account and is therefore readily determinable (level 1 inputs). Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements, and has redemption prices that are determined by the fund's net asset value per unit.

Collective Trusts – The fair values of participation units in the collective trusts are based upon the net asset values per unit as reported by the fund managers which is available to current investors via the Employer website or when Plan participants access their account and is therefore readily determinable (level 1 inputs). The collective trusts generally provide for daily redemptions by the Plan at reported net asset value per share with no advance notice requirements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of December 31, 2024 and 2023, the Plan held investments at fair value totaling \$1,479,651 and \$1,458,419, respectively, that were not certified by the Delaware Charter Guarantee and Trust Company. These investments are held by a financial institution that is not a qualified institution under 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations under ERISA and, as such, did not provide a certification as to their completeness and accuracy. For the year ended December 31, 2024, these uncertified investments generated net appreciation in fair value totaling \$119,014.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a traditional investment contract, which is a fully benefit-responsive investment contract that is reported at contract value. The contract value is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the Plan’s fully benefit-responsive investment contract as of December 31 is as follows:

The fully benefit-responsive group annuity investment contract is held with Principal Life Insurance Company (Issuer) through the Principal Fixed Income Guaranteed Option. The methodology for calculating the interest crediting rate is defined in the contract under the term “Composite Crediting Rate,” as defined in Amendment 8 to the Group Annuity Contract. This rate is determined based on a formula outlined in the Applicable Vintage Schedule and reflects the dollar-weighted aggregation of guaranteed interest balances and expected net cash flows across various deposit periods. The Composite Credit Rate is reviewed and may be reset on a periodic basis and is never less than the Guaranteed Minimum Interest Rate (“GMIR”). The GMIR for balances associated with rate schedules effective on or after December 30, 2022 cannot be less than 0.15% or greater than 3%. The key factors that influence future interest crediting rates could include the following: the level of market interest rates; the amount and timing of participant contributions, transfers and withdrawals into/out of the contract; and the duration of the underlying investments backing the contract. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract values for credit risk of the contract issuer or otherwise. The Plan’s investment contract does not specify certain conditions under which distributions from the contract would be payable at amounts below contract value. The terms and methods under which the contract may transact are defined in Article II (Deposits and Funds), Article III (Fees), Article IV (Benefits and Other Payments) and Article V (Termination) in the contract. The contract does not specify the circumstances under which the Issuer may terminate the contract. Under the contract terms, the contract is terminated when no deposit arrangements have been made and there are no deposits with a value greater than zero under the contract. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

NOTE 6 – TAX STATUS

The Plan is qualified under the provisions of the Internal Revenue Code (IRC) and is not subject to federal and state income taxes. Participating employees are not subject to federal and state income taxes on employer contributions, or on income accruing to their accounts, until they receive distributions from the Plan. The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended since, plan management believes that the plan is qualified and the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the Department of Labor or Internal Revenue Service, however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 – PARTIES IN INTEREST

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. The Plan invests in certain mutual funds managed by Principal Funds, Inc., an affiliate of Principal Trust Company. The Plan invests in units of collective investment trusts managed by Principal Global Investors Trust, an affiliate of Principal Trust Company. The Plan invests in certain pooled separate accounts, guaranteed investment accounts, and a group annuity investment contract issued by Principal Life Insurance Company, an affiliate of Principal Trust Company. Principal Trust Company is the trustee as defined by the plan, and therefore, these investments and related investment income represent party-in-interest transactions to the Plan. Notes receivable from participants also qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 9 – SUBSEQUENT EVENTS

Plan management has performed an analysis of activities and transactions subsequent to December 31, 2024 to determine the need for any adjustment to and/or disclosures within these financial statements for the year ended December 31, 2024. Plan management has performed their analysis through September 15, 2025 which was the date that the financial statements were available to be issued and there are no subsequent events to disclose.
