## Independent Auditor's Report

The Plan Trustees  
Cobalt Enterprises 401(k) Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Cobalt Enterprises 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audits of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matter – Supplemental Schedule Required by ERISA**

1. DESCRIPTION OF PLAN

The following description of Cobalt Enterprises 401(k) Plan (the Plan) provides general information only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

a. General

The Plan is a qualified defined contribution plan established on February 1, 2014. Effective January 1, 2019, the Plan became a "qualified automatic contribution arrangement 401(k) plan" (QACA). The Plan covers all employees of Cobalt Enterprises, LLC (the Company) who are not in an ineligible class of employees as defined by the Plan. The Company is also the plan sponsor and plan administrator.

Subsequent to year end, the Plan was amended to add Aero Finishing LLC as an employer effective September 1, 2025.

The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA).

b. Eligibility

All employees who are at least 18 years of age are eligible to participate in the Plan once they have completed three months of service. Employees can elect to enter the Plan as a participant on the first day of the quarter following the date on which they satisfy the service requirements.

c. Contributions

Each year, participants may contribute up to 100% of their eligible compensation, as defined in the Plan.

Upon meeting the eligibility requirements, employees are automatically enrolled into the Plan at a pretax deferral rate of 6% of their gross compensation each pay period. Employees can elect to opt-out of participating in the Plan. Employees may choose between Pre-tax and Roth contributions in their elective deferrals. Participants are allowed to make modifications to their contributions weekly.

The Company has a QACA safe harbor matching contribution feature. Under the terms of the QACA provisions, the Company matches employee contributions in an amount equal to 100% of the first 2% of eligible compensation and 50% of the next 4%, that the participant contributes to the Plan, up to a maximum of 4% of the participant's eligible compensation.

c. Contributions, (Continued)

The Company may also make discretionary matching contributions to the Plan. For 2024, no discretionary matching contributions were made.

Participants may contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollovers).

Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. Participants may change their investment options as often as permitted under the investment vehicles they choose.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

d. Participant accounts

Each participant's account is credited with the participant's salary deferral contributions and the Company's safe harbor matching contribution, and an allocation of plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings or losses thereon. Vesting in the Company's safe harbor matching contributions and the discretionary matching contributions are based on hire date and years of service.

Employees hired before January 1, 2019, are 100% vested in the safe harbor matching contributions (including QACA) even if they are not yet a participant in the Plan. Employees hired on or after January 1, 2019, are subject to the 2-yr cliff vesting schedule for QACA safe harbor matching contributions.

The vesting schedule for QACA safe harbor matching contributions plus actual earnings or losses thereon is as follows:

e. Vesting, (Continued)

Any employee who was a participant in the Plan as of March 1, 2017, will be 100% vested in discretionary matching contributions. All other employees will be subject to the 6-year graded vesting schedule for discretionary matching contributions.

The vesting schedule for discretionary matching contributions plus actual earnings or losses thereon is as follows:

Upon death, disability, or reaching normal retirement age (age 65), participants become fully vested in all account balances.

f. Payment of benefits

Benefits will be paid to the participants or participant's beneficiary upon termination of service, death, disability, or retirement.

If the participant's vested benefit is over \$1,000, then the participant must consent to any distribution before it may be made. The participants may elect to receive a distribution either through a rollover or receive a lump sum distribution directly.

If the participant's account balance is under \$1,000, then the distribution will be automatically made in a lump sum cash payment regardless of whether the participant consents to receive it.

The Plan allows in-service distributions to participants who have reached age 59 ½.

Participants may also withdraw funds from their account in the event of financial hardship as defined in the Plan document.

g. Forfeited accounts

At both December 31, 2024 and 2023, forfeited nonvested account balances totaled \$0. These balances can be used to pay administrative expenses or be used to reduce employer contributions. During 2024, forfeitures in the amount of \$1,945 were used to reduce employer QACA safe harbor matching contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a. Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

b. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

c. Investment valuation and income recognition

Investments are stated at fair value (except for fully benefit responsive investment contracts, which are required to be reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Payment of benefits

Benefits are recorded when paid.

e. Administrative expenses

Certain administrative expenses were paid by the Company and not reflected in these financial statements. Administrative expenses not paid by the Company are charged to participants' accounts and are apportioned based upon their relative account values. Transaction based fees are charged directly to participants' accounts. Investment related expenses are included in net appreciation in fair value of investments.

f. Date of the Plan's review

The Plan has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued.

3. CUSTODIAN CERTIFICATIONS UNDER ERISA SECTION 103(a)(3)(C)

The plan sponsor has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the auditors’ examination did not extend to the following information certified by Sentry Life Insurance Company (Sentry), the custodian, as complete and accurate:

- Investments
- Net appreciation in fair value of investments
- Interest and dividends
- Schedule of assets (held at end of year)

4. FAIR VALUE MEASUREMENTS

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* The daily net asset value (NAV) is used as a practical expedient to estimate fair value. Investments in pooled separate accounts (PSAs) represent ownership of units of participation (Units), rather than ownership of specific assets. The value of any one PSA is determined by aggregating the value of all the Units held by the Plan. The value of a single Unit is the total value of the PSA’s underlying investments plus other assets less liabilities divided by the number of Units outstanding. Investments in the PSAs are valued at a net asset value per share method (unit pricing) which is generally determined by the quoted market price of the underlying investments.

The following table summarizes the investments for which fair value is measured using the net asset value per share practical expedient:

5. GUARANTEED FUND

The Plan has a fully benefit-responsive investment contract with Sentry. Sentry maintains the contributions in a general account. Specific securities within the general account are not attributed to the guaranteed fund. The account is charged for participant withdrawals and administrative expenses. Sentry is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Sentry, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

- Amendments to the Plan documents (including complete or partial plan termination or merger with another plan).
- Changes to the Plan's prohibition on competing investment options.
- Bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan.
- The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.
- Premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines.
- A breach of material obligation under the contract.
- A material misrepresentation.
- A material amendment to the agreement, with the consent of the issuer.

6. PARTY-IN-INTEREST TRANSACTIONS

During 2024 and 2023, the Plan held investments in fund options managed by Sentry. Sentry is the custodian as defined by the Plan and, therefore, these transactions are recognized as exempt party-in-interest transactions under ERISA.

For the year ended December 31, 2024, the Plan paid \$4,233 for certain expenses related to the plan operations to various service providers. These expenses are recognized as exempt party-in-interest transactions under ERISA.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

8. TAX STATUS

The Plan utilizes a Defined Contribution Prototype Plan document administered by Sentry Life Insurance Company. The Plan obtained a determination letter dated June 30, 2020 from the IRS, which states that the Plan, as designed, complied with applicable requirements of the Internal Revenue Code (IRC) and, accordingly, was exempt from federal income tax. Although the Plan has been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
