### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We were engaged to perform audits of the financial statements of Mercy Corps 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### ***Basis for Disclaimer of Opinion***

As described in Note 5, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity and custodial accounts issued to former employees prior to January 1, 2009, pursuant to the Department of Labor's Field Assistance Bulletin (FAB) No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statements of changes in net assets available for benefits. The amount of these excluded annuity and custodial accounts and the related income and distributions are not determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.



In addition, pursuant to FAB No. 2009-02, such excluded pre-2009 contracts, accounts, and amounts were not covered by our auditing procedures. Accounting principles generally accepted in the United States of America (GAAP) require that these accounts and the related income and distributions be included in the accompanying financial statements.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditor's Responsibilities for the Audit of the Financial Statements***

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America (GAAS) and to issue an auditor's report. However, because of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

***Other Matter —Supplemental Schedules Required by ERISA***

The supplemental schedules, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) and Schedule H, Line 4a – Schedule of Delinquent Participant Contributions as of or for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedules referred to above.

**NOTES TO FINANCIAL STATEMENTS**  
**DECEMBER 31, 2024 AND 2023**

**NOTE 1 – DESCRIPTION OF PLAN**

The following is a brief description of the Mercy Corps 403(b) Plan (the Plan). It is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering eligible U.S. employees of Mercy Corps (the Employer). Eligible employees may make salary deferral contributions on the first of the month following their employment. After completion of one year of service and 1,000 hours, employees are also eligible to participate in employer contributions. Employees who are nonresident aliens with no U.S. source income are not eligible to participate, provided, however, that once an employee has satisfied the criteria to become a participant, such employee shall remain eligible to participate in the Plan regardless of residency status. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Amendment** - Effective January 1, 2024, the Plan was amended to allow participants to make Roth Elective Deferrals, Roth Rollover and In-Plan Roth Contributions.

**Contributions** - Contributions consist of employee salary deferral contributions and discretionary employer contributions. Employee salary deferral contributions are recorded when withheld from the employee's compensation. Discretionary employer contributions for employees are determined annually by the Employer's Board of Directors. Participants may contribute up to 80% of total eligible compensation for the Plan year, limited to \$23,000 and \$22,500 in 2024 and 2023, respectively, as prescribed by the Internal Revenue Code (IRC). Participants aged 50 and over may make additional catch-up contributions. All new employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan also includes an automatic escalation provision, whereby the elective deferral rate for participants will increase by 2% each year until the deferral amount reaches 9% or the participant elects not to have the increase applied. In 2024 and 2023, the Employer made discretionary employer contributions to all eligible participants in an amount equal to 6% of eligible compensation. In addition, contributions are subject to other limits under the IRC.

**Participant Accounts** - A separate account is maintained for each participant, which is credited with the participant's contributions, the employer's discretionary contributions, and an allocation of Plan earnings and expenses. Allocation of Plan earnings and expenses is based upon participant account balances. Allocation of employer's discretionary contributions is based on a percentage of each eligible participant's compensation, or an equal dollar value. The benefit to which a participant is entitled is the vested amount in their individual account.

**Vesting** - Participants are immediately vested in all contributions and actual earnings thereon.

**Payment of Benefits** - Upon termination of service, a participant may select a form of payment from among the options available under their specific investment. From mutual fund accounts, the normal form of payment is a lump sum amount and from annuity contracts, the normal form of payment is a single life or joint and survivor annuity equal to the participant's vested account value. Upon termination of employment, account balances that are under \$1,000 may be automatically paid out to participants and balances between \$1,000 and \$7,000 may be transferred to an IRA unless otherwise directed by the participant. The Plan provides for hardship distributions which are available only for the purpose of meeting immediate and heavy financial needs. Participants may elect to take a partial or total distribution when they reach age 59 ½ or at any time thereafter, even if they have not terminated employment with the Employer. The Plan further provides for participant loans.

**Expenses** - Administrative expenses may be paid by the Employer. Administrative and investment expenses not paid by the Employer are satisfied in part through fees received by the Plan through revenue sharing with various mutual funds and the remainder charged to participant accounts based upon relative account values on a monthly basis. Fees related to distributions and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

**Forfeited Accounts** - Forfeited accounts amounted to \$17,752 and \$17,035 at December 31, 2024 and 2023, respectively. Forfeited accounts generally are the result of employer matching contributions made to ineligible employees and include earnings thereon. The accounts will be used to reduce future employer contributions or fund administrative expenses. Forfeited nonvested accounts of \$167 and \$3,242 were used to reduce administrative expenses in 2024 and 2023, respectively.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared under the accrual method of accounting.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and management and operating expenses associated with the Plan's investments in mutual funds.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Benefit Payments** - Benefits are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but are not yet paid at year-end have not been accrued. At December 31, 2024 and 2023, there were no material amounts payable to participants.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### **NOTE 3 – FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

#### **Basis of Fair Value Measurement**

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan administrator has obtained certifications from the custodian that such information is complete and accurate.

**NOTE 5 – EXCLUDED ANNUITY AND CUSTODIAL ACCOUNTS**

The Plan has excluded from investments in the statements of net assets available for benefits certain annuity and custodial accounts held by Fidelity Investments for current and former employees. The accounts became Plan assets upon the merger of another organization with Mercy Corps, however, Mercy Corps has never provided funding to these accounts. The investment income and distributions related to such accounts have also been excluded in the statements of changes in net assets available for benefits.

The Plan's management is unable to obtain current account information from Fidelity Investments and as such, the amount of these excluded annuity and custodial accounts and the related income and distributions are not determinable. As permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*, the Plan administrator has excluded these accounts from the Plan's annual reporting.

#### **NOTE 6 – NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their vested account balance up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans must be repaid within five years unless used to acquire a primary residence. Loans are payable through payroll deductions and shall be repaid in equal installment payments not less frequently than monthly. Loans bear interest at commercially reasonable rates as determined by the Plan administrator. Interest is at prime plus 1% and ranges from 4.25% to 9.50% for loans outstanding at December 31, 2024. Loans are secured by the vested account balance of the participant.

#### **NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### **NOTE 8 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan is invested in shares of funds managed by State Street Bank and Trust Company, the custodian of the Plan, and National Financial Services, LLC, an affiliate of the custodian. These transactions qualify as party-in-interest transactions, as defined by ERISA. Fees for investment management services charged by the custodian, or affiliate of the custodian, are netted against Plan earnings and ranged from 0.48% and 0.61% of the average daily investment balances.

#### **NOTE 9 – CONCENTRATIONS, RISKS AND UNCERTAINTIES**

The Plan provides for investments that are exposed to various risks. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, and therefore participants' account balances. There were four and three investments that individually represented more than 10% of the investments held as of December 31, 2024 and 2023, respectively. See the supplemental Schedule of Assets (Held at End of Year) for the complete listing of investments held as of that date.

#### **NOTE 10 – INCOME TAX STATUS**

The Plan document is a volume submitter 403(b) plan sponsored by Transamerica Retirement Solutions, LLC. In an opinion letter dated March 31, 2017, the Internal Revenue Service (IRS) stated that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 11 – NONEXEMPT PROHIBITED TRANSACTIONS**

During 2024, 2022, and 2021, employee withholdings and loan repayments from employee payrolls amounting to \$1,500, \$126,020 and \$191,894, respectively, were not remitted to the Plan within the appropriate time period required by the Department of Labor. These transactions constitute prohibited transactions as defined by ERISA. The Employer is aware of the occurrences and is in the process of taking the appropriate steps to correct these amounts.

#### **NOTE 12 – SUBSEQUENT EVENTS**

The Plan's management has performed an evaluation of subsequent events through September 9, 2025, which is the date these financial statements were available to be issued.

In 2025 as a result of a reduction in the Company's workforce, the Company has determined that a partial termination of the Plan occurred in 2025. All affected plan participants were fully vested in their accounts.
