Eligibility Requirements: All employees of the Employer who have attained age 21 and has completed one year of service.

The Employer is Gehrig Capital Management, Inc., an Indiana corporation.

Entry Date: The January 1st or July 1st coincident with or next following the attainment of eligibility.

Effective Date: January 1, 2010

Restatement Date: January 1, 2019

Plan Year: The Plan Year is the period January 1st through December 31st of each year.

Compensation Considered: All compensation paid or accrued and considered as salary and wages within the meaning of IRC 3401(a). The maximum allowable compensation is \$345,000.

Normal Retirement Date: The first day of the month coinciding with or next following the later of a participant's attainment of age 62 and the completion of 5 years of participation.

Early Retirement Date: None provided.

Service Considered: For purposes of:

Eligibility - all years of service

Vesting - all years of service

Accrual - all years of service after January 1, 2009

Benefits - all years of service after January 1, 2009

Years of service are credited for each Plan Year in which a participant is credited with 12 months of service. Service with Lothar Gehrig, sole proprietorship, is included.

**IV. SUMMARY OF PRINCIPAL PLAN PROVISIONS**

Normal Retirement Benefit: A monthly benefit equal to 5% of Average Monthly Compensation, times years of considered service.

Average Monthly Compensation is the monthly average of a participant's considered compensation over the 3 highest consecutive Plan Years of employment.

Accrued Benefit: The Normal Retirement Benefit calculated as of the date of determination.

Termination Benefit: For termination other than for retirement, death or disability, the Accrued Benefit is payable at Normal Retirement Date or an actuarially equivalent amount if payable earlier times the vesting percentage. The vesting percentage is as follows:


