## Independent Auditor's Report

To the Plan Administrator of the Central Hudson Gas & Electric Corporation Savings Incentive Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Central Hudson Gas & Electric Corporation Savings Incentive Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note I to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

A. DESCRIPTION OF PLAN:

The following description of the Central Hudson Gas & Electric Corporation Savings Incentive Plan (the "Plan") provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Central Hudson Gas & Electric Corporation (the "Company"). On March 18, 2016, CH Energy Group, Inc. adopted the Plan and became a participating entity in the Plan (for definitional purposes, CH Energy Group, Inc. is included in the term "Company" but is independently responsible for obligations of employees of CH Energy Group, Inc.). Effective January 1, 2021, FortisUS Inc. adopted the Plan and became a participating entity in the Plan (for definitional purposes, FortisUS Inc. is included in the term "Company", but is independently responsible for obligations of employees of FortisUS Inc.).

Generally, eligible employees are immediately eligible to participate upon employment. The different classes of participants in the Plan maintain unique features relating to eligibility requirements, Company matching percentages and Company nondiscretionary nonelective contributions. All Company employees are eligible to participate in the Plan except for certain temporary employees, seasonal employees, co-ops, interns, and certain employees of FortisUS Inc. who did not transfer from covered employment under the Plan. See the Contributions section below for further information relating to the unique Company contribution features for the different classes of employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

Upon meeting eligibility requirements participants may contribute up to 75% of their plan compensation on a pre-tax basis (classified by the Company a "basic contributions") and up to 5% of their plan compensation on an after-tax basis (classified by the Company a "voluntary contributions"), subject to Internal Revenue Code ("IRC") limitations. All new participants are automatically enrolled at a contribution rate of 8% of plan compensation, unless they opt out or make another affirmative election. Participants who are at least 50 may make an additional "catch up" contribution subject to IRC limitations. Catch up contributions are not matched. Participants may also contribute funds from another qualified plan ("rollover contributions"), subject to certain requirements.

The Plan provides for a Company match of 75% of the first 8% of such basic contributions that are made by management employees of the Company, Company employees covered by the Systems Operations collective bargaining agreement with the IBEW Local 320, and other Company employees covered by a collective bargaining agreement and hired on or after May 1, 2008, and for a Company match of 50% of the first 6% of such basic contributions that are made by employees (other than Systems Operations employees) covered by a collective bargaining agreement and hired prior to May 1, 2008.

At the discretion of the Board of Directors, the Company may make additional contributions to employee accounts. No discretionary contributions were made for the plan year ending December 31, 2024. The Plan also provides an additional Company nondiscretionary contribution of 4% of eligible compensation (base wage for employees covered by a collective bargaining agreement, other than Systems Operations employees; subject to proration for part-time employees and employees employed during a portion of a year) during the first quarter of a calendar year for the prior year for Company employees who are not eligible for Central Hudson's Retirement Income Plan. Employees must be employed on the last day of the plan year, or die, become disabled or retired during the plan year to be eligible to receive that plan year contribution. This additional nondiscretionary contribution for Company employees totaled \$4,139,747 for the plan year ended December 31, 2024.

Participant Accounts

Each participant's account is credited or charged with contributions, investment income, and administrative expenses. Investment income, including realized and unrealized gains and losses, and expenses are allocated to participants' accounts based on each participant's account balance within each fund. Participants determine the percentages in which contributions are to be invested in each fund. Participants may change their investment options as set forth in the plan document. The benefit to which a participant is entitled is equal to the value of the participant's vested interest in their account.

Vesting

Participants are 100% vested at all times in all accounts.

Distribution of Benefits

Benefits may be distributed to participants upon termination of employment by reason of retirement, disability, death, or other separation from service. Distributions under the Plan may be made in lump sums, partial withdrawals, installment payments, or annuities.

A participant may also request a withdrawal upon attainment of age 59 1/2, or upon demonstration by the participant to the plan administrator that the participant is suffering from "hardship", as defined in the plan document. The minimum hardship withdrawal must be \$1,000 and participants are limited to two hardship withdrawals per plan year. A participant may also request a withdrawal from rollover or voluntary contribution funds at any time.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Loans bear an interest rate of the prime rate plus 2%. All loans must be repaid within five years. No more than three loans may be outstanding at any time. Principal and interest is generally paid ratably through payroll deductions each pay period.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting. The Plan is a participant in the Central Hudson Savings Plans Master Trust (the "Master Trust").

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded as earned on the accrual basis. The net appreciation (depreciation) in the fair market value of the Plan's interest in the investments of the Master Trust, which consists of the realized gains or losses and the change in unrealized appreciation (depreciation) on those investments, is also included in investment income (loss) from the Master Trust.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Contributions

Contributions from plan participants and company contributions are recorded in the year in which the participant contributions are withheld from compensation.

Expenses of the Plan

Administrative expenses related to the Plan are paid by the Plan, unless paid by the Company, except for costs incurred for the purchase or sale of securities and investment related costs, such as investment manager fees, which are borne by the respective investment funds. Expenses that are paid by the Company are excluded from these financial statements. Certain trustee, custodial and investment related fees are recorded at the Master Trust level and are included in the change in the Plan's interest in the Master Trust on the statement of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

C. FAIR VALUE MEASUREMENTS:

The investments of the Plan are held by Fidelity Management Trust Company under a divided Master Trust agreement (see Note D). The assets of the Master Trust are presented at fair value.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used by the Plan and Master Trust. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts* - Valued at the NAV of units held by the Master Trust at year end. The NAV, as provided by the fund manager, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

Information on the Plan's interest in the Master Trust and relevant fair value disclosures of the Master Trust's investments is presented in Note D.

D. INTEREST IN MASTER TRUST:

The Plan's investments are in the Master Trust, which was established for the investment of assets of the Plan and the Central Hudson Gas & Electric Corporation Supplemental Retirement Plan. Each participating retirement plan has a divided interest in the Master Trust.

The value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the trust plus actual contributions and allocated investment income (loss) less actual distributions and administrative expenses.

Redemptions of investments in the Fidelity common collective trust funds are allowed monthly for the Plan and participants, however, the Plan and participants are subject to a 15-day notification period. Redemptions of investments in the Harbor Capital common collective trust fund, are allowed daily for the Plan and participants, however, the Plan and participants are subject to a 15-day notification period. There are no unfunded commitments for the common collective trusts held by the Plan and Master Trust.

**E. INVESTMENT CONTRACT WITH INSURANCE COMPANY:**

The Plan, through the investment in the Master Trust, holds a traditional investment contract issued by Voya Financial, Inc. ("the contract issuer"). The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

With traditional investment contracts, the Plan owns only the contract itself. These contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting. The contract does not have a maturity date.

A 30-day notice period is required to discontinue the contract. If the market value is selected, payment will be made within 30 days. If book value is selected, within 30 days of the date that the contract is discontinued, the balance will be transferred to a settlement account and a new credit rate period will commence on the date of transfer. The Plan may

select an account which would support a credit rate of at least 5% determined by the contract issuer at the date of commencement. If it is determined that an account supporting a credit rate of at least 5% is not available, the only account available is the account with the longest remaining to its final liquidation date of the target duration of the account that is greater than 4.5 years. If it is less than 4.5 years, the contract issuer will establish a new account to receive the transfer of the Plan's balance. The balance will then be paid in installments.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that would also limit the ability of the Plan to transact at contract value with the participants.

F. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS:

Section 3(14) of ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants and the management of investments held in the Plan and Master Trust by the trustee are considered party in interest transactions.

G. RISKS AND UNCERTAINTIES:

The Plan, through the investment in the Master Trust, invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

H. TAX STATUS:

The Company adopted a pre-approved plan document of Plan Document Systems LLC, and the Internal Revenue Service (“IRS”) has determined and informed the sponsor of the pre-approved plan document by a letter dated June 30, 2020 that the pre-approved plan document is designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

I. CERTIFIED INVESTMENTS:

Certain information related to investments in the Master Trust and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including the Plan’s interest in the Master Trust and notes receivable from participants held at December 31, 2024 and 2023, and change in the Plan’s interest in the Master Trust investment income (loss) and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

J. PLAN TERMINATION:

Although the Plan was established with the intention that it will continue indefinitely, the Company retains the right to discontinue its contributions at any time or to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

K. SUBSEQUENT EVENTS:

The Plan has evaluated subsequent events through September 15, 2025, the date these financial statements were available for issuance.
