INDEPENDENT AUDITOR’S REPORT

To the Plan Administrator of the
Benoit Premium Threading, LLC Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed audits of the financial statements of Benoit Premium Threading, LLC Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS**Benoit Premium Threading, LLC Profit Sharing Plan**

December 31, 2024

Note 1 - PLAN DESCRIPTION

The following description of the Benoit Premium Threading, LLC Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution plan covering all employees of Benoit Premium Threading, LLC (the “Employer”), who have six months of service and are age 18 or older. Collectively bargained (union) employees, leased employees and non-resident alien employees are excluded from participation in the Plan. The Employer, as plan administrator, has full responsibility for the management and operation of the Plan and for monitoring the Plan’s investment performance. Fidelity Management Trust Company, the trustee, invests the Plan assets in accordance with the instructions of the participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Contributions

Each year, participants are permitted to defer a percentage of their pay into an elective deferral account on a pre-tax and/or post-tax basis subject to the limitations specified in the Internal Revenue Code (the “Code”), up to 60% of their eligible compensation, as defined in the Plan, not to exceed statutory limits. Eligible employees, including those who have not yet satisfied the eligibility requirements, may also contribute amounts representing eligible rollover distributions from other qualified plans. Participants direct their contributions and employer matching and non-elective employer contributions into various investment options offered by the Plan.

In any plan year, the Employer may make discretionary matching contributions to the Plan. For the year ended December 31, 2024, the Employer made matching contributions of \$262,943, net of forfeitures of \$25,941. In any plan year, the Employer may also make discretionary non-elective employer contributions to the Plan. The Employer did not make discretionary non-elective employer contributions for the year ended December 31, 2024.

Note 1 - PLAN DESCRIPTION (Continued)

c. Participant Accounts

Each participant's account is credited with the participant's contributions and Employer matching contributions, as well as allocations of the Employer's profit sharing contributions and plan earnings. Participant accounts are charged with allocations of plan earnings or losses and administrative expenses that are paid by the Plan. Allocations of the Employer's contributions are based on participant compensation or salary deferrals, as defined in the plan document. Allocations of plan earnings or losses and expenses are based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d. Vesting

Participants are vested immediately in their contributions, rollover contributions, and the earnings thereon. Vesting in the Employer's contributions plus earnings thereon is based on years of continuous service as follows:

e. Investment Options

The Plan provides a participant-directed investment program, whereby participants select the investments for their accounts. The Plan currently offers several mutual funds and a common collective trust, which allow participants to make individual selections of investments. The options offered represent several different alternatives to investing with different risk and return characteristics. Participants may change their investment options daily.

Note 1 - PLAN DESCRIPTION (Continued)

f. Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Notes receivable terms shall be no greater than five years, unless the note receivable is used to purchase a participant's principal residence in which case the notes receivable term will be determined at the time the loan is made and must be within a reasonable term. The notes receivable is secured by the vested balance in the participant's account and bear interest at a rate equivalent to current interest rates for loans from commercial sources. Interest rates on the notes receivable from participants range from 4.25% through 9.50% as of December 31, 2024. Principal and interest is paid ratably through payroll deductions.

g. Payment of Benefits

Following termination of service, the Plan will distribute to the participant in a lump sum an amount equal to the value of the vested interest in their account. A participant whose account balance exceeds \$7,000 must elect to receive benefits. Participants with an account balance of \$1,000 or less may receive an involuntary distribution. Terminated participants may also request a partial withdrawal of the vested interest in their account. In-service distributions are permitted for participants who have reached the age 59½. Additionally, hardship withdrawals are permitted from a participant's deferral contribution account for specific financial hardships.

h. Forfeited Accounts

Forfeited accounts are applied to pay administrative expenses or to reduce the contributions of the Employer. During 2024, Employer contributions were reduced by \$25,941 from forfeited accounts. As of December 31, 2024 and 2023, the Plan had nonvested forfeiture accounts totaling \$364 and \$5,873, respectively.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

a. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

b. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 4 for a discussion of fair value measurements.

The Plan's investments in mutual funds are stated at fair value based on information provided by Fidelity Management Trust Company, the Plan's trustee. Shares of mutual funds are valued at quoted market prices which represent the net asset value (NAV) of the shares held by the Plan at year end. The Plan's investments also include an investment in the Fidelity Advisor Stable Value Portfolio, a common collective trust that invests in fully benefit responsive investment contracts.

Related investment fees are netted against investment income. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as, held during the year.

d. Note Receivable from Participants

Note receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance has been recorded for credit losses as of December 31, 2024.

e. Payment of Benefits

Benefits are recorded when paid.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

f. Administrative Expenses

Certain expenses of maintaining the Plan, including investment related expenses, are paid directly by the Employer, and are excluded from these financial statements. Certain expenses incurred with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying Statement of Changes in Net Assets Available for Benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are also included in administrative expenses. In addition, certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying Statement of Changes in Net Assets Available for Benefits.

g. SECURE 2.0 Act of 2022

On December 29, 2022, the SECURE 2.0 Act was enacted to help improve retirement savings. The SECURE 2.0 Act made wide-ranging changes, both mandatory and elective, to qualified plans and its provisions have various effective dates.

Significant provisions were as follows:

- The RMD age was increased from 72 to 73, effective January 1, 2023, and to age 75, effective January 1, 2033;
- The excise tax for failure to take RMDs was reduced from 50 percent to 25 percent of the RMD amount that was not taken, beginning January 1, 2023; and
- All catch-up contributions for participants with compensation of more than \$145,000 (indexed for inflation) are required to be designated as Roth 401(k) contributions beginning after December 31, 2023. However, in August 2023, the Internal Revenue Service (IRS) announced an administrative transition period that delays this requirement until taxable years beginning after December 31, 2025.

The Plan will incorporate changes in its plan document and administration to the extent required by the "SECURE 2.0 Act".

h. Subsequent Events

Management evaluates events subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 4, 2025, which is the date the financial statements were available to be issued.

Note 3 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the supplemental Schedule H, Line 4i Schedule of Assets (Held at End of Year) as of December 31, 2024, and the activity related to investments and notes receivable from participants reflected in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, as follows:

Note 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy which prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 4 - FAIR VALUE MEASUREMENTS (Continued)

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price (Level 1). The mutual funds held by the Plan were deemed to be actively traded.
- *Stable value collective trust fund*: Valued at the NAV as determined by the manager of the fund. The fund trades on a daily basis at the established NAV of \$1 per share, which is readily determinable by the participants. The stable value collective trust fund is classified as a Level 2 investment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those used by other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Based on a reevaluation of the criteria for concluding that an investment has a readily-determinable fair value, the fair value of the stable value collective trust as of December 31, 2023 has been reclassified to Level 2 in the fair value table to conform with the current year presentation. This reclassification has no impact on net assets available for benefits as of December 31, 2023.

The stable value collective trust held by the Plan as of December 31, 2024 and 2023, invests primarily in investment contracts issued by insurance companies, financial institutions and money market funds. The trust intends to maintain a stable NAV of \$1.00 per share. The Fidelity Advisors Stable Value Portfolio is subject to certain potential limitations on transfers to other investment options and on the timing of withdrawals. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 5 - PARTY IN INTEREST TRANSACTIONS

The Plan invests in shares of mutual funds and a common collective trust managed by Fidelity Management Trust Company. Additionally, an affiliate of Fidelity Management Trust Company, Fidelity Workplace Services, LLC provides recordkeeping services. Fidelity Management Trust Company is the trustee for the Plan; therefore, these transactions qualify as party in interest transactions.

Note 6 - RISK AND UNCERTAINTIES

The Plan provides for various investments in certain mutual funds, a money market fund, and a stable value collective trust. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in all of their employer contributions.

Note 8 - TAX STATUS

The Plan utilizes a non-standard pre-approved plan document and relies on the advisory letter issued to the non-standard pre-approved plan document sponsor. The non-standard pre-approved plan document sponsor received an advisory letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was acceptable under section 401 of the Code. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and ERISA. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. As of December 31, 2024, the plan administrator believes that it has no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
