Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Stine, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Stine, LLC 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Stine, LLC 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of Plan

The following brief description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan available to all eligible employees of Stine, LLC (the Company). An employee becomes eligible to participate in the Plan after he/she has completed 1 year of service and is at least 21 years of age. Eligible employees may enter the Plan on the first day of the quarter following meeting all eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Each active participant in the Plan may enter into a written salary reduction agreement with the Sponsor in an amount not more than 60% of the participant's pre-tax annual compensation, as defined in the plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. The maximum deferral allowed for 2024 was \$30,500 (\$23,000 if the participant is under age 50), which the Sponsor may contribute on behalf of the participant to the Plan. In addition, the Sponsor may determine, at its sole discretion, the amount of matching contribution and/or profit sharing contribution, if any, to be made to the Plan from its current or accumulated net profits. The Company's contribution is invested in the same manner as the participants direct their contributions to be invested. For 2024, the employer contribution was 50% of the first 6%.

Effective November 3, 2023, Participants may designate all or a portion of their contributions as Roth contributions. Designated Roth contributions are made on an after-tax basis and are subject to the same rules as pretax contributions discussed above.

Participant accounts:

Each participant's account is credited with the participant's contribution, and allocations of the company's discretionary match contribution and/or profit-sharing contribution and plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon.

Vesting in company contributions portion of their accounts is based on years of continuous service and is determined as follows:

Payment of benefits:

On termination of service due to death, disability, or retirement, a participant will receive payment equal to the value of his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Allocated insurance contracts:

Premium payments are deducted from Plan assets and the purchased life insurance contracts are excluded from Plan assets. Premiums paid for allocated insurance contracts were \$-0- and \$-0- for 2024 and 2023, respectively. The value of these insurance contracts as of December 31, 2024 and 2023 were \$1,152,246 and \$1,122,265, respectively.

Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the Event of Plan termination, participants will become 100 percent vested in their accounts.

Forfeitures:

Forfeited balances of terminated participants' nonvested accounts are used to reduce administrative costs and to reduce future Company matching contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$31,989 and \$25,722, respectively. During 2024, \$35,987 was forfeited by participants who withdrew from the plan. Forfeitures in the amount of \$33,776 were used to pay plan expenses or to reduce Company matching contributions during 2024.

Note 2. Summary of Significant Accounting Policies

Basis of accounting:

Financial statements of the Plan are presented on the accrual basis of accounting.

Cash and cash equivalents:

The Plan includes all cash accounts, which are not subject to withdrawal restrictions or penalties, and all highly liquid debt instruments purchased with a maturity of three months or less as cash or cash equivalents on the accompanying statement of net assets available for benefits.

Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess contribution payable:

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Payment of benefits:

Benefits are recorded when paid.

Administrative expenses:

Except for audit fees, most other administrative fees of maintaining the Plan are paid by the company.

Note 3. Information Certified by Trustee (Unaudited)

At December 31, 2024 and 2023, the Plan's investments were held by the Trustee. The following is a summary of the Plan's financial information that is included in the financial statements based on information certified by the Trustee as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for reporting and disclosure under Employee Retirement Income Security Act of 1974.

Note 4. Fair Value Measurements of Financial Instruments

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related Party/Party-In-Interest Transactions

The Plan does not consider company contributions to the Plan to be party-in-interest transactions. The Company provides certain accounting, administrative and investment management services to the Plan for which no fees are charged.

Note 6. Tax Status

The prototype Plan obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service stated that the prototype plan, as then designed, was following the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and tax counsel believe that the Plan is designed and is being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as

of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is generally subject to examination for a period of three years after the filing of its employee benefit plan annual return. There are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8. Subsequent Events

The Plan has performed a review of subsequent events through September 18, 2025, the date the financial statements were available to be issued.



