Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the financial statements of QVI 401-K Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), my audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In my opinion, based on my audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

My audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

I am required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that I identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, I compared such information to the related certified investment information.

In forming my opinion on the supplemental schedule, I evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements December 31, 2024 and 2023

1. Description of the Plan

The following description of the QVI 401-K Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General — The Plan is a defined contribution plan covering employees of Quality Vision International Inc. and Quality Vision Services Inc. (collectively, the “Company” or “Employer”), who are over 18 years of age and have completed at least 1 month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Fidelity Management Trust Company (“FMTC”) and Fidelity Workplace Services LLC (“FWS”) serve as the Plan's trustee for the assets under its custody and recordkeeper, respectively.

Contributions — Each year, participants may contribute up to 75% of pretax or post-tax compensation, as defined in the Plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined plans (rollover contributions).

The Plan contains an automatic enrollment feature under which, upon reaching eligibility, the Company will begin to automatically deduct 5% of compensation on a pre-tax basis unless otherwise directed by the participant. The automatic enrollment percentage increased to 6% effective October 1, 2024.

The Company may make discretionary matching contributions and/or discretionary contributions to eligible participants. There were no discretionary contributions made during the years ended December 31, 2024 and 2023.

Participants may elect, pursuant to the provisions of the QVI Profit Sharing Retirement Plan (“Profit Sharing Plan”) to have a portion of their share of the Employer contribution under the Profit Sharing Plan transferred to the Plan and allocated to their respective participant account. The Employer contributions under the Profit Sharing Plan transferred to the Plan amounted to \$629,574 and \$570,378 for years ended December 31, 2024 and 2023, respectively. The 2024 amount was received by the Plan on March 10, 2025 of which \$614,600 was received in cash and \$14,974 from forfeited non-vested accounts. The 2023 amount was received by the Plan on March 12, 2024 of which \$558,955 was received in cash and \$11,423 from forfeited non-vested accounts.

All contributions are subject to certain Internal Revenue Code (“IRC”) limitations. Participants direct the investment of their contribution into various investment options offered by the Plan. The Fidelity Freedom Target Date Funds are the default investments used when a participant has not made their investment election.

Participant Accounts — Each participant's account is credited with the participant's contributions, an allocation of Employer contributions and Plan earnings, and charged with withdrawals and administrative expenses and Plan losses. Allocations are based on participant earnings, or account balances as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting — Participants are immediately vested in their contributions, plus actual earnings thereon. Participants' allocated share of Employer contributions from the Profit Sharing Plan, and earnings thereon, vest ratably over six years of service, as defined in the Plan. Vesting in the Company's matching or discretionary contributions, plus actual earnings thereon, are based on vesting schedules with participants 100 percent vested after six years of continuous service, as defined in the Plan.

Notes Receivable from Participants — Participants may borrow from their fund accounts a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, or up to ten years for the purchase of a participant's primary residence. Interest is fixed at the prime rate when the loan is issued.

Payment of Benefits — The Plan provides for normal retirement benefits upon reaching the age of 65 and has provisions for disability, death, hardship, in-service and termination benefits for those participants who are eligible to receive such benefits. A participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures — Forfeitures of non-vested Employer contributions can be used to pay the expenses of the Plan or to reduce future Employer contributions. As of December 31, 2024 and 2023, unallocated forfeitures amounted to \$28,637 and \$17,445, respectively. During 2024 and 2023, participant forfeitures amounted to \$54,497 and \$29,038, of which \$11,423 and \$2,436 were used to reduce the Employer contributions, and \$32,402 and \$20,865 were used to reduce administrative expenses, respectively.

Plan Termination — Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

The financial statements of the Plan are prepared using the accrual basis of accounting under accounting principles accepted in the United States of America.

Notes Receivable from Participants — Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits — Benefits are recorded when paid.

Administrative Expenses — The Plan's administrative expenses may be paid by the Plan or the Company. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits. Beginning during the first calendar quarter of 2023, a quarterly administrative fee for recordkeeping will be deducted from participant accounts and a quarterly revenue credit may be available to certain participant accounts based on investments held. During 2024 and 2023, total administrative fees of \$72,273 and \$50,898 were offset by revenue credits of \$101,707 and \$64,590, resulting in a net expense credit of \$29,432 and \$13,692, respectively.

Use of Estimates — The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risk and Uncertainties — The Plan invests in investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with these securities, it is reasonably possible that changes in their values will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events — Plan management has evaluated subsequent events and transactions for potential recognition or disclosure through June 30, 2025, the date that the financial statements were available to be issued.

3. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan follows the fair value measurement guidance required by accounting principles generally accepted in the United States of America for financial and nonfinancial assets and liabilities. That guidance defines fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Valued at quoted market prices which represent the Net Asset Value (NAV) of shares held by the Plan at year end.

Common/Collective Trusts: Valued at the NAV based on the underlying assets of the trusts. The NAV is used as a practical expedient to estimate fair value and is obtained from the information provided by the investment advisor using the audited financial statements of the common collective trusts at year end. The Putnam Stable Value Fund is subject to certain redemption terms and restrictions in accordance with the Participation Agreement entered into between the parties.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) The common collective trust fund is measured at net asset value and has not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Related-Party and Party-In-Interest Transactions

The Plan invests in certain investments managed by Fidelity. Fidelity is the trustee, as defined by the Plan and, therefore, transactions involving these investments qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

Certain employees and/or officers of the Company or its affiliates perform administrative services to the Plan at no cost to the Plan.

5. Tax Status

The Plan adopted a pre-approved defined contribution plan sponsored by FMR LLC, a related party to FWS and FMTC. FMR LLC received an opinion letter from the Internal Revenue Service, dated June 30, 2020, which states that the pre-approved defined contribution plan document satisfies the applicable provisions of the IRC. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

As of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Certified Financial Information

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the years then ended, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by FMTC and furnished to the Company. The Company has obtained certifications from FMTC as of December 31, 2024 and 2023, and for the years then ended, that such information is complete and accurate.
