Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the financial statements of BMS Logistics, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1: Description of the Plan

The following description of the BMS Logistics, Inc. 401(k) Plan (the Plan), provides only general information. Refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of BMS Logistics Inc. (the Company). Employees are eligible to begin deferring contributions the first day of the month after completion of sixty days of service and attainment of age 18. Auto-enrollment at 1% with no escalation applies. Employees who are eligible for deferral contributions are eligible for employer matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employee Contributions

Participating employees may elect to contribute a dollar amount or percentage of their annual compensation, as defined in the Plan document, to the Plan on a tax-deferred basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Transfers from qualified plans and certain individual retirement accounts are allowed under the provisions of the Plan. Participants are also allowed to make Roth rollover contributions of amounts received from other tax-qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan such as mutual funds, money market funds, common stock and other investments.

Employer Contributions

The Company will contribute a qualified matching contribution equal to 100% of each participant's, elective deferral, not to exceed 5% of each participant's compensation.

Participant Accounts

Each participant's account is credited with the participant's voluntary contribution and allocations of the employer's matching contribution and Plan earnings, which are allocated proportionately among all participants based on participant earnings as defined by the Plan. Participants' accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in the participant's contributions and company matching contributions, plus actual earnings.

Participant Loans

Under the terms of the Plan, participants may not borrow from their accounts.

Payment of Benefits

On termination of service due to death, disability, retirement, or termination of employment, the participant may receive a lump-sum payment equal to the value of the participant's vested interest in his or her account or annual installments if the participant is required to receive lifetime required minimum distributions. In-service hardship distributions are allowed. Effective July 1, 2024, the minimum amount of a hardship distribution is \$1,000 and participants are limited to one per plan year. Mandatory distributions apply to account balances less than \$5,000 and automatic rollovers apply to any of those balances over \$1,000.

Note 2: Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from the Company are accrued in the period in which they become an obligation of the employer by declaration of the Board of Directors. Contributions from employees are accrued when withholding is made from employees' payroll.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

See Note 3 for further documentation on fair value measurements.

Investment Valuation and Income Recognition

The Plan's investments are presented at fair value, as determined and certified by Citizens State Bank and Trust Company (the Custodian), as of the Plan's year end. Investments in registered investment companies are valued at quoted market prices that represent the net value of shares held by the Plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid. As of December 31, 2024 there were three distributions pending, totaling an amount of \$3,668. As of December 31, 2023, there were four distributions pending, totaling an amount of \$6,599.

Administrative Fees

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of distributions from participants accounts are charged directly to the participants account. Investment fees and other expenses are included in administrative expenses.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds and Money Market Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Stock - Level 1

Valued at the closing price reported on an active market on which the individual securities are traded.

Common Stock - Level 2

Valued at the closing price reported on an inactive market on which the individual securities are traded.

Note 4: Related Parties and Parties in Interest

The Plan Sponsor absorbs some administrative expenses of the Plan, cost of audit fees and the cost of fiduciary bonds. As the Plan does not reimburse the Company for the cost of such services they are not included in these financial statements.

Investment related expenses are included in the net appreciation of fair value of investments. These transactions qualify as exempt party-in-interest transactions.

Administrative functions are performed by officers or employees of the Company. Additional party-in interest transactions include audit fees paid to Varney & Associates, CPAs, LLC, and investment fees paid to the Custodian. These transactions qualify as exempt party-in-interest transactions.

Note 5: Plan Termination

Although the Plan Sponsor has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6: Tax Status

The Plan Sponsor adopted a nonstandardized form of a prototype Plan. The Internal Revenue Service issued an opinion letter, dated June 30, 2020, on the prototype Plan document, indicating the basic Plan document is acceptable under Code Section 401 of the Internal Revenue Code. Although the Plan has been amended since receiving the letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8: Information Prepared and Certified by Custodian (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including net appreciation in fair value of the investments and interest and dividends for the years ended December 31, 2024 and 2023 were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Custodian of the Plan.

Note 9: Reconciliation of Financial Statements to Form 5500

The financial statements amounts reconcile with the annual Form 5500 filing to the Internal Revenue Service.

Note 10: Subsequent Events

Management has evaluated subsequent events through September 9, 2025, the date on which the financial statements were available to be issued.
