nLIGHT, Inc. 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of nLIGHT, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023**

1. Description of Plan

The following description of the nLIGHT, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

a. General

The Plan was established January 1, 2001 by nLIGHT, Inc. (the “Company”) as a defined contribution plan under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The trustee of the Plan is Fidelity Management Trust Company (“Fidelity”). The Plan uses the Fidelity Volume Submitter Defined Contribution Plan prototype document. The Plan is administered by the Company as the Plan sponsor.

The Plan also includes employees from Nutronics, Inc. (the “Participating Employer”) which is owned by nLIGHT, Inc. In June 2023, the Participating Employer was renamed as nLight DEFENSE Systems, Inc.

b. Eligibility

Employees of the Company are eligible to participate in the Plan upon reaching 18 years of age except for temporary employees. Participants may enter the Plan on the first day of the month coinciding or following the date the employee meets the eligibility requirement.

c. Contributions

The Plan includes an automatic enrollment feature. New participants are automatically enrolled in the Plan with a 3% deferral rate, unless the participant affirmatively elects otherwise. Each participant having automatic enrollment contributions made on their behalf will have their deferral rate increased annually by 1%, up to a maximum of 10%.

Participants may contribute up to 100% of their eligible compensation to the Plan, subject to the Internal Revenue Service (“IRS”) limits. The Plan also allows rollover contributions from other qualified plans. Upon reaching the age of 50, eligible employees may make additional catch-up contributions as allowed by the IRC. The Company may make discretionary matching or qualified non-elective contributions to the Plan. The discretionary match is equal to 50% of the first 6% deferred by the participant. The Plan also makes a nonelective fixed employer contribution equal to 3% of the participant’s eligible compensation for employees under the Participating Employer.

d. Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, the Company's contributions, and an allocation of the Plan's earnings and expenses, and are valued on a daily basis. The current benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Vesting

Participants are immediately vested in their elective deferrals, rollover contributions, qualified non-elective contributions, nonelective employer contributions, and discretionary employer matching contributions to the Plan and the net earnings thereon.

f. Investments

Participants direct the investment of their account balances in one or a combination of several investment options offered by the Plan. Participants may change their investment elections or transfer their assets between investments on a daily basis.

g. Forfeitures

Participants who terminate employment forfeit the non-vested portion of Company discretionary matching contributions and earnings thereon. At December 31, 2024 and 2023, forfeitures totaling approximately \$2,000 and \$3,000, respectively, were available to reduce future Company contributions or pay Plan administrative expenses. During 2024 and 2023, forfeitures of approximately \$2,000 and \$0, respectively, were utilized to pay administrative expenses or to offset Company contributions.

h. Payment of Benefits

Upon reaching retirement age, termination of service or death, a participant may elect to receive their vested account balance in a lump-sum distribution. Account balances less than \$1,000 can be distributed at the trustee's discretion in a single lump-sum cash payment to the participant or beneficiary. Account balances greater than \$1,000 but less than \$5,000 can be rolled over to an individual retirement account at the discretion of the Plan Administrator for the participant.

i. Hardship Withdrawals

Upon certain conditions, participants, while still employed by the Company, are permitted to withdraw, in a single sum, a portion of their employee deferrals as a result of an immediate and heavy financial need subject to a \$500 minimum. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of postsecondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster clean-up on the participant's principal residence or to prevent eviction or foreclosure from the participant's principal residence.

j. Notes Receivable From Participants

Participants may borrow the lesser of \$50,000 or 50% of their vested account balance, subject to a \$1,000 minimum and certain other restrictions. Loans are secured by the vested account balance of the participant and bear interest at a rate equal to the prevailing interest rate that would be charged under similar circumstances as determined by the Company. Loans are repaid through payroll deductions over periods ranging up to five years unless the loan is used to acquire a principal residence, in which case the loan term may be for a period of ten years.

Interest rates on outstanding loans at December 31, 2024 ranged from 4.25% to 9.50%, maturing through 2034.

k. Administrative Expenses

The Company pays certain administrative fees of the Plan, including legal, trustee and audit fees. Direct expenses paid by the Plan for investment management and recordkeeping were approximately \$158,000 and \$189,000 for 2024 and 2023, respectively. Certain expenses are included in the transaction prices of investments bought and sold and are not separately quantifiable. The Plan charges certain loan and distribution fees to the impacted participants.

2. Summary of Significant Accounting Policies

a. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

b. Use of Estimates

The preparation of the financial statements in conformity with GAAP requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Net appreciation in fair value of investments consists of the net change in unrealized gains or losses during the year and the realized gain or loss on investments sold during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date.

d. Contribution Receivables

Contribution receivables are contributions earned during the year but not received until the subsequent period due to the timing of the deposit and can be from either the Company or the participants. Contribution receivables are recorded at cost and due to its nature, the Plan does not establish an allowance for credit losses for contribution receivables.

e. Notes Receivable from Participants

Notes receivable from participants are carried at their unpaid principal balance plus any accrued but unpaid interest. The Plan does not establish an allowance for credit losses on notes receivables since the receivables are fully secured by the participants' contributions to the Plan.

f. Payment of Benefits

Benefits are recorded when paid.

g. Subsequent Events

The Plan has evaluated subsequent events through September 10, 2025, the date the financial statements were available for issuance.

The Plan was amended on January 1, 2025 to remove the nonelective fixed employer contribution from the Participating Employer.

3. Plan Termination

Although it has not expressed any intention to do so, the Company may terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

4. Fair Value Measurements

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, establishes a framework for fair value measurements. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at fair value based on their quoted market price on an active market.

5. Risks and Uncertainties

The Plan assets are invested in a variety of investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, foreign currency and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, and therefore participant account balances.

6. Information Certified by the Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the financial statements and supplemental schedule was provided and certified by Fidelity, the trustee, as of December 31, 2024 and 2023 and for the years then ended as complete and accurate.

- Investments, at fair value
- Notes receivable from participants
- Investment income
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

7. Party-In-Interest Transactions

Certain Plan investment funds are managed by Fidelity, the trustee. Certain investment fees are paid by the trustee and are reflected in the investment income or loss for the year. The Plan also issues loans to participants that are secured by the vested balance in the participants' accounts. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Additionally, the Plan sponsor, nLIGHT, Inc., and the Participating Employer are parties-in-interest to the Plan; however, there were no transactions with the aforementioned parties other than the funding of contributions to the Plan and payment of certain administrative expenses of the Plan, which are exempt transactions.

8. Tax Status

Effective January 1, 2022, the Plan was restated utilizing a Fidelity Volume Submitter Plan Document (“Fidelity Plan Document”). Fidelity received an advisory letter from the IRS on June 30, 2020, in which the IRS stated that the Fidelity Plan Document, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the advisory letter. However, management of the Plan believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax exempt as of and for the years ended December 31, 2024 and 2023.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Independent Auditor's Report

To the Plan Administrator and Participants
nLIGHT, Inc. 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of nLIGHT, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. **nLIGHT, INC. 401(K) PLAN
NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023**

1. Description of Plan

The following description of the nLIGHT, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

a. General

The Plan was established January 1, 2001 by nLIGHT, Inc. (the “Company”) as a defined contribution plan under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The trustee of the Plan is Fidelity Management Trust Company (“Fidelity”). The Plan uses the Fidelity Volume Submitter Defined Contribution Plan prototype document. The Plan is administered by the Company as the Plan sponsor.

The Plan also includes employees from Nutronics, Inc. (the “Participating Employer”) which is owned by nLIGHT, Inc. In June 2023, the Participating Employer was renamed as nLight DEFENSE Systems, Inc.

b. Eligibility

Employees of the Company are eligible to participate in the Plan upon reaching 18 years of age except for temporary employees. Participants may enter the Plan on the first day of the month coinciding or following the date the employee meets the eligibility requirement.

c. Contributions

The Plan includes an automatic enrollment feature. New participants are automatically enrolled in the Plan with a 3% deferral rate, unless the participant affirmatively elects otherwise. Each participant having automatic enrollment contributions made on their behalf will have their deferral rate increased annually by 1%, up to a maximum of 10%.

Participants may contribute up to 100% of their eligible compensation to the Plan, subject to the Internal Revenue Service (“IRS”) limits. The Plan also allows rollover contributions from other qualified plans. Upon reaching the age of 50, eligible employees may make additional catch-up contributions as allowed by the IRC. The Company may make discretionary matching or qualified non-elective contributions to the Plan. The discretionary match is equal to 50% of the first 6% deferred by the participant. The Plan also makes a nonelective fixed employer contribution equal to 3% of the participant’s eligible compensation for employees under the Participating Employer.

d. Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, the Company's contributions, and an allocation of the Plan's earnings and expenses, and are valued on a daily basis. The current benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Vesting

Participants are immediately vested in their elective deferrals, rollover contributions, qualified non-elective contributions, nonelective employer contributions, and discretionary employer matching contributions to the Plan and the net earnings thereon.

f. Investments

Participants direct the investment of their account balances in one or a combination of several investment options offered by the Plan. Participants may change their investment elections or transfer their assets between investments on a daily basis.

g. Forfeitures

Participants who terminate employment forfeit the non-vested portion of Company discretionary matching contributions and earnings thereon. At December 31, 2024 and 2023, forfeitures totaling approximately \$2,000 and \$3,000, respectively, were available to reduce future Company contributions or pay Plan administrative expenses. During 2024 and 2023, forfeitures of approximately \$2,000 and \$0, respectively, were utilized to pay administrative expenses or to offset Company contributions.

h. Payment of Benefits

Upon reaching retirement age, termination of service or death, a participant may elect to receive their vested account balance in a lump-sum distribution. Account balances less than \$1,000 can be distributed at the trustee's discretion in a single lump-sum cash payment to the participant or beneficiary. Account balances greater than \$1,000 but less than \$5,000 can be rolled over to an individual retirement account at the discretion of the Plan Administrator for the participant.

i. Hardship Withdrawals

Upon certain conditions, participants, while still employed by the Company, are permitted to withdraw, in a single sum, a portion of their employee deferrals as a result of an immediate and heavy financial need subject to a \$500 minimum. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of postsecondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster clean-up on the participant's principal residence or to prevent eviction or foreclosure from the participant's principal residence.

j. Notes Receivable From Participants

Participants may borrow the lesser of \$50,000 or 50% of their vested account balance, subject to a \$1,000 minimum and certain other restrictions. Loans are secured by the vested account balance of the participant and bear interest at a rate equal to the prevailing interest rate that would be charged under similar circumstances as determined by the Company. Loans are repaid through payroll deductions over periods ranging up to five years unless the loan is used to acquire a principal residence, in which case the loan term may be for a period of ten years.

Interest rates on outstanding loans at December 31, 2024 ranged from 4.25% to 9.50%, maturing through 2034.

k. Administrative Expenses

The Company pays certain administrative fees of the Plan, including legal, trustee and audit fees. Direct expenses paid by the Plan for investment management and recordkeeping were approximately \$158,000 and \$189,000 for 2024 and 2023, respectively. Certain expenses are included in the transaction prices of investments bought and sold and are not separately quantifiable. The Plan charges certain loan and distribution fees to the impacted participants.

2. Summary of Significant Accounting Policies

a. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

b. Use of Estimates

The preparation of the financial statements in conformity with GAAP requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Net appreciation in fair value of investments consists of the net change in unrealized gains or losses during the year and the realized gain or loss on investments sold during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date.

d. Contribution Receivables

Contribution receivables are contributions earned during the year but not received until the subsequent period due to the timing of the deposit and can be from either the Company or the participants. Contribution receivables are recorded at cost and due to its nature, the Plan does not establish an allowance for credit losses for contribution receivables.

e. Notes Receivable from Participants

Notes receivable from participants are carried at their unpaid principal balance plus any accrued but unpaid interest. The Plan does not establish an allowance for credit losses on notes receivables since the receivables are fully secured by the participants' contributions to the Plan.

f. Payment of Benefits

Benefits are recorded when paid.

g. Subsequent Events

The Plan has evaluated subsequent events through September 10, 2025, the date the financial statements were available for issuance.

The Plan was amended on January 1, 2025 to remove the nonelective fixed employer contribution from the Participating Employer.

3. Plan Termination

Although it has not expressed any intention to do so, the Company may terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

4. Fair Value Measurements

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, establishes a framework for fair value measurements. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at fair value based on their quoted market price on an active market.

5. Risks and Uncertainties

The Plan assets are invested in a variety of investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, foreign currency and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, and therefore participant account balances.

6. Information Certified by the Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the financial statements and supplemental schedule was provided and certified by Fidelity, the trustee, as of December 31, 2024 and 2023 and for the years then ended as complete and accurate.

- Investments, at fair value
- Notes receivable from participants
- Investment income
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

7. Party-In-Interest Transactions

Certain Plan investment funds are managed by Fidelity, the trustee. Certain investment fees are paid by the trustee and are reflected in the investment income or loss for the year. The Plan also issues loans to participants that are secured by the vested balance in the participants' accounts. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Additionally, the Plan sponsor, nLIGHT, Inc., and the Participating Employer are parties-in-interest to the Plan; however, there were no transactions with the aforementioned parties other than the funding of contributions to the Plan and payment of certain administrative expenses of the Plan, which are exempt transactions.

8. Tax Status

Effective January 1, 2022, the Plan was restated utilizing a Fidelity Volume Submitter Plan Document (“Fidelity Plan Document”). Fidelity received an advisory letter from the IRS on June 30, 2020, in which the IRS stated that the Fidelity Plan Document, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the advisory letter. However, management of the Plan believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax exempt as of and for the years ended December 31, 2024 and 2023.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
