We have performed audits of the financial statements of Wacker Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### Note 1 - Plan Description

The following description of Wacker Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a voluntary defined contribution savings plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is sponsored by Wacker Chemical Corporation.

Substantially all salaried and nonunion hourly employees of Wacker Chemical Corporation and substantially all employees of the former Wacker Polymer Systems, Inc. (collectively, the "Company") are eligible to participate in the Plan on the first of the month on or following their dates of hire with the Company.

Effective January 1, 2011, substantially all employees of Wacker Polysilicon North America LLC (WPNA), a subsidiary of Wacker Chemical Corporation, are eligible to participate on the first of the month on or following their dates of hire with WPNA. Effective January 1, 2022, substantially all employees of Wacker Biotech US Inc. (WBU), a subsidiary of Wacker Chemical Corporation, are eligible to participate on the first of the month on or following their dates of hire with WBU. Effective April 26, 2024, substantially all employees of Wacker Silicone Manufactured Innovations LLC (WSMI), a subsidiary of Wacker Chemical Corporation, are eligible to participate on the first of the month on or following their dates of hire with WSMI.

#### **Contributions**

Participants may make annual contributions to the Plan on a pretax basis up to the maximum percentage of compensation and dollar amount permissible under the Internal Revenue Code (IRC). Additionally, participants may make after-tax contributions to the Plan, which are subject to certain limitations, as defined by the Plan and the IRC.

The Company is required to provide a matching contribution in an amount equal to 50 percent of the first 6 percent of the base compensation that the participant contributes to the Plan. Effective February 1, 2003, the Plan was amended to change the company contribution for participants who either (a) had their benefits frozen in Wacker Salaried Pension Plan or (b) were hired after January 31, 2003. For these participants, the Company now provides a matching contribution in an amount equal to 100 percent of the first 6 percent of the base compensation that the participant contributes to the Plan.

Subsequent to year end, the Plan was amended to remove the employer match on after-tax employee contributions.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Company 34 percent after one year of service and an additional 33 percent per year thereafter until becoming 100 percent vested. Participants become fully vested upon retirement, death, or disability.

### Note 1 - Plan Description (Continued)

#### ***Benefit Payments***

Upon termination of service, participants with account balances of less than \$1,000 will receive their vested account balance in a lump-sum amount. Participants with balances in excess of \$7,000 have the option of deferring payments until age 70½, age 72, or age 73, depending on their date of birth. In the event of an employee's death, the vested account balance will be paid to the participant's named beneficiary.

Participants may, at any time, make withdrawals from employee accounts attributable to after-tax or rollover contributions. Prior to termination, participants may not make withdrawals from employee accounts attributable to pretax contributions unless the participant has attained age 59½ or in the case of hardship, as defined in the plan document.

#### ***Participant Notes Receivable***

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the IRC. Participant notes receivable are collateralized by the participant's account balance and bear interest at a market rate

#### ***Transfers***

A participant from Wacker Union Savings Plan who becomes salaried or nonunion hourly may transfer his or her account balance to the Plan. In addition, a participant from the Plan who becomes eligible in Wacker Union Savings Plan may transfer his or her participant account balance in the Plan to Wacker Union Savings Plan.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions to the Plan.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, participants become 100 percent vested, and the net assets of the Plan will be allocated as prescribed by ERISA and its related regulations.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### ***Administrative Expenses***

Various administrative costs are periodically paid for by the Company.

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 5, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

### Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### ***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### ***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Note 4 - Fair Value Measurements (Continued)**

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management’s own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

**Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets.

**Collective Trust Fund**

The collective trust fund is valued at net asset value per share (NAV) or its equivalent of the fund, which is based on the fair value of the fund's underlying assets. There are no redemption restrictions or unfunded commitments related to this investment.
