NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

(1) DESCRIPTION OF PLAN:

The following description of Planmeca USA, Inc. and Planmed 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The financial statements were available to be issued on August 19, 2025, with subsequent events being evaluated through this date.

General -

The Plan is a defined contribution plan established on August 1, 1989 covering all employees of Planmeca USA, Inc., Planmed, and KaVo Dental (collectively, the Company), upon commencement of their employment, who are not:

- Independent contractors

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions -

Participants may contribute up to 75% of their compensation as defined by the Plan, limited to the maximum amount allowable under the IRS. Some or all of a participant's contribution may be designated as a Roth contribution. Roth contributions are made on an after-tax basis; however, such contributions will not be taxed at the time of distribution. Participants who have attained the age of fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified, defined contribution or defined benefit plans. The Plan also includes auto enrollment for all employees. After employment commences, unless participants elect otherwise, they automatically contribute 5% of eligible compensation to the Plan. Participants also receive matching contributions from the Company equal to 100% of a participant's deferral up to 3% of compensation, plus 50% of a participant's deferral over 3% and up to 5% of compensation. Additional discretionary employer contribution amounts may be contributed as determined by the Company.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts, mutual funds and common/collective trusts as investment options for participants. Contributions are subject to certain limitations.

Participant Accounts -

Each participant's account is credited with the participant's elective contribution, employer's contributions, rollovers, and earnings thereon. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(1) DESCRIPTION OF PLAN: (Continued)

Vesting -

Participants are immediately vested in their salary deferral contributions, the Company's matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service. A year of service, for vesting purposes, is defined as a Plan year in which the employee completes a whole year of service (1,000 hours or more).

Forfeited Accounts -

Forfeited balances of terminated participants' non-vested accounts are used to reduce employer contributions and/or administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$98 and \$51, respectively. Forfeitures of \$1,732 were used to reduce employer contributions during the year ended December 31, 2024.

Participant Loans -

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have one note outstanding at a time. The maximum loan term is five years, unless it is for the purchase of a principal residence, which can be repaid in ten years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates charged by commercial lending institutions, as periodically determined by the Plan administrator. The interest rate applicable to all outstanding loans is 4.25% at December 31, 2024. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits -

Participants withdrawing during the year for reasons of minimum required distributions, disability, retirement, death, or termination of employment are entitled to their vested account balance. If withdrawing participants are not entitled to their entire account balance, the amounts not received are forfeited. Benefit payments are made in the form of a lump sum payment, installment payments, an annuity, or a direct rollover into an Individual Retirement Account or another qualified plan. A participant with a vested balance not exceeding \$1,000 will receive a lump sum amount equal to the value of the participant's vested interest in their account. If the participant's vested balance exceeds \$1,000 but is less than \$5,000, the participant must withdraw or roll over the funds themselves or the Plan will roll over the balance into an IRA that is established for the participant. In-service withdrawals are available to participants who meet certain hardship requirements or attain age 59-1/2.

(2) SUMMARY OF ACCOUNTING POLICIES:

Basis of Accounting -

The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates -

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

(2) SUMMARY OF ACCOUNTING POLICIES: (Continued)

Investment Valuation and Income -

Appreciation or depreciation in the market value of an investment held both at the beginning and end of the year is equal to the difference between the market value at the beginning and end of the year. Appreciation or depreciation in the market value of an investment acquired during the year and held at the end of the year is equal to the difference between the cost and the market value of the investment at the end of the year.

Gain or loss recognized from the disposition of an investment held at the beginning of the year is equal to the difference between the market value of the disposed asset at the beginning of the year and the proceeds from disposition. Gain or loss realized from the disposition of an investment acquired during the year is equal to the difference between the cost and the proceeds from disposition.

Notes Receivable from Participants -

Notes receivable from participants are measured at their unpaid principal balances plus accrued interest, if any.

Payment of Benefits -

Benefits are recorded when paid.

Administrative Expenses -

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid by the Company. Administrative expenses of \$63,157 were paid by the Plan during the year ended December 31, 2024.

(3) PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(4) FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

(4) FAIR VALUE MEASUREMENTS: (Continued)

Level 2:

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024.

Common/Collective Trust: Valued periodically based upon the current fair value of the underlying assets of the fund based on quoted market prices.

Pooled Separate Accounts: Investments in shares of pooled separate accounts held with an insurance company are stated at estimated fair market value and are valued by the insurance company based on the net asset value of shares held by the Plan at year end. The net asset value is determined by the insurance company based on the market value of the underlying investments held in the pooled fund.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Shares in registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) INCOME TAXES:

The Plan has adopted the Principal Life Insurance Company Pre-Approved Profit Sharing Plan with CODA, which is a non-standardized prototype plan. The prototype plan has received a determination letter from the IRS dated June 30, 2020, stating that the prototype plan is qualified under the Internal Revenue Code (IRC). Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes the Plan has been operated in compliance with the applicable requirements of the IRC and, therefore, the Plan is exempt from taxation.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan believes it is no longer subject to income tax examination for years prior to 2021.

(6) CERTIFIED INVESTMENTS:

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation/depreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company (the trustee of the Plan).

(7) RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(8) PARTY-IN-INTEREST TRANSACTIONS:

As of December 31, 2024 and 2023, \$18,407,848 and \$16,159,248 of the Plan's investments are shares of pooled separate accounts or common/collective trusts offered by Principal Life Insurance Company or one of its subsidiaries, respectively. As Principal Life Insurance Company is the Trustee of the Plan, these investments qualify as party-in-interest investments. Fees were paid by the Plan to Principal Life Insurance Company for investment and recordkeeping services in the amount of \$63,157 for the year ended December 31, 2024, which qualifies as a party-in-interest investment.

Participants covered under the Plan are considered to be parties-in-interest. Participant loans in the amount of \$344,766 and \$342,817 December 31, 2024 and 2023, respectively, are considered to be party-in-interest investments.
