### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Beyer Automotive 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control related matters that we identified during the audit.



#### Note 1. Description of the Plan

The following description of Beyer Automotive 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution 401(k) profit-sharing plan that is available to all eligible employees of Beyer Automotive Management (the Company). The Board of Directors of the Company controls and manages the operation and administration of the Plan. Principal Trust Company and Principal Life Insurance Company (Principal) serve as the custodians of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On October 10, 2024, the Plan Sponsor changed ownership. With this change in ownership, the Plan Sponsor name changed from Don Beyer Motors, Inc., to Beyer Automotive Management, LLC. The Plan name changed from Don Beyer Motors 401(k) Plan to Beyer Automotive 401(k) Plan. The change in ownership did not affect plan operations.

Eligibility: All employees of the Company who have attained the age of 21 and completed one year of service (1,000 hours in a twelve-month period), are eligible for participation. Eligible employees begin to participate on January 1, April 1, July 1, or October 1, following completion of the age and service requirements. The plan document was amended effective April 1, 2023 reducing the service requirement from one year of service (1,000 hours in a twelve-month period) to 60 days. Entrance dates remain quarterly.

Contributions: Each year, participants may elect to defer a portion of their eligible compensation, as defined by the Plan, up to the maximum dollar limit prescribed by the Internal Revenue Code (IRC). The Plan has an automatic enrollment provision whereby participants will automatically have 6% of their compensation deferred into the Plan as a pre-tax elective deferral, unless they make an alternative election or opt-out of participation. The automatic deferral percentage will increase by 1% per year thereafter until it reaches 10%. Participants who attain age 50 by the end of the Plan year are eligible to make additional (catch-up) contributions, subject to annual limitations. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan also includes a Roth 401(k) deferral option.

The Company may make a discretionary matching contribution as determined by the Board of Directors. During the year ended December 31, 2024 and 2023, the Board of Directors chose to make a matching contribution equal to 25% of the first 6% of eligible compensation that a participant contributes as an elective deferral. The Company may make an annual discretionary non-elective contribution which is allocated to participants employed on the last day of the Plan year at the discretion of the Company's Board of Directors. During the year ended December 31, 2024, no such contribution was made.

Participant Investment Options: Participants direct the investment of contributions into various investment options offered by the Plan. Participants may change their investment allocation at any time.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, if any, (b) An allocation of Plan earnings, net of administrative expenses. The Plan's earnings or losses are allocated according to the participant's relative account balance in the various investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting: Participants are immediately 100 percent (100%) vested in their salary deferral and rollover contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. After two years of service, participants become vested at 20 percent (20%). Vesting increases an additional 20% per year thereafter until the participant is fully vested after six years of service. Participants become fully vested upon retirement, disability or death.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator. At December 31, 2024 and 2023, outstanding notes bore interest rates of 5.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits: A participant or beneficiary shall be entitled to receive all or a portion of the balance held in his or her account upon termination of employment, retirement, death, or disability. The plan provides for in-service distributions for participants reaching age 59 ½ and in the event of a severe financial hardship, as defined by the plan. Participant benefits are paid in a lump sum payment or non-recurring partial payment. Vested balances of less than \$1,000 may be automatically distributed without participant consent in a single lump-sum payment. Vested balances greater than \$1,000 but less than \$5,000 may be automatically rolled-over without participant consent to an individual retirement account.

Forfeited Accounts: A participant's accrued vested benefit is determined on the date employment is terminated. The non-vested portion is forfeited upon total distribution of an individual's account. Forfeitures of participant's non-vested accounts are used to reduce matching contributions or to pay administrative expenses. Forfeited non-vested accounts amounted to \$1,109 and \$18 as of December 31, 2024 and 2023, respectively. During 2024, forfeitures of \$35,313 were used to reduce matching contributions, forfeitures of \$18 were reallocated to participants and forfeitures of \$12,544 were used to pay administrative expenses.

Administrative Expenses: All significant costs to administer the Plan are paid by the Plan if not paid by the Company. Any expenses paid by the Company are not reflected in the accompanying financial statements.

#### **Note 2. Summary of Significant Accounting Policies**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid for transferring a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: In preparing these financial statements, the Plan Administrator has evaluated events and transactions for potential recognition or disclosure through August 18, 2025, the date the financial statements were available to be issued. See Note 11.

#### **Note 3. Information Certified by the Custodians**

Certain information related to investments is disclosed in the accompanying financial statements and ERISA-required supplementary schedules, including investments from participants held at December 31, 2024 and 2023, and net appreciation in fair value and contract value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to information certified as complete and accurate by Principal Life Insurance Company (the Plan's Custodian). The Custodian did not certify the notes receivable due from plan participants as of December 31, 2024 and 2023, nor the related interest income received from participant loans for the year ended December 31, 2024.

#### Note 4. Investments and Fair Value Measurements

The Plan measures on a recurring basis its investments at fair value in accordance with Financial Accounting Standards Board (FASB) codification *Fair Value Measurement*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that are accessible to the Plan. These generally provide the most reliable evidence and are used to measure fair value whenever available.
- Level 2 Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, which are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted prices for similar assets or liabilities in active markets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The inputs or methodology used for valuing investments are not an indication of the risk associated with investing in those securities.

The following are descriptions of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Shares of registered investment companies (mutual funds) are valued at the daily closing price as reported by the funds. The funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. The funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Units of participation in pooled separate accounts are reported at the accumulated value of units held by the Plan at year-end as reported to the Plan by the insurance company. The accumulated unit value is determined daily by the custodians and is based on the net asset value of shares in the underlying fund, the fund's dividends and the contract's separate account charges. While some pooled separate accounts may have publicly quoted pricing inputs (Level 1), the account values of pooled separate accounts are not publicly quoted and are, therefore, classified as Level 2 investments.

Collective investment trusts: The Plan invests in a variety of collective investment trusts offered separately by Principal Global Investors Trust Company.

The Plan invests in a stable value collective trust fund for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the net asset value (NAV) provided by the custodian, Principal, as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the stable value collective trust fund, the issuer reserves the right to require 12-months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Plan invests in Principal Life-Time Hybrid collective investment trust funds offered by Principal Global Investors Trust Company. The collective investment trust funds are valued based upon the net asset value (NAV) of units of the Trusts as reported to the Plan by the trusts. Units of the trusts are published daily and used as the basis for current transactions. The units of the CIT are valued daily based on closing market prices of the underlying investments. The daily unit value is computed by dividing the total assets of the trusts, less its liabilities, by the total number of units outstanding as of the valuation date. Investment income earned is reinvested in the trusts and included in the determination of unit values. The collective investment trust funds provide for daily redemptions by the Plan at reported NAV, with no advance notice requirements.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain investments or financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5. Investment Contract with Insurance Company

The Plan has entered into a group annuity contract with Principal Life Insurance Company (Principal) which provides for investments in various pooled separate accounts and allows for the purchase of deferred income annuities issued by Principal Life Insurance Company. The pooled separate accounts are credited with earnings on underlying investments and charged for participant withdrawals and certain administrative expenses. The pooled separate accounts consist of various fund investment options covering multiple asset classes.

#### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

#### **Note 7. Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are funds managed by Principal and its affiliates. The Principal companies are the custodians as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to the Custodians by the Plan for administrative services were \$55,232 for the year ended December 31, 2024.

#### **Note 8. Tax Status**

The Plan has adopted a non-standardized pre-approved profit-sharing plan with CODA sponsored by Principal Life Insurance Company. The sponsor of the prototype plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, that the prototype plan as then designed, was in compliance with the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

#### **Note 10. Prohibited Transactions**

The participant contributions and loan repayments of \$7,576 were untimely remitted to the Plan during the year ended December 31, 2024. The lost earnings will be remitted during 2025. The Plan Sponsor will file Form 5330 in 2025 and pay the applicable excise taxes.

#### **Note 11. Subsequent Events**

Effective April 1, 2025, OR Topco, LLC was added as an adopting employer of the Plan.
