### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Wacker Union Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

### Note 1 - Plan Description

The following description of Wacker Union Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement and related union agreements, if applicable, for a more complete description of the Plan's provisions.

#### **General**

The Plan is a voluntary defined contribution savings plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is sponsored by Wacker Chemical Corporation (the "Company").

All hourly employees of the Company represented by the United Steelworkers of America (USWA) and its Local Number 7237, Steelworkers Local Number 727, and Teamsters Local Union Number 348 are eligible to participate in the Plan on the first of the month on or following their dates of hire with the Company.

#### **Contributions**

Participants may make annual contributions to the Plan on a pretax basis up to the maximum percentage of compensation and dollar amount permissible under the Internal Revenue Code (IRC). Additionally, participants may make after-tax contributions to the Plan, which are subject to certain limitations, as defined by the Plan and by the IRC.

For employees of USWA Local Number 7237, the company match is equal to 50 percent of employee deferrals up to 6 percent of eligible compensation, as defined by the Plan. In addition, for certain employees in Location Code 001 of USWA Local Number 7237, the Plan also provides a nonelective company contribution of 3 percent of eligible compensation, as defined by the Plan.

For employees of Steelworkers Local Number 727, the company match is equal to 100 percent of employee deferrals up to 6 percent of eligible compensation, as defined by the Plan. There is no nonelective company contribution.

For employees of Teamsters Local Union Number 348, the company match is equal to 50 percent of employee deferrals up to 6 percent of eligible compensation, as defined by the Plan, with a 3 percent nonelective company contribution.

The Plan may accept rollover contributions from other qualified plans.

Subsequent to year end, the Plan was amended to remove the employer match on after-tax employee contributions.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, company matching and other contributions, and an allocation of plan earnings and expenses based on the participant's proportionate share of funds in each of the investment accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants' accounts of the Plan are invested as directed by the participants in any one or more investment alternatives offered by the Plan.

#### **Benefit Payments**

Upon termination of service, participants with account balances under \$1,000 will receive their vested account balances in lump-sum amounts. Participants with balances in excess of \$1,000 have the option of deferring payments until age 70½. In the event of an employee's death, the vested account balance will be paid to the participant's named beneficiary.

### Note 1 - Plan Description (Continued)

Participants may make withdrawals at any time from participants' accounts attributable to after-tax or rollover contributions. Prior to termination, participants may not make withdrawals from employee accounts attributable to pretax contributions unless the participant has attained age 59½ or in the case of hardship, as defined in the plan document.

#### ***Vesting***

Participants are immediately 100 percent vested in their contributions to the Plan. A participant becomes 34 percent vested in employer contributions after completing one year of service and an additional 33 percent per year thereafter until becoming 100 percent vested. Participants become fully vested upon retirement, death, or disability.

#### ***Participant Notes Receivable***

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the IRC. Participant notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

#### ***Transfers***

A participant from Wacker Savings Plan who becomes collectively bargained may transfer his or her account balance to the Plan. In addition, a participant from the Plan who becomes salaried or nonunion hourly may transfer his or her participant account balance to Wacker Savings Plan.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce the Company's matching contributions to the Plan.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances, and the net assets of the Plan will be allocated as prescribed by ERISA and its related regulations.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### ***Administrative Expenses***

Various administrative costs are periodically paid by the Company.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 12, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

### Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### ***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### ***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Note 4 - Fair Value Measurements (Continued)**

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management’s own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

**Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets.

**Collective Trust Fund**

The collective trust fund is valued at net asset value per share (NAV) or its equivalent of the fund, which is based on the fair value of the fund's underlying assets. There are no redemption restrictions or unfunded commitments related to this investment.
