## Independent Auditors' Report

### Board of Trustees of The Episcopal School in the City of New York

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Episcopal School DC Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## 1. Description of Plan

The following description of The Episcopal School DC Retirement Plan (the "Plan") is provided for general information purposes only. Participants and all others should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan, established in 1989, is a defined contribution plan which is available to eligible employees of The Episcopal School in the City of New York (the "School"). Participation is voluntary and employees may enroll in the Plan at any time during their employment with the School for participant contributions and following one year of employment with the School for School contributions. There are no special age requirements to be satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

On December 31, 2017, \$4,109,025 of assets were transferred into the Plan from The Episcopal School Tax-Deferred Annuity Plan (the "TDA"). These assets represented the accounts of participants who were contributing into another plan the School sponsored. Effective January 1, 2018, the School adopted a new plan document combining the two (2) plans.

During 2019, the Plan changed vendors from Teachers Insurance and Annuity Association of America and College Retirement Equities Fund ("TIAA and CREF") to The Ascensus Trust Company ("Ascensus"). Current Plan participants were given an option to maintain balances previously held through TIAA and CREF during 2019 or transfer their assets to Ascensus, however, all new contributions to the Plan may only be made to Ascensus. As a result, \$3,672,277 of Plan assets were transferred from TIAA and CREF to Ascensus and the Plan restated its Plan document effective July 1, 2019. TIAA and CREF and Ascensus both serve as Trustees of the Plan and handle administrative duties.

### **Contributions**

Participants under the Plan may elect to reduce their compensation by a specific percentage and have that amount contributed to the Plan on a pre-tax or Roth basis. Employer non-elective contributions are allocated to the individual accounts of qualifying participants each Plan year equal to 5% of compensation for employees between one and five years of service, and 10% for employees with more than five years of service, as defined in the Plan document. The Plan, by law, cannot recognize contributions in excess of a specified dollar limit set by the Internal Revenue Service ("IRS") each year.

Participants may also contribute amounts representing distributions from other qualified plans.

### **Vesting**

Participants are 100% vested in their contributions (including rollovers) and any allocated earnings or losses thereon. All employer contributions to the Plan and the earnings or losses thereon are fully vested when made.

### 1. Description of Plan *(continued)*

#### ***Participant Accounts***

Participants direct the contribution to their choice of investments offered by the Plan. Each participant's account is credited with the participant's allocation of employer contributions and allocations of the Plan earnings on his or her specific investments. Allocations of Plan earnings are based on each participant's account balance and charged with any applicable withdrawals, Plan losses and administrative expenses, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

#### ***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account as permitted by the Plan. In addition, participants may request distributions due to disability, or after reaching age 59 ½. The Plan's policy is to make payments in lump sum, partial or installment payments, or annuity contract (if assets are held in a custodial account).

A participant may apply for a hardship withdrawal at any time. This withdrawal must be for an immediate financial need for which funds are not reasonably available from other resources. Hardships include post-secondary education expenses for the participant or their dependents, medical expenses to the extent not otherwise reimbursed under the School's medical programs, expenses for the purchase of a principal residence or major alteration thereto, to prevent eviction from or foreclosure on a principal residence and to pay for funeral or burial expenses or immediate and heavy financial need as determined based on Internal Revenue Service Regulations.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000. Participant loans are secured by the balance in the participant's account and bear interest at prime rate plus one percent. Loans must be repaid within five years, unless the loan is used to purchase a participant's principal residence or the participant is on authorized leave for military service for a period which extends the maturity date of the loan beyond five years.

### 2. Summary of Significant Accounting Policies *(continued)*

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates (continued)***

The Plan was viewed as an amalgamation of individual annuity and custodial accounts, and the Plan and its record-keepers did not maintain financial information at the Plan level. Because certain historical records were not maintained or are not available at the Plan level, the Plan has excluded, from investments in the accompanying statements of net assets available for benefits, certain annuity and custodial accounts, and related activity, issued to current and former employees prior to January 1, 2009. This accounting policy election is permitted by the Department of Labor's ("DOL") Field Assistance Bulletin No. 2009-02 ("FAB 2009-02"), "Annual Reporting Requirements for 403(b) Plans", however, U.S. GAAP requires that these accounts and the related income and distributions be included in the accompanying financial statements. The amount of these excluded annuity and custodial accounts and the related income and distributions are immaterial to the Plan.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

#### ***Investment Valuation and Income Recognition***

The TIAA Traditional Annuity Account is an unallocated contract. The fully benefit responsive contracts are carried at contract value and the non-benefit responsive contracts are carried at fair value, which approximates their contract value. Contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers in (if any), less any withdrawals and transfers out (if any). The fair value is derived from a discounted cash flow analysis and other factors. Investments in registered investment companies and money market fund are stated at fair value as determined by quoted market prices, which represents the net asset value of shares held by the Plan at year end. The pooled separate account is valued at the NAV of units held by the Plan. The NAV, as provided by TIAA and CREF, is used as a practical expedient to estimate fair value. The NAV based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### 2. Summary of Significant Accounting Policies (*continued*)

#### ***Expenses***

All expenses of maintaining the Plan are paid by the School and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded upon a distributable event.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 16, 2025.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, dividends and interest income and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF and Ascensus, LLC, as agent for Ascensus Trust Company and Newport Trust Company, LLC qualified institutions.

#### ***TIAA Traditional Annuity***

The TIAA Traditional Annuity is comprised of six types of contracts. The fully benefit responsive contracts are the Group Supplemental Retirement Annuity ("GRSA"), the Supplemental Retirement Annuity ("SRA"), and the Retirement Choice Plus contracts. The non-benefit responsive contracts are the Group Retirement Annuity, Retirement Annuity ("RA"), and Retirement Choice contracts. The Plan utilizes the GSRA and SRA contracts, which are reported at contract value, and the RA contract, which is reported at fair value. Contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers in (if any), less any withdrawals and transfers out (if any). Contract value approximates a discounted cash flow value calculated using a risk-adjusted market discount rate which correlates closely with the TIAA Traditional Annuity's historical crediting rates. Unobservable inputs include the risk-adjusted discount rate applied and the range of significant input values are as follows: GSRA – 4.50% - 4.75%; SRA – 4.50% - 4.75%; and RA – 5.25% - 5.50%.

#### ***TIAA Traditional Annuity (continued)***

Under GSRA and SRA contracts, lump-sum withdrawals and transfers can be done at any time without any restrictions or charges. Under the RA contract, lump-sum cash withdrawals are not allowed and all other withdrawals and transfers must be paid in ten annual installments.

The contracts use the vintage method to credit interest to the TIAA Traditional Annuity Account. Vintages are time periods that represent when money was initially invested in the TIAA Traditional Annuity Account and corresponding interest rate during that distinct time period. The vintage method recognizes the fact that the level of prevailing interest rates available on new long-term investments will vary over time and that as the long-term investments in a specific vintage mature, they will be reinvested at different rates. When funds flow into the TIAA Traditional Annuity Account, they are immediately invested at the prevailing pay-in-rate for new money. The funds earn interest at the prevailing vintage rates. The vintage will always consist of two parts: the guaranteed portion and the discretionary portion. The guaranteed portion represents the minimum amount of interest that will be credited to an account, regardless of the economic environment. The discretionary portion represents interest earned over and above the guaranteed rate.

The TIAA Traditional annuity represents approximately 9% and 9% of the Plan's net assets available for benefits as of December 31, 2024 and 2023, respectively, and represents an obligation from TIAA to repay as amounts come due. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investors Service (Aa1 as of October 2024), Standard and Poor's (AA+ as of May 2024), A.M. Best (A++ as of July 2024), and Fitch (AAA as of August 2024). The plan administrator does not believe that any events would limit the Plan's ability to transact at contract value.

#### ***TIAA Real Estate***

The TIAA Real Estate Account generally invests in real estate properties and real estate-related investments. The TIAA Real Estate Account's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The TIAA Real Estate Account sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. While redemptions from the TIAA Real Estate Account may occur daily, transfers out are limited to one per calendar quarter. There are no unfunded commitments on the Plan's investments.

### 5. Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### 6. Tax Status

The School has adopted a restated prototype plan document effective July 1, 2019 which is intended to satisfy the Internal Revenue Service's final 403(b) regulations. The prototype plan document preparer received an opinion letter dated August 7, 2017 from the Internal Revenue Service. The Plan has been amended since receiving the opinion letter, however, the School believes that the Plan is designed and currently being operated in accordance with applicable sections of the Internal Revenue Code.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examination by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### 7. Party-in-Interest Transactions

Certain investments are managed by TIAA and CREF and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the School who participate in the Plan, provide administrative services to the Plan at no cost to the Plan.

### 8. Late Remittances

During 2024, the School was outside of the period described by Department of Labor regulations to transmit to the Plan certain participants' contributions and loan repayments totaling \$11,946. Plan management has since remitted the participants' contributions and loan repayments and calculated and remitted lost earnings for the delinquent contributions in August of 2024 and January of 2025.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements.
