We have performed audits of the financial statements of Echo Global Logistics 401(k) Savings and Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Echo Global Logistics 401(k) Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which was established on January 1, 2013, is a defined contribution plan covering all employees of Echo Global Logistics (the Company) who have 30 days of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Act of 1974, as amended (ERISA).

On June 3, 2022, Echo Global Logistics acquired Roadtex Corp. On July 8, 2022, all employees were automatically enrolled within the Echo Global Logistics 401(k) Savings and Retirement Plan and the Roadtex Corp 401k Plan was frozen.

On November 1, 2022, Echo Global Logistics acquired Fastmore Logistics, LLC. The Fastmore Logistics LLC 401(k) Plan continued to operate through December 31, 2022. At that time, the Plan was frozen. All employees of Fastmore Logistics 401(k) plan became eligible for the Plan effective January 1, 2023. The Fastmore Logistics 401(k) plan merged into the Plan effective May 1, 2023. On May 10, 2023, total assets of approximately \$2,516,000 were transferred into the Plan. On May 24, 2023, the assets transferred were allocated to participants.

Plan Administration

The Plan's assets are held in a trust fund with Principal Trust Company (Principal), the trustee of the Plan. The Plan is administered by the 401(k) plan committee.

Contributions

Employees may make pre-tax and Roth contributions up to 100% of annual compensation, as defined in the Plan and are subject to Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. All newly hired employees eligible to become participants in the Plan will be enrolled in the Plan's automatic escalation feature, which will automatically increase their elective deferrals 1% annually up to 10%.

The Company may make a discretionary match. The Company contributed 25% of the first 8% of base compensation that a participant contributed to the Plan for the 2024 and 2023. The Company may provide a discretionary profit-sharing contribution. For the years ended December 31, 2024 and 2023, there were no discretionary profit-sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company's matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as

defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus the actual earnings thereon. Vesting in the Company's contribution portion (Employer Match and Profit Sharing), of participants' accounts, plus the actual earnings thereon, is based on years of credited service. Upon normal retirement or death, all contributions become fully vested. Participants vest in the Company's contribution portion and earnings thereon according to the following schedule:

Less than one year of service	0%
One year of service	33%
Two years of service	67%
Three or more years of service	100%

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account, which are based on rates available for similar loans from commercial lending institutions as determined by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions. Repayment occurs over a period not to exceed five years, unless the loan is to acquire any dwelling unit that is or will be the principal residence of the participant, in which case the repayment period may extend to 10 years. Participants can have no more than one loan outstanding at a time.

Payment of Benefits

Participants may take withdrawals prior to termination of employment under a hardship withdrawal, rollover contribution, or an age 59½ withdrawal, whereby a participant may withdraw all or any portion of his or her vested account balance. Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

The Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act) changed the age at which participants are required to take required minimum distributions from their accounts. Under the new law, effective January 1, 2020, participant distributions may not be deferred past April 1 following the year in which the participant reaches the age of 72.

Forfeitures

The forfeited non-vested account balance was approximately \$0 and \$0 as of December 31, 2024 and 2023, respectively. Forfeitures may be used to pay administrative expenses or to offset the Company's contributions. During December 31, 2024, the Plan utilized forfeitures in the amount of \$144,979 to offset the Company's contributions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

Benefit Payments

Benefits are recorded when paid.

Risk and Uncertainties

The Plan invests in various investment securities. These investment securities are exposed to various risks, such as interest rate, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

NOTE C - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. Financial Accounting Standards Board Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. That hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If an asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of an asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds - Valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

Collective trust funds - Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business matter.

Pooled separate accounts - Pooled separate accounts are valued on a NAV basis as determined by Principal. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. All investments in this category can be redeemed daily, have a daily redemption notice period and have no unfunded commitments. The fair values of these investments are determined by reference to the respective fund's underlying assets, with Principal specifying the source(s) to use for underlying investment asset prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of mutual funds managed by an affiliate of Principal. The Plan also allows loans to participants. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE F - INCOME TAX STATUS

The Company adopted a non-standardized prototype plan sponsored by Principal. The prototype plan obtained its latest opinion letter on March 14, 2014, in which the Internal Revenue Service (IRS) stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not requested its own determination letter from the IRS. The Plan has been amended but the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan was qualified and that the related trust was tax-exempt as of December 31, 2024 and 2023.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE H - DELINQUENT CONTRIBUTIONS

During 2020, the Plan Sponsor inadvertently failed to deposit \$3,161 of participant contributions within the required time frame specified by the Department of Labor (DOL). The DOL considers late deposits to be nonexempt or prohibited transactions. For the 2020 late deposit, the Plan will deposit lost earnings and also file Form 5330 and pay applicable excise taxes to correct this failure. The excise tax payments will be made from the Company's assets and not from assets of the Plan.

During 2023, the Plan Sponsor inadvertently failed to deposit \$99 of participant loan repayments within the required time frame specified by the Department of Labor (DOL). The DOL considers late deposits to be nonexempt or prohibited transactions. For the 2023 late deposit, the Plan will deposit lost earnings and also
