## Independent Auditor's Report

To the Plan Administrator of Nashville Christian Schools Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE A - DESCRIPTION OF PLAN**

The following description of Nashville Christian Schools Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering a majority of all full-time employees of Nashville Christian Schools Inc. (the "School") who are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation subject to IRS prescribed limits. Participants may also contribute amounts representing distributions from other qualified plans. The School may make discretionary contributions to the plan. For 2024 and 2023, the employer elected to match 100% of the employees' contributions up to \$1,000.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the School's contribution and (b) plan earnings. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants' nonvested accounts are used to reduce future School contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the School's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants become 100% vested in the School's discretionary contribution portion after 5 years of service.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer discretionary contributions to selected investment options. Participants may change their investment options at any time.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Note Receivable from Participant

The Plan allows participants to borrow from their accounts. The note receivable from participant is secured by the applicable participant's account balance and bear interest at a rate which is commensurate with local prevailing rates as determined quarterly by the School. As of December 31, 2024 and 2023 this effective rate on note receivable was 9.50%. Principal and interest are paid through payroll deductions. As of December 31, 2024 and 2023 note receivable from participant totaled \$1,811 and \$-0-, respectively.

Administrative Costs

The School absorbs significant administrative costs of the plan.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition

The Plan's investments consist of shares of registered investment companies which are stated at fair value. Quoted market prices are used to value investments. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Payments of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures of contingent assets and liabilities at the date of the financial statements, and the reported revenue and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances. Any accrued but unpaid interest is included in the employee's contribution receivable. Interest income is recorded on the accrual basis. Related fees are recorded in the notes receivable from participants and paid out of the participant's account when they are incurred.

Management estimates an allowance for uncollectible notes receivable based on the related participant account balances and historical trends. Management has estimated the allowance for uncollectible notes receivable from participants to be \$-0- as of December 31, 2024 and 2023.

Forfeitures

As of both December 31, 2024 and 2023, there were no funds remaining in the forfeited non-vested accounts. During the year ended December 31, 2024 and 2023 forfeiture funds to reduce the employer contribution totaled \$4,019 and \$6,516, respectively.

**NOTE D – PARTY-IN-INTEREST TRANSACTIONS**

During the years ended December 31, 2024 and 2023, certain plan investments included registered investment companies managed by American United Life Insurance Company, a One America Company, the custodian of the plan. These transactions qualify as party-in-interest transactions.

**NOTE E - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**NOTE F - TAX STATUS**

The Plan has adopted a prototype non-standardized 401(k) profit sharing plan agreement that was sponsored by the Plan's third-party administrator. Although the Plan has been amended since the prototype non-standardized 401(k) profit sharing plan determination letter was received the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, management believes the Plan was qualified as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken any uncertain tax positions that more likely than not would not be sustained upon examination by the Internal Revenue Service ("IRS"). As of December 31, 2024 and 2023, the Plan has not recognized any uncertain tax positions. The plan is subject to audits by taxing and compliance jurisdictions; however, there are currently no audits for tax periods in process. The plan is no longer subject to tax examination for years prior to 2019.

**NOTE G – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE H – GUARANTEED INTEREST CONTRACTS**

The Plan has an interest-earning investment option, backed by American United Life Insurance Company, a One America Company's ("AUL") general account assets. AUL guarantees that interest will be credited at the higher of the rate guaranteed in the group annuity contract and the current rate declared by it. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attributable to the guaranteed investment contract. Contract value, as reported to the plan by AUL represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 4 percent. Such interest rates are reviewed on a quarterly basis for resetting. As of December 31, 2024 and 2023 the contract value was \$93,806 and \$95,552, respectively.

**NOTE I – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Codification 820-10 (FASB ASC 820-10), *Fair Value Measurements* (formerly FASB Statement No. 157), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

*Registered investment companies:* Value is based on quoted asset values of the shares held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Revenue Sharing Formula:

The investment options of the Plan include various portfolios within an AUL separate account. The separate account in turn invests in investment portfolios of certain open-end management investment companies. AUL receives indirect compensation from these investment companies for the services provided by AUL.

The compensation received by AUL is computed by each investment company by multiplying the daily account balance of the AUL separate account's interest in a particular portfolio by a predetermined percentage rate negotiated with the investment company. This indirect compensation is not charged to the plan or participants accounts but is paid directly by the investment company.
