INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Lampo Group, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

Basis for Opinion

NOTE 1: DESCRIPTION OF THE PLAN

The following description of The Lampo Group, LLC 401(k) Plan (the “Plan”) provides only general information. Refer to Plan documents for a more complete description of Plan provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Ramsey Solutions (“the Company”, “Sponsor”, “Employer” or “Plan Administrator”). The Plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Plan’s Investment Committee (Investment Committee) determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s Board of Trustees.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Capital Bank and Trust Company, the trustee or custodian and the qualified institution for the Plan, which invests contributions and Plan earnings, makes investment transactions as directed by the Investment Committee and provides certain recordkeeping services. Capital Group acts as the third-party administrator for the Plan, which performs certain plan administration and annual ERISA compliance testing.

Eligibility

Employees may become a participant of the Plan when they are age eighteen or older. An eligible employee may enter the Plan on the first day of the month after all entry requirements have been met. Employees become eligible to receive the employer match after one year of service.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation as defined in the Plan document up to the regulatory limit. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Also, participants may elect to have a percentage of their elective deferrals to be designated as Roth 401(k) deferrals which are contributed to the Plan after-tax and includible in the computation of the participant’s personal income. Lastly, participants may elect to have a percentage of their elective deferrals to be designated as after-tax voluntary employee contributions which are contributed to the Plan after-tax and are includible in the computation of the participant’s taxable income. Investment gains on the after-tax deferrals are taxed as ordinary income upon taking a qualified distribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

NOTE 1: DESCRIPTION OF THE PLAN (Continued)

The Company contributes 100% of the first 4% of compensation that a participant contributes to the Plan. The Company also has a discretionary contribution up to 6% of compensation based on each plan year. The matching Company contribution is invested as directed by the participant. Additional profit sharing amounts may be contributed at the option of the Company and are invested as directed by the participant.

During the year ended December 31, 2024, the Company did not make a discretionary contribution or a profit sharing contribution to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company's matching contributions, as well as allocations of the Company's discretionary contributions, the Company's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are immediately vested in Company's safe harbor matching contributions. Vesting in the Company's discretionary and profit sharing contribution portion of their accounts, if applicable, is based on years of continuous service, and a participant is 100% vested after three years of service.

Benefit Payments

Participants are eligible to receive benefits upon retirement, death, disability, or termination of employment. Benefit and termination payments are made in the form of a lump-sum payment equal to the value of the participant's vested interest in his or her account or partial withdrawals of the vested interest in his or her account. Participant accounts with a vested interest of less than \$5,000 may only receive payment of benefits in a lump-sum payment, but this distribution must be consented to before being made. Participant accounts with a vested interest of less than \$1,000 will receive an automatic lump-sum distribution.

Forfeitures

At December 31, 2024 and 2023, the forfeited nonvested accounts totaled \$255,765 and \$135,630, respectively. These accounts will be used to pay administrative expenses and reduce future employer contributions. In 2024, employer contributions were reduced by \$48,000 from forfeited nonvested accounts.

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC), a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and the custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Distributions to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, September 8, 2025, and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

NOTE 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company, the qualified institution:

- a) Total investments, at fair value, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b) Investment income, information included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- c) All amounts included in Note 4, *Fair Value Measurements*
- d) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024

NOTE 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

NOTE 5: TAX STATUS

The Plan uses a pre-approved plan document sponsored by Capital Group Retirement Plan, which received an opinion letter from the IRS, dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United State of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by American Funds, a related party to Capital Bank and Trust Company, the Trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees are charged to the participants for the processing of distributions. These fees are considered customary and reasonable for such services.

American Funds provides certain administrative services to the Plan pursuant to a custodial agreement between the Company and American Funds. American Funds receives revenue from mutual fund service providers for services American Funds provides to the funds. This revenue is used to offset certain amounts owed to American Funds for its administrative services to the Plan.

If the revenue received by American Funds from such mutual fund service providers exceeds the amount owed under the custodial agreement, American Funds remits the excess to the Plan's trust on a quarterly basis. Such amount may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there was approximately \$217,000 of excess funds. The Plan or Plan Sponsor may make a payment to American Funds for administrative expenses not covered by revenue sharing. The Plan used these to pay for Sagespring Wealth Partners, LLC and other plan expenses. During 2024, there was approximately \$72,000 of unused funds towards expenses, which are included with interest and dividends on the Statement of Changes in Net Assets Available for Benefits.

NOTE 7: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
