Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sutter VNA and Hospice Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Sutter VNA and Hospice Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Notes to Financial Statements

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Sutter VNA and Hospice Retirement Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description or Plan Document for a more complete description of the Plan's provisions.

General – The Plan, which became effective January 1, 1979, is a defined contribution plan covering eligible employees of Sutter VNA and Hospice (the "Plan Sponsor"). On January 1, 1997, the Pension Plan for Visiting Nurse Association of San Mateo County, Inc. (the "San Mateo Plan") was merged into and superseded by the Plan. Accordingly, the Plan also constitutes a continuation of the San Mateo Plan as of January 1, 1997. Sutter Health (the "Plan Administrator"), the parent company of the Plan Sponsor, is responsible for the administration and management of the Plan. The Retirement Benefits Investment Committee is responsible for (1) establishing and revising the Plan's investment policy and (2) establishing and monitoring the oversight committees that monitor the investments offered through the Plan. All investments are participant-directed. Fidelity Management Trust Company (Fidelity) serves as trustee. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (the IRC) and similar state tax laws and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Freezing of plan – Effective December 31, 2000, the Board of Directors of the Plan Sponsor voted to freeze the Plan. No new participants may enter the Plan and no additional contributions may be made to the Plan after December 31, 2000. All participant account balances are 100% vested.

Participant accounts – Individual accounts are maintained for each participant. Each participant's account is credited with earnings, and charged with losses, withdrawals and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Participants' investment options – Participants direct the investment of their accounts and investment earnings into various investment options offered by the Plan. Participants may change their investment options at any time directly through Fidelity.

Payment of benefits – On termination of service due to death, disability, retirement, or other reasons, a participant shall receive a distribution equal to the value of the participant's vested interest in his or her account in one of the following forms: (a) an annuity option for certain participants, or (b) a lump-sum distribution of vested accrued benefits. Plan provisions do not allow the distribution of a participant's benefit without the written consent of the participant, other than minimum required distributions. Participants subject to minimum required distributions and employed with the Plan Sponsor or an affiliated entity are able to defer benefit payments until they cease employment. Participants may also receive in-service distributions after attaining normal retirement age of 65.

On December 20, 2019, the Setting Every Community Up for Retirement Enhancement Act (SECURE Act) was enacted and signed into law. The SECURE Act changed the age requirement for required minimum distributions from age 70½ to age 72 effective after December 31, 2019. The Plan Sponsor intends to amend the Plan Document by December 31, 2025.

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement Act of 2022 (SECURE Act 2.0) was enacted and signed into law. SECURE Act 2.0 included several optional retirement provisions to improve retirement savings and changed the age requirement for required minimum distributions from age 72 to age 73 after December 31, 2022, and age 75 after December 31, 2024. The Plan Sponsor intends to amend the Plan Document by December 31, 2026, for the required minimum distribution age requirements.

Administrative expenses – Certain administrative functions are performed by officers or employees of the Plan Sponsor and the Plan Administrator. No such officer or employee of the Plan Sponsor or the Plan Administrator receives compensation from the Plan. Other than fees associated with transaction-based services and recordkeeping fees, which are charged to participants, the Plan's administrative expenses are paid first from any remaining forfeitures and then by the Plan Sponsor, as specified in the Plan Document.

The Plan Sponsor has a revenue sharing agreement with Fidelity. Effective October 1, 2015, the revenue sharing agreement was amended to change the quarterly funding of revenue credits directly to participants (instead of the Revenue Credit Account) and the participant revenue credits were allocated based on the average quarterly balances in specified funds and the rates earned for each type of fund invested. During the 2024 Plan year, the Plan earned \$821 in revenue credits to participants and reported the credits in the financial statements as other income.

Plan termination – Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participant balances will be distributed in accordance with the Plan Document and ERISA.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of accounting – The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States.

Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes net unrealized appreciation (depreciation) of investments and net realized gains and losses on the sale of investments during the period.

Payment of benefits – Benefit payments are recorded when paid.

Risks and uncertainties – The Plan utilizes various investment instruments, including registered investment companies. Investment instruments, in general, are exposed to various risks such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment instruments, it is at least reasonably possible that changes in the values of investment instruments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Sponsor has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee of the Plan has certified to the completeness and accuracy of:

- investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- net appreciation in fair value of investments, dividends, and interest reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- investments reflected on the supplemental schedule of assets (held at end of year).

NOTE 4 – FAIR VALUE MEASUREMENTS

The Plan accounts for investments at fair value. A fair value hierarchy for valuation inputs has been established to prioritize the valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Each fair value measurement is reported in one of the three levels, which is determined by the lowest level of input that is significant to the fair value measurement in its entirety. These levels are:

Level 1 – Quoted prices are available in active markets for identical assets or liabilities as of the measurement date.

Level 2 – Pricing inputs are based on quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 – Pricing inputs are generally unobservable for the assets or liabilities and include situations where there is little, if any, market activity for the investment. The inputs into the determination of fair value require management's judgment or estimation of assumptions that market participants would use in pricing the assets or liabilities.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan:

Registered investment companies – Fair values are based on quoted market prices in active markets for identical assets that the Plan has the ability to access at the measurement date.

The previously described methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management of the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no changes in the valuation techniques used as of December 31, 2024 and 2023.

NOTE 5 – INCOME TAX STATUS

The Plan has received an advisory letter from the Internal Revenue Service (the IRS) dated June 30, 2020, stating that the form of the Plan, as an underlying volume submitter profit sharing plan, is qualified under Section 401(a) of the IRC and therefore, the related trust is tax-exempt. Subsequent to this determination by the IRS, the Plan was amended. In accordance with Revenue Procedures 2017-29 and 2017-41, the Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS volume submitter profit sharing plan advisory letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as fiduciaries of the Plan, any party rendering services to the Plan, the employer, and certain others. Plan investments are shares of registered investment companies managed by affiliates of Fidelity. Fidelity is the trustee and recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.
