## **INDEPENDENT AUDITOR'S REPORT**

To the Plan administration and management of  
NHS Affiliated Companies 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of NHS Affiliated Companies 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## NHS Affiliated Companies 401(k) Profit Sharing Plan Notes to Financial Statements

### NOTE 1: DESCRIPTION OF THE PLAN

The following description of the NHS Affiliated Companies 401(k) Profit Sharing Plan (the "Plan") provides only general information. Refer to Plan documents for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all full-time employees of NHS Management, LLC (the "Company", "Sponsor", "Employer", or "Plan Administrator") and related control group (the employers). The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan's 401(k) Committee (Investment Committee) determines the appropriateness of the Plan's investment offerings and monitors investment performance. Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Fidelity Management Trust Company, the trustee and qualified institution for the Plan, which invests contributions and Plan earnings, makes investment transactions as directed by the Investment Committee and provides certain recordkeeping services. Fidelity Management Trust Company also performs certain plan administration and annual ERISA compliance testing.

#### ***Eligibility***

Employees may become a participant when they have completed one year of eligible service with at least 1,000 hours and are age 21 and older. Employees covered by a collective bargaining agreement and nonresident aliens who do not receive any earned income from the Employer which constitutes United States source income are not eligible. An eligible employee may enter the Plan on the first day of the month after all entry requirements have been met.

## NHS Affiliated Companies 401(k) Profit Sharing Plan Notes to Financial Statements

### NOTE 1: DESCRIPTION OF THE PLAN (Continued)

#### **Contributions**

The Plan permits eligible employees, through a salary deferral election, to defer the lesser of a percentage of pre-tax annual compensation up to the maximum permissible pursuant to the Internal Revenue Code, or 90% of compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year may defer a catch-up contribution. The employer has elected a safe harbor option and provides a written notice each Plan year to all active participants of their rights and obligations and, under certain circumstances is deemed to satisfy the "ADP and "ACP" tests. The employer shall make safe harbor employer matching contributions on behalf of each eligible participant in an amount equal to 100% of deferrals up to 4% of eligible compensation. The employer may make an additional matching employer contribution on behalf of each eligible participant in an amount equal to a percentage of the eligible contribution made by each eligible participant during the year.

During the year ended December 31, 2024, the Company made \$2,902,090 in safe harbor matching contributions. The employer did not make any additional contributions during the year ended December 31, 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and the Company's matching contributions, including safe harbor matching contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their contributions, and the safe harbor matching contributions plus actual earnings thereon. Vesting in the employer's profit sharing and other discretionary contributions is based on years of service and the years of vesting service schedule as follows:

### NOTE 1: DESCRIPTION OF THE PLAN (Continued)

#### ***Receivables***

Contributions receivable include those pursuant to formal commitments based on the Plan's adoption agreement. Evidence that a formal commitment existed was based on criteria that (a) the contribution is based on participant compensation that existed for the current plan year and (b) the plan terms require a contribution to be made for the current plan year.

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 and a maximum amount of the lesser of one-half of the participant vested account balance or \$50,000 reduced by the highest outstanding loan balance in the participant account during the prior twelve-month period. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans that would be made under similar circumstances, such as a rate computed using the prime rate (as specified in the Wall Street Journal) plus 1%. Loan terms shall not exceed 5 years with the exception of 10 years if used to acquire a principal residence. Delinquent participant loans are deemed to be distributions based on the terms of the Plan document. Principal and interest is paid ratably through payroll deductions.

#### ***Benefit Payments***

The Plan provides retirement benefits for participants who reach normal retirement age of 59 ½. Terminated participants may take a payout of the vested portion of their account balance. Participants who have reached normal retirement age are fully vested in their account balance and may receive a lump-sum distribution, a partial withdrawal, or a rollover distribution in an amount equal to the value of his/her account. The Plan also provides for complete distribution of the participant's account balance to the participant or designated beneficiary upon disability or death. The Plan documents do not permit hardship distributions.

#### ***Forfeitures***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$473 and \$286, respectively. These accounts will be used to reduce employer safe harbor matching contributions or pay Plan expenses. In 2024, there were no Plan forfeitures applied to either of the allowable uses.

#### ***Plan Amendments***

There were no significant Plan amendments during the year.

### **NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

#### ***Use of Estimates***

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments generally are reported at fair value but may also be reported at contract value or net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### ***Payments of Benefits***

Distributions to participants are recorded when paid.

### NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

#### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

#### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

#### *Subsequent Events*

Management has evaluated subsequent events through the date that the financial statements were available to be issued, September 16, 2025, and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

### NOTE 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the qualified institution:

- a) Total investments, at fair value, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b) Notes receivable from participants, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- c) Investment income and interest income from notes receivable information included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- d) All amounts included in Note 4, Fair Value Measurements.
- e) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024, including notes receivable.

### NOTE 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
  - observable; or
  - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

### **NOTE 5: TAX STATUS**

The IRS has determined and informed the Trustee by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are managed and valued by Fidelity Management Trust Company: thus, all investment transactions for these investments qualify as party-in-interest transactions. Fidelity Management Trust Company was the trustee and record-keeper, and the Plan uses Regions Bank as the third-party benefit and compliance consultant for the Plan.

In general, the administrative expenses for the Plan are paid from the Plan's assets. From time-to-time certain expenses of the Plan, including legal and accounting fees, are paid by the Plan Sponsor. In addition, certain services to the Plan by the Plan Sponsor were performed at no charge.

### **NOTE 7: PLAN TERMINATION**

Although it has not expressed any intent to do so, the plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their employer contributions.
