## Independent Auditor's Report

To the Plan Administrator of  
Novartis Corporation Post Employment Welfare Benefits Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Novartis Corporation Post Employment Welfare Benefits Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Novartis Corporation Post Employment Welfare Benefits Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Novartis Corporation Post Employment Welfare Benefits Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Novartis Corporation Post Employment Welfare Benefits Plan's ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

#### **1. Description of Plan**

The following description of the Novartis Corporation (the "Company") Post Employment Welfare Benefits Plan (the "Plan") provides only general information about the Plan's provisions. Participants should refer to the Plan agreement for a complete description of the Plan's provisions, copies of which may be obtained from the Plan sponsor.

##### **General**

The Plan provides for the administration of a welfare plan for the benefit of eligible retirees of the Company and adopting affiliates. The Plan is intended to be a free-standing retiree plan with no active employees of the Company or any affiliate participating in the Plan.

Certain Plan assets are held in the Alcon Laboratories, Inc. Voluntary Employees' Beneficiary Association ("VEBA") Trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Any individual hired on or after January 1, 2015 shall not be an eligible retiree under this plan.

##### **Benefits**

The Plan provides medical and pharmacy, dental and life benefits to eligible participants and to their beneficiaries and covered dependents.

Effective January 1, 2017, the Company sponsored voluntary retiree life insurance for employees aged 55 with five years of service shall be closed to associates retiring on or after this date.

##### **Insured Benefits**

The Plan fully insures the dental and life insurance benefits. Premiums for dental and life benefits are paid to the insurance company from the general assets of the Company or the VEBA.

##### **Self-insured benefits**

The medical and pharmacy benefits offered by the Plan are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only ("ASO") agreements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan's VEBA Trust, or the general assets of the Company. In 2024 the total reimbursement from the VEBA Trust for the claims paid by the Company was \$650,000. Despite the Plan's utilization of third-party claims' processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

##### **Contributions**

Retirees may contribute specified amounts, determined periodically by the Company, for coverage for themselves.

The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

#### **2. Summary of Accounting Policies**

##### **Basis of Accounting**

The accompanying financial statements are prepared under the accrual method of accounting

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Payment of Benefits**

The Company pays premiums from the general assets and is then reimbursed by the Plan's VEBA Trust. The premiums are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. In 2024 the total reimbursement from the VEBA Trust for the life insurance premiums paid by the Company was \$312,000.

Claim payments are recorded when submitted to the Plan by the third-party claims' processor for reimbursement. Amounts due to claims processors that have yet to be submitted to the Plan by the third-party claims' processor are recorded as claims payable in the accompanying statements of benefit obligations.

#### **Refunds**

Refunds due from the Plan's pharmacy benefits manager are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$22,446,091 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits.

#### **Medicare Subsidy**

The Plan's postretirement benefit obligation does not reflect an amount associated with the Medicare subsidy allowed under the Medicare Prescription Drug Improvement and Modernization Act of 2003 because the Plan is not directly entitled to the Medicare subsidy. The Company has included the effects of the Medicare subsidy in measuring its postretirement benefit obligation; therefore, the Plan's postretirement benefit obligation differs from that of the Company.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

A portion of the Plan's investment balance is trust-owned life insurance ("TOLI") administered by The Prudential Insurance Company of America (the "insurance company"). The TOLI is an investment vehicle designed to increase the tax efficiency of the Plan's investments through an arrangement that has the tax benefits of insurance and rate of returns and risk of index fund investments. The insurance company issues life insurance policies on certain of the Plan participants with the Plan as the owner and beneficiary of the policies. The insurance costs are paid out of the investment in the TOLI to the insurance company. The Plan has the option to reinvest life insurance proceeds into the TOLI or to have the proceeds paid directly to the Plan. The costs paid to the insurance company, less certain fees, are held in a separate account by the insurance company to pay death benefits estimated to be paid during the year. At the end of each year, the insurance company calculates the actual amount that should have been charged in the previous year using the actual experience rate of the policy. This amount is compared to the amount held in the separate account, and the investment account is either increased for any amounts due to the plan or deducted for any amounts due to the insurance entity. The contract may be terminated at any time with no incremental termination fee or surrender charge.

#### **Subsequent Events**

The Plan has evaluated subsequent events through September 17, 2025, which is the date the financial statements were available to be issued.

#### 3. Benefit Obligations

A postretirement benefit obligation has been recognized for retiree medical benefits for eligible participants and their dependents upon retirement. These benefit obligations represent the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. The obligations represent the amounts that are expected to be funded by contributions from the Company and from existing assets of the Plan. Postretirement benefits include future benefits expected to be paid to or for (a) currently retired or terminated employees and their beneficiaries and dependents, and (b) active employees and their beneficiaries and dependents after retirement from service with the Company.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

For measurement purposes, for the year ended December 31, 2024, a 6.75% weighted-average annual rate of increase in the average per capita cost of covered health care benefits was assumed; the rate was assumed to decrease gradually to 4.50% for 2033 and to remain at that level thereafter. For the year ended December 31, 2023, a 6.25% weighted-average annual rate of increase in the average per capita cost of covered health care benefits was assumed; the rate was assumed to decrease gradually to 4.50% for 2031 and to remain at that level thereafter.

The weighted-average health care cost trend rate assumption has a significant effect on the amounts reported as postretirement benefit obligations. If the assumed rates increased by 1 percentage point in each year, it would increase the obligation as of December 31, 2024 and 2023 by \$20,968,000 and \$25,599,000, respectively.

The following were other significant assumptions used in the valuation as of December 31, 2024 and 2023:

Weighted-average discount rate	5.50% for 2024 and 5.00% for 2023
Average retirement age	63 for 2024 and 63 for 2023
Mortality	Pri-2012 generations for both 2024 and 2023 projected both using MP-2021

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the benefit obligations.

#### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023, other than to reflect the Trust Owned Life Insurance investment presented at net asset value ("NAV") at December 31, 2024.

*Money Market Fund:* Valued at amortized cost, which approximates fair value.

*Trust Owned Life Insurance:* Valued at NAV as a practical expedient to estimate fair value based on the underlying assets held in the contract. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported NAV. The investment strategies include tracking the United State bond market, the S&P 500 index and foreign stocks. The contract is comprised of variable separate account funds valued at their net asset value, including adjustment for expenses paid to the policy. The separate accounts have no unfunded commitments and there is a 15-day advance notice required for redemptions.

#### **5. Administration Expenses**

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, the trustees and the actuary. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

#### **6. Tax Status**

The VEBA Trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (the "IRS") dated February 7, 2000, stating that the trust is tax-exempt under the provisions of Section 501(c) of the Internal Revenue Code (the "Code"). However, as a result of the Plan's funding policy, from time to time, the trust may be subject to income taxes. In 2024, \$30,473 of income taxes have been recorded for unrelated business taxable income.

In addition, the Plan and the Trust are required to operate in conformity with the Code to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed tax position taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

#### **7. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

#### **8. Related-Party and Party In Interest Transactions**

Certain administrative expenses are paid by the Plan to Principal Trust Company ("Principal"). Principal is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions under ERISA. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

#### **9. Certification by the Trustee**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Principal Trust Company, the trustee of the Plan has certified to the completeness and accuracy of substantially all investments and related investment activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

**10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks, as well as the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits. For the year ended December 31, 2024, two trust owned life insurance policies represented a concentration of greater than 10% of the Plan's net assets available for benefits. The investments as a percentage are 58.76% and 26.70%. For the year ended December 31, 2023, three trust owned life insurance policies represented a concentration of greater than 10% of the Plan's net assets available for benefits. The investments as a percentage are 10.48%, 54.09% and 29.80%.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.
