Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of ABC Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ABC Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE A – DESCRIPTION OF PLAN

The following brief description of Horizon Management, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General:

Horizon Management, Inc. (the “Company”) established the Horizon Management, Inc. 401(k) Profit Sharing Plan (the “Plan”) effective January 1, 2001.

The Plan is a defined contribution 401(k) profit sharing plan covering substantially all employees who are employed by Horizon Management, Inc. (the “Employer”) as defined in the Plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility:

An eligible employee is any person employed by the Company excluding employees who are union employees, employees acquired as part of 410(b)(6)(C) until transition period has expired and non-resident aliens with no U.S. income. Employees of the Company are eligible to participate in the Plan on the first day of each quarter of the plan year, coincident with or next following the date the eligibility requirements are met for deferrals after completing 90 days of service. Participants must complete at least 500 hours of service during the Plan year to be eligible to receive any employer matching and profit sharing contributions.

Contributions:

Participants may make voluntary contributions from up to 100% of their annual compensation, as described in the Plan agreement. The participant may elect to have their compensation reduced by making contributions to the plan on a pre-tax or on an after-tax basis. The total annual participant voluntary contribution is limited to \$23,000 and \$22,500 in 2024 and 2023, respectively. Participants who will be at least age 50 by the end of the year may make additional contributions of \$7,500 for 2024 and 2023, respectively. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Company contributes a matching contribution at a rate of 25% of the first 4% of the participant’s elective contribution for eligible participants of the Plan. The Company made matching contributions of \$46,948 and \$52,839 in 2024 and 2023, respectively.

Participants’ Accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) Plan earnings, and (c) any forfeiture of terminated participants' non-vested accounts as defined by the Plan agreement. The allocation of the Company's matching contribution is based on the participant's contribution. The allocation of the Company's profit sharing contribution is based on the participant's wages. Other allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE A – DESCRIPTION OF PLAN (CONTINUED)

Plan Assets:

The Plan's assets are invested in various mutual funds and contract with insurance company as administered by Empower Annuity Insurance Company. The participants are responsible for making investment decisions and may direct contributions to any or all mutual funds available.

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are 100% vested in the employer's profit sharing and matching contributions and actual earnings thereon after six years of credited service.

Payment of Benefits:

Upon termination of service, a participant may receive a lump sum distribution equal to his or her account balance. If the participant's account balance is less than \$5,000, the plan administrator directs the trustee to make a lump sum distribution. Participants terminated for reasons other than death, disability, or retirement are entitled to receive their benefits as soon as administratively feasible.

Forfeitures:

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account, or other methods allowed by the Plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The non-vested amount will be forfeited and may be used by the participating employer to reduce future matching or discretionary contributions. Forfeitures in the amount of \$11,054 and \$0 for the years ended December 31, 2024 and 2023, respectively, were used to offset employer contributions.

Notes Receivable from Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at prime plus one percent. The maximum number of loans that a participant may have outstanding at any one time is one. Principal and interest is paid ratably through payroll deductions. Furthermore, participants may withdraw funds from their accounts for financial hardship.

Plan Costs:

The Company pays all significant costs with exception of administrative and investment fees.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition:

The investments are stated at fair market value. Quoted market prices are used to value investments and are determined by the custodian of the Plan. The net asset value of the investment contract is equal to contract value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

Subsequent Events:

Management evaluated all activity of the Plan through September 17, 2025, the date the financial statements were available to be issued, and concluded that no subsequent events have occurred that would require recognition or disclosure in the financial statements or notes.

NOTE C – CERTIFIED INVESTMENTS

Certain information summarized below related to the accompanying financial statements and ERISA-required supplemental schedules was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Transamerica Life Insurance Company, the plan trustees. NOTE D – INVESTMENTS AT FAIR VALUE

The Financial Accounting Standards Board's Accounting Standards Codification (ASC) Topic 820, Fair Value Measurement, establishes a framework for measuring fair value. The framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There are three general valuation techniques that may be used to measure fair value, as described below:

- a) Market approach - Uses prices and other relevant information generated by market transactions involving identical or comparable assets or liabilities. Prices may be indicated by pricing guides, sale transactions, market trades, or other sources;
- b) Cost approach - Based on the amount that currently would be required to replace the service capacity of an asset (replacement cost); and
- c) Income approach - Uses valuation techniques to convert future amounts to a single present amount based on current market expectations about the future amounts (includes present value techniques and option-pricing models). Net present value is an income approach where a stream of expected cash flows is discounted at an appropriate market interest rate.

The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

NOTE F – INCOME TAX STATUS

The Plan, a prototype plan, obtained its latest determination letter dated March 31, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect the amounts reported on the statement of net assets available for benefits.

NOTE H – PARTY-IN-INTEREST TRANSACTIONS

Certain participants have borrowed on their vested account balances. As the individuals are participants in the Plan, these transactions qualify as party-in-interest transactions.
