INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees
NYSА-PPGU Welfare Fund and Plan

Opinion

We have audited the accompanying financial statements of NYSА-PPGU Welfare Fund and Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, the statements of fund's benefit obligations as of December 31, 2024 and 2023, and the related statement of changes in fund's benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of NYSА-PPGU Welfare Fund and Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in plan benefit obligations for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of NYSА-PPGU Welfare Fund and Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about NYSА-PPGU Welfare Fund and Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about NYSA-PPGU Welfare Fund and Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of assets held for investment purposes at year end of NYSA-PPGU Welfare Fund and Plan as of December 31, 2024 ("supplemental schedule") is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying supplemental schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 – DESCRIPTION OF THE PLAN

The following brief description of the NYSA-PPGU Welfare Fund and Plan (“Fund”) is provided for general information purposes only. The Summary Plan Description includes more complete information concerning the Fund’s provisions.

a) General

The Fund is a multi-employer welfare benefit plan. The Fund, which is non-contributory, is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The Fund was established by New York Shipping Association, Inc. (d/b/a Shipping Association of New York and New Jersey) (“NYSA”) and the Port Police & Guards Union (“PPGU”) to fulfill a multiemployer contractual commitment of NYSA’s employer members under the Collective Bargaining Agreement (“Agreement”) between NYSA and PPGU, that expires on December 31, 2025.

The Agreement and Declaration of Trust and Plan (“Trust and Plan”) was amended and restated January 21, 2010 and was amended subsequent thereto.

b) Benefits

The Fund provides insured death and accidental death and dismemberment benefits to eligible participants and insured health benefits to all eligible participants, eligible retired employees and eligible dependents.

The Fund is self-insured for non-occupational disability benefits.

Note 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a) Post-retirement Benefits

The post-retirement benefit obligations are the actuarial present value of those estimated future benefits that are attributed to employee service rendered through December 31, 2024. Post-retirement benefits include future benefits expected to be paid to or for (1) currently retired and fully eligible employees (as well as their beneficiaries and dependents) and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers.

Note 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

a) Post-retirement Benefits (Continued)

Prior to an active employee's eligibility date, the post-retirement benefit obligation is the portion of the expected post-retirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected post-retirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimated future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

For measurement purposes, a 6.0% annual rate of increase in the per capita cost of covered health care benefits (or, the weighted average health care cost-trend rate) was assumed for 2024; the rate was assumed to decrease periodically until it reaches an ultimate rate of 3.5% per year in year 2035. The rate used to measure the benefit obligation as of December 31, 2024 was 6.0%.

The following other significant assumptions were used in the valuations as of December 31, 2024 and 2023.

Changes in actuarial assumptions and other changes in the accompanying statement of changes in post-retirement benefit obligations principally represent an increase in the weighted average discount rate from 4.80% to 5.50%.

The foregoing assumptions are based on the presumption that the Fund will continue. Were the Fund to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the post-retirement benefit obligation. However, the trustees are authorized by the trust agreement to terminate the Fund, in which event, any obligation to the retirees ceases upon exhaustion of the Fund's assets.

b) Benefit Obligations

The Fund's deficiency of net assets over benefit obligations as of December 31, 2024 and 2023 relates solely to the post-retirement benefit obligations, the funding of which is not covered by the contribution rate provided by the Agreement. Regulatory authorities do not require prefunding of post-retirement benefit obligations.

The weighted average health care cost-trend rate assumption (Note 2(a)) has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point each year, it would increase the obligation as of December 31, 2024 and 2023 by \$940,290 and \$1,029,255, respectively.

c) Depreciation

No provision for depreciation has been made in these financial statements. Furniture and equipment have been fully depreciated and are still in use by the Fund.

d) Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Board of Trustees to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 3 – FUNDING POLICY

The employer members of NYSA are required to make annual contributions to the Fund in accordance with the Agreement. For 2024, such contribution amounted to \$5,713,369.

In accordance with the Agreement between NYSA and PPGU, for 2025, the employer members agreed to pay a specific amount to pay for premiums for active medical and prescription coverage as set forth in the Agreement and, subject to certain assumptions, to fund a Health Reimbursement Account. They also agreed to provide full funding to pay for all plan administrative expenses and all other welfare benefits that were previously being provided, such as Medicare premiums, temporary disability benefits and life insurance.

Note 4 – PENSION

The Fund participates in the NYSA-PPGU Pension Fund (“Pension Fund”) and NYSA-PPGU Money Purchase Pension Fund (“Money Purchase Fund”) on behalf of its employees. The Pension Fund is a non-contributory defined benefit plan. The Money Purchase Fund is a non-contributory, defined contribution plan. This Fund contributed \$1,166 to the Pension Fund and \$576 to the Money Purchase Fund in 2024.

Note 5 – SHORT-TERM LEASE COMMITMENT

The Fund leases office space from PPGU, a related entity, under a short-term lease agreement which expired on December 31, 2022. This operating lease is classified as short-term and renewable on a month to month basis. The Fund has made an accounting policy election not to recognize right of use assets and lease liabilities that arise from short-term leases for any class of underlying asset. Under the terms of the lease, the Fund is also responsible for its pro rata portion of real estate taxes and utilities. A portion of the minimum lease payments, real estate taxes and utilities is allocated to other NYSA-PPGU Funds. Net rent expense to the Fund was \$15,988 for 2024 and will be approximately \$16,000 for 2025.

Note 6 – DEPOSITS WITH STATE AGENCIES

In connection with the Fund’s self-insurance program for providing statutory, non-occupational disability benefits, interest-bearing cash deposits are maintained with the appropriate state agencies of New York and New Jersey. As of December 31, 2024 and 2023, said deposits were \$30,000 (see attached schedule, page 13).

Note 7 – TAX STATUS

The Fund was advised by the United States Treasury Department on January 19, 1999 that it continues to qualify for tax-exempt status under the provisions of Internal Revenue Code Section 501(c) 9. The Board of Trustees believes that the Trust and Plan, as amended, continues to qualify for tax-exempt status. The Fund had no unrecognized tax benefits as of and for the year ended December 31, 2024 and has no open years subject to examination prior to the year ended December 31, 2023. The Fund has no income tax related penalties or interest for the period reported in the financial statements.

Note 8 – RELATED PARTY TRANSACTIONS

a) Pension Fund

Expenses incurred (i.e., salaries, taxes, benefits, rent and insurance) of approximately \$67,000 were allocated to the Pension Fund in 2024. As of December 31, 2024 and 2023, a receivable of \$5,250 and \$6,455, respectively, was due from the Pension Fund.

b) NYSA-PPGU Vacation and Holiday Fund

Expenses incurred (i.e., salaries, taxes and benefits) of approximately \$19,500 were allocated to the NYSA-PPGU Vacation and Holiday Fund in 2024. As of December 31, 2024 and 2023, a receivable of \$1,490 and a \$2,189, respectively, was due from the NYSA-PPGU Vacation and Holiday Fund.

Note 9 – CONCENTRATION OF CREDIT RISK

During 2024 and 2023, the Fund maintained balances with a bank that, at times, exceeded Federally insured limits.

Note 10– FUND TERMINATION

Subject to the provisions of the Trust and Plan, the Trustees may, at any time, amend the Trust and Plan to modify, change, reduce, restrict, suspend or terminate any benefit or benefit payment being made or to be made and may terminate the Fund and Plan, provided that such amendment or action conforms with the requirements of ERISA and any other applicable law.

Note 11– RISKS AND UNCERTAINTIES

The actuarial present value of retiree benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

The Fund is not aware of any subsequent events which would require recognition or disclosure in the accompanying financial statements.
