**Note 1 - Plan Description**

The following description of Redpath and Company, Ltd. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution 401(k) profit-sharing plan covering substantially all employees of Redpath and Company, Ltd. (the "Company").

Employees are eligible to make 401(k) deferral contributions upon date of hire. Employees who have attained age 21 and completed six months of service are eligible to receive employer contributions starting on the next payroll date after meeting the eligibility requirements.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Administration**

The Company is the sponsor and administrator of the Plan. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust) is the Plan's custodian. Principal Life Insurance Company (Principal) is the Plan's recordkeeper. Various administrative costs, charges, and expenses are paid by the Plan, and only those expenses paid by the Plan are reflected in these financial statements.

**Contributions**

The Plan provides for employee 401(k) salary deferral contributions of a percentage of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions in addition to their regular deferral contributions. Participants may designate all or a portion of their contributions as Roth deferral contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Employees are automatically enrolled in the Plan at a 6 percent pretax contribution rate unless they elect otherwise. Participants' contribution rates are automatically increased by 1 percent on an annual basis until they reach a rate of 10 percent or make an alternative election.

The Plan provides for discretionary employer matching and profit-sharing contributions. Participants must complete six months of service, after which they are considered active participants, during the plan year to be eligible for discretionary employer contributions. For the years ended December 31, 2024 and 2023, the Company made discretionary matching contributions equal to 4 percent of a participant's compensation.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

**Vesting**

Participants are immediately vested in all contributions made to their accounts plus actual earnings thereon.

**Note 1 - Plan Description (Continued)**

***Benefit Payments***

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account. Benefits may also be made in the form of installment payments, as specified by the participant or beneficiary. In-service distributions may be made from a participant's vested account at any time after the attainment of age 59½.

***Hardship Withdrawals***

Participants may request that all or a portion of their accounts be distributed in the case of severe financial hardship, as defined in the plan document. The Company must approve any such hardship withdrawals.

***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$500 up to a maximum of 50 percent of their account balances, not to exceed \$50,000. The notes receivable are collateralized by the participant's account and bear interest rates that are commensurate with local prevailing rates determined by the plan administrator. The notes generally have a term of 5 years. Loans for the purchase of a principal residence can be paid over a reasonable period of time that may exceed 5 years but may not exceed 30 years. Principal and interest payments are due on at least a quarterly basis.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Principal Trust and its affiliates. Principal Trust is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible. Delinquent loans are reclassified as distributions based on the terms of the plan document.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the Company.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including August 19, 2025, which is the date the financial statements were available to be issued.

In February and March 2025, the Plan received rollover contributions totaling approximately \$3,124,000 from the Company's employee stock ownership plan. Effective January 1, 2025, the Plan's name was changed to Redpath and Company, LLC 401(k) Profit Sharing Plan.

**Note 3 - Certified Information**

Principal Trust holds all of the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Principal Trust.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

**Note 4 - Fair Value Measurements (Continued)**

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

**Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets.

**Common Collective Trust Funds**

Common collective trust funds are valued at net asset value per share or its equivalent of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

**Pooled Separate Accounts**

Pooled separate accounts are valued at net asset value per share or its equivalent of the funds, which is based on the fair value of the funds' net underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

The Plan is a prototype plan. The prototype plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.
