INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the
HydroGeoLogic, Inc. 401(k) Profit Sharing Plan and its Participants:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the HydroGeoLogic, Inc. 401(k) Profit Sharing Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of the HydroGeoLogic, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of HydroGeoLogic, Inc. (the Company). The Plan covers all employees of the Company that have reached 18 years of age, except for nonresident aliens and leased employees. The Plan also covers all employees covered under the McNamara-O'Hara Service Contract Act of 1965 (SCA). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended effective July 1, 2023 to modify the vesting schedule whereby all Company contributions fully vest over 3 years.

Eligibility

Participants may enter the Plan on the first day of the month coinciding with or following the date the eligibility requirement is met.

Participant Contributions

Participants may contribute up to 100% of their eligible annual compensation, as defined by the Plan, not to exceed the maximum allowable contributions under the Internal Revenue Code (the Code), which totaled \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions subject to limitations imposed by the Code, which totaled \$7,500 for the year ended December 31, 2024. The Plan allows for pre-tax and Roth deferrals. Participants are also permitted to make rollover contributions from another qualified plan.

Automatic Enrollment

The Plan has an automatic enrollment feature whereby an eligible employee who does not elect to contribute a specific percentage of their compensation or elect to opt out of Plan participation will be automatically enrolled to contribute to the Plan at a rate of 3% of eligible compensation, as defined by the Plan.

Company Contributions

The Plan allows for Company discretionary matching, profit sharing, and qualified nonelective contributions. The Company matched 50% of the first 5% of participant elective deferrals, calculated on a per payroll basis, during the year ended December 31, 2024. Company discretionary matching contributions totaled \$1,162,065 for the year ended December 31, 2024.

Participants must be employed on the last day of the Plan year and complete 1,000 hours during the year to receive an allocation of any profit sharing contribution. The Company did not make any profit sharing contributions to the Plan during the year ended December 31, 2024.

1. DESCRIPTION OF THE PLAN – cont’d.

Company Contributions – cont’d.

The Company is required to provide minimum health and welfare benefits at a set hourly rate based on hours worked or hours paid, as defined by individual contracts, for all employees subject to prevailing wage requirements and minimum fringe benefits on contracts covered under the SCA. The funds are used to pay insurance premiums on the employees’ behalf and trust fees. The remaining SCA prevailing wage contributions, as prescribed by the SCA, are contributed by the Company in the form of qualified nonelective contributions. The Company made qualified nonelective contributions totaling \$462,828 to the Plan during the year ended December 31, 2024.

Participant Accounts

Each participant’s account is participant-directed and credited with the participant’s contributions and Company contributions in accordance with the investment options selected by the participant. Plan earnings, losses, and administrative expenses are allocated to each participant’s account based upon the balance in each account. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant’s account.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balances, not to exceed \$50,000, without regard to the intended use of the funds. The notes are collateralized by a participant’s vested account balance. The minimum amount that may be borrowed is \$1,000. Participants may only have a maximum of two notes outstanding at any time during a Plan year, and a maximum of three notes are permitted within a twelve month period. Note repayments are to be made each pay period through payroll deductions. The notes bear interest at rates commensurate with those offered by financial institutions at the time of the notes’ issuance. Notes for reasons other than the purchase of a primary residence are to be repaid within five years. Notes originated for the purchase of a primary residence are to be repaid within thirty years.

Vesting

Participants are immediately vested in their contributions and Company qualified nonelective contributions, plus earnings thereon. Prior to July 1, 2023, participants vested in Company discretionary matching contributions and profit sharing contributions, and earnings thereon, based upon years of service according to the following schedule:

Effective July 1, 2023, participants vest in Company discretionary matching contributions and profit sharing contributions, and earnings thereon, based upon years of service according to the following schedule:

Upon retirement from the Company, death, or disability during employment at the Company, a participant becomes 100% vested in their Company discretionary matching contributions and profit sharing contributions.

Forfeitures

Forfeitures of Company discretionary matching and profit sharing contributions may be applied to reduce future Company contributions or pay plan expenses. Forfeitures become available to the Plan when a distribution of the participant’s entire vested account balance occurs or with a five year break in service. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,594 and \$53,822, respectively. Forfeitures used to reduce the Company’s matching contributions during the year ended December 31, 2024 totaled \$101,459.

Payment of Benefits

Upon termination of service, retirement, death, disability, or attainment of age 59½, a participant, or his or her beneficiary in the event of death, is entitled to a distribution of his or her vested account balance. Distributions from the Plan prior to retirement are payable in the form of a lump sum payment, or in the case of required minimum distributions, installment payments equal to the value of the participant’s vested interest in his or her account. Upon termination, if a participant’s account balance is less than \$7,000, the Plan may elect to automatically distribute the participant’s vested balance. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, participant deferrals, rollover contributions, and any earnings thereon may be withdrawn for a hardship purpose. Distributions are subject to the applicable provisions of the Plan agreement. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½. As of December 31, 2024 and 2023, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not received such distributions prior to year-end.

Plan Expenses

Expenses incurred in the administration of the Plan are required to be paid by the Custodian with assets of the Plan unless the Company, at its discretion, elects to pay them. During the year ended December 31, 2024, the Company paid a portion of direct expenses related to the Plan’s operations. The Plan paid \$167,178 in direct expenses during the year ended December 31, 2024. Loan and distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Principal Fixed Income Guaranteed Option is considered fully benefit-responsive. Principal Life Insurance Company has represented that fair value equals contract value for this investment contract.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of these investments may occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments, except for the fully benefit-responsive investment contract, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Interest income is recorded on the accrual basis. Delinquent notes are treated as distributions based on the terms of the Plan agreement.

Fair Value Measurement

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Interests in registered investment companies: Valued at the closing price reported in the active market in which the funds are traded.

Interests in common/collective trusts: Valued at the net asset value (NAV) of shares held by the Plan at year-end as a practical expedient.

Interests in pooled separate accounts: Valued at the net asset value (NAV) of shares held by the Plan at year-end as a practical expedient.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through September 2, 2025, the date the financial statements were available to be issued, and determined there were no material events that warrant disclosure.

3. INVESTMENTS

All investment data disclosed in the accompanying financial statements and supplemental schedule including assets held as of December 31, 2024 and 2023, and interest and dividend income and net appreciation in the fair value of investments for the year ended December 31, 2024, was obtained or derived from the information supplied to the Plan administrator and certified as complete and accurate by the Custodian and Trustee of the Plan, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company.

4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has an investment in the Principal Fixed Income Guaranteed Option, which is a fully benefit-responsive investment contract with Principal. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT – cont'd

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fully benefit-responsive guaranteed investment contract. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed semiannually for resetting. The contract cannot be terminated by the issuer before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan sponsor or other Plan sponsor events that significantly affect the Plan's normal operations.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer or that would limit the ability of the Plan to transact at contract value with the participants.

5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by affiliates of Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal"). Principal is the custodian, recordkeeper, and trustee as defined by the Plan. The Plan loans funds to its participants according to the applicable provisions of the Plan document. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all contributions to the Plan would cease and all affected participants would become 100% vested in their accounts.

7. INCOME TAX STATUS

The Plan has adopted a prototype plan through Principal, which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties, and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the Internal Revenue Service (IRS) and Department of Labor; however, there are currently no audits in progress for any open periods.

8. COMPANY CORRECTIVE CONTRIBUTIONS

Subsequent to December 31, 2022, the Company determined that they did not implement the correct plan entry date for new hires to the Plan. The plan entry date used was the first of the month after the participant's date of hire instead of the date of hire in compliance with an amendment to the Plan effective January 1, 2017 changing the plan entry date to the date of hire. As a result, affected participants were not given the opportunity to defer in accordance with the terms of the Plan. In order to correct these operational errors, the Company is required to make qualified nonelective employer contributions (QNECs) to the affected employees for an aggregate contribution of \$35,060, related to participants that entered the Plan in 2017 through 2023. The corrections were remitted to the participants during 2023. Participants are 100% vested in these QNEC contributions. Effective February 24, 2023, the Plan was amended to change the plan entry date to the first of the month after the participant's date of hire.

During the year ended December 31, 2022, the Company determined that they did not properly withhold deferrals for certain participants during a given payroll period. As a result, affected participants were not given the opportunity to defer in accordance with the terms of the Plan. In order to correct these operational errors, the Company is required to make qualified nonelective employer contributions (QNECs) to the affected employees for an aggregate contribution of \$2,228, including missed deferrals and related matching contributions totaling \$2,061 plus lost earnings totaling \$167. The corrections were remitted to the participants during 2023. Participants are 100% vested in these QNEC contributions.
