### SUMMARY OF PLAN PROVISIONS

**Effective Date:** January 1, 2016.

**Plan Year:** January 1 to December 31.

**Participation:** An eligible employee shall participate on the January 1 or July 1 following attainment of age 21 and 1 year of service.

**Year of Service for Vesting and Eligibility:** 1000 hours of service during a plan year.

**Year of Service for Benefit Computation:** 1000 hours of service during a plan year.

**Compensation:** Form W-2 compensation that is actually paid in gross income during a plan year while a participant. For self-employed participants it shall be earned income. If a participant enters plan mid-year, their entire compensation for that plan year is used.

**Eligible Employee:** Any employee of the employer.

**Normal Retirement Date:** First of the month coincident with or next following the participant's 65<sup>th</sup> birthday, or 5 years of participation if later.

**Early Retirement Date:** The plan does not provide for retirement prior to the normal retirement date.

**Normal Form of Benefit:** Life annuity payable monthly for single employees or actuarially equivalent qualified joint and 50% survivor annuity payable monthly for married employees.


