As discussed in Note 9 to the financial statements, the Board of Directors of Center ID Corp., the Center ID Corp 401(k) Plan's sponsor, voted by unanimous consent in March 2025 to terminate the Plan and the Plan was liquidated as of June 24, 2025. As a result, the Plan is presenting the 2025 financial statements on the liquidation basis of accounting. Our opinion is not modified with respect to that matter.

**Responsibilities of Management for the Financial Statements**

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS**

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Center ID Corp 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Effective April 14, 2025, in connection with the merger of the Plan's sponsor with a third party, the Plan has been terminated and was fully liquidated on June 24, 2025. The Plan transferred participants' accounts to other plans or into individual retirement accounts, or cashed out the participant balance, in accordance with the wishes of the participant or the Plan provisions. As of April 14, 2025, all participants are fully vested in their accounts within the Plan. The Plan's financial statements as of June 24, 2025 and for the period from January 1, 2025 through June 24, 2025 are presented on the liquidation basis of accounting. The below Plan provisions are prior to the changes due to Plan termination.

*(a) General*

The Center ID Corp 401(k) Plan (the Plan) was created effective January 1, 2024. The Plan is a contributory, defined contribution plan covering eligible employees of Center ID Corp, Inc. (the Company or Plan sponsor). There is no age or service requirement to be eligible to participate in the plan and entry dates are 1<sup>st</sup> day of each month.

Prior to March 1, 2024, the Plan sponsor participated in the TECNA 401(k), a national multiple employer program (PEP) that serves technology and professional employer groups participating in technology trade associations. On March 1, 2024, the balances from TECNA specific to Center ID employees of \$5,605,755 were transferred to Plan. The Plan began accepting contributions for pay periods ending after February 29, 2024 from the Plan sponsor on March 1, 2024. On March 6, 2024, the Plan received employee contributions of \$66,477 for the pay period ended February 29, 2024 which are included in participant contributions in the statement of changes in net assets available for benefits.

On April 14, 2025, the Plan Sponsor was acquired, and the Trustee terminated the Plan effective on this same date. All participant accounts became fully vested and nonforfeitable as of this date and all accounts were fully distributed on June 24, 2025.

*(b) Contributions*

Participants may contribute to their deferred contribution account on a pre-tax and post-tax basis up to the statutory limits prescribed by the Internal Revenue Code, including catch-up contributions for those participants who have reached age 50. The Company may also make a discretionary matching contribution and/or a profit-sharing contribution. The employer match is based upon a discretionary percentage of the participants' compensation or a discretionary dollar amount to be determined by the Company on a uniform basis. The Company did not make either

a matching employer contribution or a profit-sharing contribution in 2025 and 2024.

*(c) Participants' Accounts*

Each participant's account is credited with the participant's contribution, employer contributions, and an allocation of earnings of the Plan. Allocations of Plan earnings are based on participants' account balances, as defined by the Plan. Allocations of the profit-sharing contributions, if any, are based upon eligible participants' compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participants' account.

Each participant directs the investment of their account by selecting from alternative investment funds offered by the trustee.

*(d) Vesting*

Participants are immediately vested in their contributions, plus earnings thereon. Participants are vested in the discretionary match and profit-sharing contributions at a rate of 25% after one year of service with full vesting after four years of service. All employer contributions vest upon death, attainment of normal retirement age (65), or total and permanent disability.

*(e) Payment of Plan Benefits and Other Distributions*

Participants are eligible for distributions upon termination of service, retirement, death or disability. Upon termination, if the participant's account balance is less than \$5,000, the amount will be distributed from the Plan, either in cash, or by rollover to an IRA or another employer qualified plan. Account balances in excess of \$5,000 may stay in the Plan until the participant requests a distribution or becomes subject to minimum distributions at age 70-1/2.

Upon attainment of age 59-1/2 or normal retirement age (age 65), a participant may receive an in-service distribution of vested balances.

*(f) Plan Expenses*

Participants are assessed direct fees for processing specific transactions, such as loans and distributions. Otherwise, the Company bears the cost of administering the Plan to the extent such expenses are not offset by revenue sharing arrangements.

*(g) Forfeitures*

The non-vested portion of a terminated participant's account balance, if any, will be forfeited and generally used to reduce the employer's contribution. The balance of the forfeiture accounts at June 24, 2025 and December 31, 2024, were \$0 and \$0 respectively.

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### *(a) Method of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting.

### *(b) Investments*

The Plan's assets consist primarily of mutual funds and are stated at fair value as determined by quoted market prices, which represent the net asset values of shares held by the Plan at year-end. The change in market value and realized gains and losses during the year are recognized as net appreciation (depreciation) in terms of the fair value of investments in the accompanying statement of changes in net assets available for plan benefits. Purchases and sales of securities are reflected on a trade date basis. Interest is recorded when earned. Dividends are recorded on the ex-dividend date basis.

### *(c) Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from these estimates.

## **NOTE 3 - INFORMATION CERTIFIED BY TRUSTEE**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The Plan administrator has obtained certification from Ascensus Trust Company that the following information is complete and accurate.

1. Amounts included as investments in the statement of net assets available for benefits at June 24, 2025 and December 31, 2024 in Note 4.
2. Investment income included in the statement of changes in net assets available for benefits for the period from January 1, 2025 to June 24, 2025.

## **NOTE 4 - INVESTMENTS**

FASB ASC 820, Fair Value Measurements and Disclosures establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or

liabilities in active markets that the plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability; and

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and classified within level 1 of the valuation hierarchy.

Money market funds are valued at the quoted closing price reported on the active market on which the securities are traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **NOTE 5 - TAX STATUS**

The Plan operates under the provisions of a prototype plan which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which stated that the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter. The Administrator believes that the Plan and related trust are designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has concluded that, as of June 24, 2025, the Plan has not taken any uncertain positions that would require recognition or disclosure.

## **NOTE 6 - DISTRIBUTIONS TO PARTICIPANTS**

In connection with the Plan's termination, participants were notified and provided with distribution options, including a lump-sum cash payment or a direct rollover to another qualified retirement plan or Individual Retirement Arrangement (IRA). The distribution of all account balances began on April 23, 2025 and was completed on June 24, 2025.

## **NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Transactions with Ascensus and Vanguard qualify as party-in-interest transactions.

## **NOTE 8 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through August 29, 2025, the date on which the financial statements were available for issue.
