Our audit did not extend to the certified investment information except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Plan Description

The following description of Fathom Manufacturing, LLC 401(k) Profit Sharing Plan (f/k/a Midwest Composite Technologies, LLC 401(k) Profit Sharing Plan) (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution and voluntary savings plan covering all eligible employees of Fathom Manufacturing, LLC and its subsidiaries (the "Company"), as described in the plan agreement. The Plan does not cover union employees, nonresident aliens, or leased employees. Employees who have attained the age of 19 and have completed at least three months of service are eligible to participate in the Plan. Effective December 1, 2024, employees who have attained the age requirement are eligible to participate in the Plan following one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company is the sponsor of the Plan. Certain employees of the Company, as provided in the plan trust agreement, are the plan administrators and have responsibility for the administration of the Plan. Reliance Trust Company was the Plan's trustee and ADP was the Plan's recordkeeper until November 30, 2024. Effective December 1, 2024, Fidelity Management Trust Company is the Plan's trustee and Fidelity Workplace Services, LLC is the Plan's recordkeeper. Various administrative costs, charges, and expenses are paid by the Plan, and only those expenses paid by the Plan are reflected in the financial statements.

Contributions

The Plan provides for employee salary deferral contributions on pre- and post tax Roth contributions, up to a maximum of 90 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code (IRC). Participants who have attained age 50 may make catch-up contributions in addition to their regular salary deferral contributions up to 100 percent of annual compensation subject to limitations by the IRC. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Effective January 1, 2025, the Company adopted an automatic enrollment and annual increase program for newly eligible participants. Under this program, eligible employees who do not make an affirmative deferral election will be automatically enrolled in the Plan with a default deferral rate. The deferral rate will automatically increase by 1.00 percent annually, up to a maximum of 10.00 percent, unless the participant elects otherwise.

The Plan provides for safe harbor employer matching contributions of 100 percent of a participant's contribution, not to exceed 4 percent of the employee's deferred compensation.

The Company may also make additional discretionary contributions to the Plan. In 2024, the Company did not elect to make any additional contributions outside of the match described above.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Vesting

Participants are immediately 100 percent vested in employee salary, rollover, and safe harbor matching contributions and any income or loss thereon. Vesting in the Company's discretionary matching and discretionary nonelective portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Company as follows: 33 percent after one year of service, 66 percent after the two years of service, and become fully vested after three years of service.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. Account balances of less than \$5,000 are automatically distributed upon termination. In-service distributions may be made from a participant's vested account at any time after the attainment of age 59½. Under certain conditions, participants may receive a hardship distribution subject to a \$500 minimum.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$594 and \$24,404, respectively. These amounts will be used in accordance with the applicable plan provisions. During 2024, forfeitures of \$1,596 were used to reduce the Company's contributions.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by the trustees, Reliance Trust Company and Fidelity Management Trust Company or their affiliates; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Participant Notes Receivable

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Notes receivable bear interest at a market rate.

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 17, 2025, which is the date the financial statements were available to be issued.

Note 3 - Trustee Transition and Investment Allocation Change

On December 1, 2024, the Plan transitioned its trustee and custodian services from Reliance Trust Company to Fidelity Management Trust Company (see Note 4). In preparation for this transition, all participant-directed investments were liquidated and temporarily invested in a money market fund to facilitate the transfer of assets.

A blackout period was implemented from November 22, 2024 through December 31, 2024, during which participants were unable to make changes to their investment allocations, request distributions, or perform other account transactions. The blackout period was communicated to participants in accordance with the requirements of ERISA Section 101(i) and was completed in January 2025.

Following the conclusion of the blackout period, participant accounts were reallocated in accordance with their investment elections under the new trustee platform.

Note 4 - Certified Information

Effective December 1, 2024, the Plan changed its trustee from Reliance Trust Company to Fidelity Management Trust Company (collectively, the "Trustee"). The Trustee of the Plan held the Plan's investments and participant notes receivable and executed all related transactions during the periods under audit. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Money Market Funds

Money market funds are valued at quoted prices reported in active markets.

Stable Value Collective Trust Fund

The stable value collective trust fund is composed primarily of fully benefit-responsive investment contracts that are valued at net asset value of units of the bank collective trust. Net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it were determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the stable value collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidations will be carried out in an orderly business manner.
