### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Mission Lane 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### Opinion

### Notes to Financial Statements

#### 1. Description of Plan:

The following description of the Mission Lane 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement or summary plan description for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all eligible employees of Mission Lane LLC (the "Company" or the "Employer"). Employees become eligible to make contributions to the Plan on the first day of the month coincident with or following their hire date. Participants are eligible to receive employer matching and discretionary contributions after they have completed one year of service during which they have completed a minimum of 1,000 hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions:** The Plan provides for participant contributions of pre-tax and Roth contributions of annual compensation, as defined in the Plan. Participants may contribute up to 100% of pre-tax annual compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, as well as certain individual retirement accounts.

The Company may make discretionary matching and profit-sharing contributions as determined by the Company. During 2024 and 2023, the Company's matching contribution was equal to 100% of the first 3% of participant's contributions plus 50% of additional participant contributions up to a maximum of 4.5%. During 2024 and 2023, there were no discretionary contributions.

Participants of qualifying age may make additional "catch-up" contributions. Contributions are subject to certain limitations.

**Participant Accounts:** Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options:** Participants may direct Fidelity Management Trust Company, the trustee, as to the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections at any time.

**Vesting:** Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's contributions is based on years of continuous service. Participants are fully vested in Company contributions after attaining one year of credited service. Participants that retire, become disabled, or die while employed by the Company immediately become 100% vested.

## MISSION LANE 401(k) PLAN

### Notes to Financial Statements, Continued

#### 1. Description of Plan, Continued:

**Vesting, Continued:** During 2023, the Company had a Plan turnover rate in excess of 20% and was deemed to have partially terminated. With this partial termination, Internal Revenue Service (“IRS”) regulations required all affected participants to become fully vested in the Company’s matching contributions. Thus, participants that left employment during the plan year were immediately 100% vested in the Company’s matching contributions, plus actual earnings thereon. New participants will be subject to the Plan’s regular vesting provisions. Forfeitures related to participants that left employment during 2023 amounting \$61,263 were incorrectly withheld from payments of benefits during 2023 and have been returned to participants in 2024. These amounts are recorded as a distribution payable on the 2023 statement of net assets available for benefits.

**Notes Receivable from Participants:** Participants may borrow from their Plan a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms cannot exceed five years unless the proceeds are used to acquire a principal residence. The loans are secured by the vested balance in the participant’s account and bear interest at rates commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. Management has evaluated notes receivable from participants for collectability and has determined that no allowance is considered necessary.

**Other Receivable:** Other receivable of \$48,602 as of December 31, 2024 consists of correcting transactions funded to the Plan in January 2025.

**Plan Administration:** Overall responsibility for administering the Plan rests with the Company. Participant accounts are administered by Fidelity Investments Institutional Operations Company, an affiliate of the trustee and the third-party administrator of the Plan.

**Payment of Benefits:** Distribution of the vested portion of a participant's account will occur upon the participant's termination of service, retirement, death, disability, or hardship withdrawal, as defined in the Plan. A participant is entitled to receive a lump-sum payment in an amount equal to the vested value of his or her account.

### Notes to Financial Statements, Continued

#### 1. Description of Plan, Continued:

**Forfeitures:** Forfeited balances of terminated participants' non-vested accounts are used to offset employer contributions. There were no forfeitures used to reduce employer contributions in 2024 or 2023. Forfeited balances available were \$14,490 at December 31, 2024 and \$69,937 at December 31, 2023. Additions to forfeited balances available were \$5,816 and \$64,354 during 2024 and 2023, respectively. \$61,263 of forfeitures withheld from participant accounts in 2023 were deemed to have been incorrectly withheld from the participant, as described in the Vesting section above, and were returned to participants in 2024.

#### 2. Summary of Significant Accounting Policies:

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual method of accounting.

**Investment Valuation and Income Recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits:** Benefits are recorded when paid.

**Use of Estimates:** The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**Subsequent Events:** Management has evaluated subsequent events through September 17, 2025, the date the financial statements were available for issuance, and has determined that there are no subsequent events to be reported in the accompanying financial statements.

#### 3. Fair Value Measurements:

The Financial Accounting Standards Board (“FASB”) has issued guidance for measurement and disclosure of fair value and establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar instruments in active and inactive markets; and model driven valuations with significant inputs and drivers derived from observable active markets. There were no assets or liabilities whose fair value was determined using primarily Level 2 inputs at December 31, 2024 and 2023.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement. There were no assets or liabilities whose fair value was determined using primarily Level 3 inputs at December 31, 2024 and 2023.

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments carried or disclosed at fair value:

**Money market:** Valued at the cost, which approximates fair value.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission (“SEC”). These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods previously described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. Administrative Expenses:

Substantially all administrative expenses are paid by the Plan Sponsor, Mission Lane LLC. These expenses include recordkeeping, investment management fees, and audit services.

#### 5. Related Party Transactions:

The Plan invests in mutual funds and a money market fund of an affiliate of the trustee. These are related party transactions and are identified as parties-in-interest in the accompanying Schedule of Assets (Held at End of Year). The Plan paid administrative fees to the trustee or affiliates of the trustee totaling \$23,208 during 2024 and \$18,903 during 2023.

#### 6. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

#### 7. Tax Status:

The Internal Revenue Service has determined and informed the prototype sponsor by letter dated June 30, 2020, that the adopted prototype plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Management has evaluated the effects of accounting guidance related to uncertain income tax positions and concluded that the Plan had no significant financial statement exposure to uncertain income tax positions at December 31, 2024 and 2023. The Plan is not currently under audit by any tax authority.

#### 8. Risks and Uncertainties:

The Plan provides for various investments in mutual funds and money market accounts. Investments are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the financial statements.
