Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Supplemental Schedule Required by ERISA***

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the ATS ESOP Holdings Inc. Employee Stock Ownership Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan was originally adopted effective January 1, 2013, and has been subsequently amended and restated from time to time. The Plan operates as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Sections 401(a) and 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (the IRC), subject to the applicable provision of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

On December 23, 2013, the Plan purchased 100% of the common stock of Acclaim Technical Services, Inc. The common stock was purchased using the proceeds of a borrowing from Acclaim Technical Services, Inc. (Note 5) and the stock is held in a trust fund established under the Plan. The borrowing is to be repaid over 30 years by contributions from the plan sponsor. As the Plan makes each scheduled payment of principal and interest, an appropriate percentage of stock is allocated to eligible participants' accounts in accordance with applicable regulations under the IRC. Effective December 31, 2019, Acclaim Technical Services, Inc. converted from a corporation to a limited liability company called Acclaim Technical Services, LLC.

Effective January 1, 2020, as part of a reorganization of Acclaim Technical Services, LLC and its wholly owned subsidiaries, ATS ESOP Holdings, Inc. (the “Company”) became the sponsor of the Plan, and the Plan was redesignated as the ATS ESOP Holdings Inc. Employee Stock Ownership Plan. As part of the redesign, the common shares of Acclaim Technical Services, LLC, previously owned by Acclaim Technical Services Employee Stock Ownership Plan, were converted to member interests and contributed to ATS ESOP Holdings, Inc.

The borrowing is collateralized by the unallocated shares of stock. The lender has no rights against shares once they are allocated under the ESOP. Accordingly, the financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to: (a) the accounts of employees with vested rights in allocated stock (Allocated), and (b) stock not yet allocated to employees (Unallocated).

**Eligibility:** The Plan covers substantially all employees of the Company, except for leased employees, employees of an affiliated employer, employees who are members of a collective bargaining unit, non-resident aliens, employees classified under the Service Contract Act and independent contractors. Employees who have attained 21 years of age and who have performed one hour of service are eligible to participate in the Plan. As a result of the Company's acquisition of Entegra Systems, Inc., Oasis Engineering, LLC and Alder Technology, Inc., the employees of those acquired companies became eligible to participate in the Plan effective January 1, 2023, October 1, 2023 and January 1, 2024, respectively.

**Contributions:** Generally, the Company's contributions will be in the amounts sufficient to service the debt obligations in Note 5. Contributions are invested in the common stock of the Company. Except in cases of termination due to retirement, death or disability, in order to be eligible for the Company contributions, a participant must be employed by the Company on the last day of the Plan year and have worked 1,000 hours. The Company may also make discretionary cash and noncash contributions as determined each year by the Company's Board of Directors. There were no noncash discretionary contributions made during the year ended December 31, 2024. The Company made cash contributions of \$114,393 for the year ended December 31, 2024. Employee contributions are not permitted.

**Participant Accounts:** Each participant's account is credited with allocations of the Company's contributions, forfeitures, net unrealized appreciation of Company common stock, and other investment earnings or loss, if any.

The Company's contributions may consist of acquisition indebtedness contributions, stock purchase contributions or other discretionary cash contributions and are allocated to active participants based on the percentage that their eligible compensation is representative to total eligible compensation.

Net unrealized appreciation of Company common stock, as determined by an independent appraiser, is allocated based on the number of shares held by the participants at year-end multiplied by the change in the per share value.

**Vesting:** Participants' interests in Company contributions and related earnings become 20 percent vested after two years of credited service, then an additional 20 percent per year with each year of credited service until fully vested after six years of credited service. Participants received one year of vesting for every five years of credited service that were completed prior to January 1, 2013. Participants become fully vested upon retirement, death or disability.

**Payment of Benefits:** Distribution of Plan benefits due to termination, retirement, disability or death will be made in Company common stock (see Put Option below) or a lump sum payment. Periodic installments over a period of five years not to exceed the life of the participant and participant's beneficiary are also permitted. Participants may also elect to rollover their account to another tax deferred account. All vested account balances not exceeding \$1,000 may be immediately distributed in a lump-sum payment. Distributions of a participant's vested account balance upon termination of employment shall be made as soon as administratively feasible after the end of the plan year during which termination of employment occurs.

**Administrative Expenses:** As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. Expenses that are paid by the Company are excluded from these financial statements. The Company has historically paid the operating expenses for the Plan.

**Forfeited Accounts:** Forfeitures of terminated participants' non-vested account balances may be used to reduce Company contributions, pay plan expenses or reallocated to participants. Forfeitures allocated to participants during December 31, 2024, totaled \$196,297.

**Voting Rights:** Participants may direct the voting of shares of the Company common stock allocated to their accounts on any matter on which stockholders are allowed to vote. Such matters are limited to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business, or other similar transactions. If a participant fails to provide instructions, the trustees will vote shares for which the participant has the right to direct voting in the manner directed by the Plan Administrator. The trustees will vote any unallocated shares of the Company common stock in the same manner.

**Diversification:** Diversification will be offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Participants eligible for diversification may elect to direct the Plan to diversify a portion of their account during a 90-day election period which begins on the first day of the plan year that follows each of the six plan years beginning with the plan year in which the participant becomes eligible for diversification. In each of the first five years, a participant may diversify up to 25 percent of the number of Company common stock allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify may elect to receive a cash distribution or to rollover the amount to one or more of at least three diversified investment options, which may be made available in another qualified plan maintained by the Company. Effective January 1, 2023, the Plan was amended to allow only employees actively employed by the Company to diversify their funds into the ATS 401(k) Plan which is a Plan also sponsored by the Company.

**Put Option:** Under Federal income tax regulations, the Company common stock that are held by the Plan and its participants and are not readily tradable on an established market, or are subject to trading limitations, include a put option (the liquidity put). The liquidity put is a right to demand that the Company buy any shares of its common stock distributed to participants for which there is no market. The Plan may also honor the put, although it is not required to do so. The put price is the fair market value of the stock as determined as of the most recent valuation date, as defined.

The purpose of the liquidity put is to ensure that the participant has the ability to ultimately obtain cash after receiving a distribution of stock. If the put option is not exercised within 60 days, it temporarily lapses; put options may then be exercised during the first 60 days of the following plan year. In the event a put option is exercised, the Company shall have the option of paying the purchase price either in a lump sum within 30 days of exercise or in a series of six equal installments, with the first payment to be made within 30 days of exercise and the five remaining payments to be made annually on the exercise date.

**Right of First Refusal:** An agreement between the Company, the Plan and all participants who receive a distribution of common stock, has placed restrictions on the transfer or sale of common stock. Shares cannot be sold or transferred without first offering them to the Company at a per-share price no greater than that tendered by a prospective third-party purchaser or the last ESOP valuation. If the Company does not exercise its right to purchase the shares, then the shares must be offered to the Plan.

## **NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting:** The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Allocations:** The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (Allocated) and (b) stock not yet allocated to employees (Unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

**Investment Valuation and Income Recognition:** The shares of Company common stock are reported at fair value. See Note 4 for a discussion of fair value measurements. Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net unrealized appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits:** Benefits are recorded when paid.

**Subsequent Events:** The Plan has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2      Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

During the year ended December 31, 2024, shares of the level 3 Company Common Stock totaling \$835,729 were redeemed. The unrealized gains related to the level 3 Company Common Stock totaled \$1,529,656. There were no transfers of level 3 assets during the year ended December 31, 2024.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Plan's Investments in shares of the Company's common stock are reported at its fair value as determined by an independent appraiser retained for this purpose by the Plan's trustee. The independent fair value appraisal is dependent upon historical and forecasted operations of the Company as represented by management, and general industry and market conditions affecting the Company's business. The fair market appraisal was determined using a combination of both the income and market approaches. Within the income approach the discounted cash flow method was used. Within the market approach the guideline public company method was used.

**NOTE 5 – LOAN PAYABLE**

In December 2013, the Plan entered into a \$15,750,000 term loan agreement with Acclaim Technical Services, Inc. The proceeds of the loan were used to purchase Acclaim Technical Services, Inc. common stock. Unallocated shares are used as collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments divided by the total of the current year payments, plus all future years' principal and interest payments. This resulted in 66,903 shares being released and allocated for the year ended December 31, 2024.

The agreement provides for the loan to be repaid over 30 years with a final payment due in 2043. The scheduled principal and interest payment per year is \$673,721. Interest is charged at a fixed rate of four percent. The carrying value of the note payable as of December 31, 2024 and 2023 was \$8,841,047 and \$9,148,815, respectively. **NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participation of all participants will end and the accounts of each participant shall become 100 percent vested. Participant accounts will be distributed in accordance with provisions of the Plan.

**NOTE 7 – TAX STATUS**

The Internal Revenue Service (“IRS”) has determined and informed the company by a letter dated February 19, 2015, that the plan is qualified and that the trust established under the plan is tax exempt under the appropriate sections of the IRC. The plan has been amended since receiving the determination letter. However, the plan administrator and the plan’s tax counsel believe that the plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the plan was qualified and the related trust was tax exempt, as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognizes a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 – PARTY-IN-INTEREST TRANSACTIONS**

The Plan invests in Company common stock and has indebtedness to the Company. During the year ended December 31, 2024, all of the administrative expenses of the Plan were paid by the Company. Certain accounting and administrative functions of the Plan are performed by employees of the Company at no cost to the Plan. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

**NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan’s investment consists of the Company’s common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.
