Independent Auditor's Report

The Southern California Edison Company Benefits Committee

Opinion

We have audited the financial statements of Southern California Edison Company Comprehensive Disability Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for plan benefits as of December 31, 2024 and 2023, and the changes in its net assets available for plan benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.



Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Notes to Financial Statements Year ended December 31, 2024

Note 1. Description of Plan

The Southern California Edison Company Comprehensive Disability Plan (“the Plan”) is sponsored by Southern California Edison Company (“the Sponsor” or “the Company”), a wholly-owned subsidiary of Edison International. The Plan covers Edison International and its subsidiaries that elect to participate in the Plan (“Participating Companies”). In compliance with the Department of Labor regulations, the Sponsor established a Comprehensive Disability Plan Trust Account (“the Trust”) for the benefit of employees of the Participating Companies. Employees may choose the Plan, instead of the state-sponsored plan in their respective states of employment, if any, to pay for partial income replacement by participants who, because of physical or mental illness or injury, are unable to perform their regular work duties.

Participants should refer to the Plan document and amendments for a more complete description of the Plan’s provisions.

Eligibility

Subject to exceptions for certain out of state employees (outside of California), all employees of the Participating Companies are eligible to participate in the Plan except for employees not regularly scheduled to work more than 16 hours a week or employees not scheduled to work for a period longer than two weeks.

Coverage

Short-term Disability

Participating Companies provide short-term disability benefits of 60% to 70% of an employee’s base pay for up to 53 weeks. All Plan participants have a seven consecutive calendar day waiting period for short-term disability benefits.

Paid Family Leave

Participating Companies provide 60% to 70% of an employee’s base pay, up to a weekly maximum determined by the state for up to 8 weeks, subject to certain differences for bargaining unit employees in Nevada and certain other out of state employees who may not participate in the Plan. In addition, the seven consecutive calendar day waiting period is eliminated for employees who are eligible for paid family leave benefits. Effective January 1, 2021, the Paid Family Leave program expanded to include new eligibility for employees who take time off work due to a qualifying military event arising out of the overseas military deployment of the employee's family members.

Benefits under the Plan are generally unvested and subject to change.

Participant Contributions

Participants in the Plan contribute through payroll deductions deposited biweekly in the Trust. Deductions are calculated using the same wage base and participant contribution rate as the California-sponsored State Plan. Effective January 1,

2024, the wage cap for calculating participants' contributions has been eliminated. The participant contribution rate was 1.1% in 2024 for California and non-California employees.

Benefit Payments and Employer Contributions

The Participating Companies pay benefits to participants directly and are subsequently reimbursed by the Plan. For each Plan year, the amount reimbursed by the Plan cannot exceed the employee contributions. Total payments by the Participating Companies on behalf of the Plan for the year ended December 31, 2024 exceeded reimbursement received from the Plan. Any unreimbursed portion is the responsibility of the Participating Companies and is reflected as employer contributions in the accompanying statement of changes in net assets available for plan benefits.

Administrative Expenses and Employer Contributions

For each Plan year, non-benefit expenses of the Plan are reflected as administrative expenses in the accompanying statement of changes in net assets available for plan benefits. The Sponsor is reimbursed for reasonable and necessary expenses incurred in the performance of its duties related to the Plan. Reimbursement for non-benefit payment expenses cannot exceed the interest income earned on the Trust. As there is no interest income in 2024, all non-benefit expenses are borne by the Participating Companies and are reflected as employer contributions in the statement of changes in net assets available for plan benefits.

Accounts Payable to Southern California Edison Company

Accounts payable to the Sponsor include the participant contributions collected by the Plan that have not been transmitted to the Sponsor.

Fund Custody and Plan Termination

Custody of the funds is maintained by Wells Fargo Bank, with the Sponsor acting as administrator. Although it has not expressed an intent to do so, the Sponsor maintains the right to terminate the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are presented on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") applicable to employee benefit plans.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Benefit Payments

Benefit payments are recorded when paid.

Benefit Obligations

California law allows employers to apply for approval of a voluntary plan for the payment of disability insurance and paid family leave insurance benefits to their employees in lieu of the mandatory State plan coverage. To be approved for a voluntary plan, an employer is required to post a security deposit with the State of California's Employment Development Department to guarantee that it meets all obligations of the voluntary plan. The Company has filed and annually updates a disability surety bond in favor of the State of California, in accordance with applicable state legal requirements. At December 31, 2024 and 2023, the outstanding bond was \$12,852,100 and \$7,783,800, respectively.

Subsequent Events

The Plan has evaluated subsequent events through the date the financial statements were available to be issued.

Note 3. Tax Status

The Company believes that the Trust established under the Plan to hold the Plan's assets is qualified as tax exempt pursuant to the appropriate sections of the Internal Revenue Code. Tax years that remain open for examination by the Internal Revenue Service are 2021 - 2023.
