Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Clinica Sierra Vista Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C), pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency. Provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section —

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. 1. Description of Plan:

The following description of Clinica Sierra Vista Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering all eligible employees of Clinica Sierra Vista (the Organization). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Organization's Board of Directors is responsible for oversight of the Plan. The Organization's Board of Directors is responsible for determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Eligibility – Nonexcluded employees are immediately eligible to participate in the Plan as a contributing participant upon commencement of employment with the Organization. Participants are required to attain age 18 to qualify for employer matching contributions and must also complete one year of service to qualify for employer nonelective contributions.

Contributions – The Plan permits eligible employees, through a salary deferral election, to have the Organization make annual pretax and Roth contributions of up to the maximum allowed by the Internal Revenue Code (IRC). The Plan includes an automatic contribution arrangement under which each eligible participant is automatically enrolled in the Plan with a pretax election of 3 percent unless they affirmatively elect otherwise. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employee rollover contributions are also permitted.

The Organization makes employer matching contributions equal to 100 percent of the participant's deferral on up to 3 percent of eligible compensation and employer nonelective contributions between 1 percent and 3 percent of eligible compensation, based on years of service.

Contributions are subject to certain limitations.

Investment options – Upon enrollment in the Plan, a participant may direct contributions into any of the funds offered by the Plan. Participants may change their investment options daily.

Participant accounts – Each participant's account is credited with the participant's contributions, the Organization's contribution, allocations of the Plan earnings or losses, and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on the shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Notes receivables from participants – The plan document includes provisions authorizing loans from the Plan to active eligible participants demonstrating a qualifying need. Only one loan may be outstanding at any one time. The minimum amount of a loan is \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50 percent of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on the prime rate plus 1 percent.

1. Description of Plan (continued):

Vesting – Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Organization’s contribution portion of their accounts plus earnings thereon is based on years of service. A participant is fully vested after five years of credited service or upon death or disability while actively employed.

Benefit payments – Upon termination of service for reasons other than death, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested account. Upon termination on account of death, a beneficiary may elect to receive either a lump-sum amount equal to the value of the vested account or installments. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

Forfeited accounts – At December 31, 2024 and 2023, forfeited accounts totaled \$93,977 and \$9,278, respectively. These accounts may be used to pay Plan expenses, reduce employer contributions, or reallocate to participants in the same manner as employer contributions. During 2024 and 2023, forfeitures of \$837,065 and \$422,450, respectively, were applied toward employer contributions.

Plan termination – The Organization has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the participants would become 100 percent vested in their accounts.

2. Summary of Significant Accounting Policies:

Basis of accounting – The financial statements have been prepared on the accrual basis of accounting in accordance with GAAP.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the plan sponsor to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment valuation and income recognition – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of benefits – Benefit payments to participants are recorded upon distribution.

Administrative expenses – Certain administrative expenses are paid by the Plan as provided in the plan document.

Subsequent events – The Plan sponsor has evaluated subsequent events through August 12, 2025, the date on which the financial statements were available to be issued.

3. Information Certified by the Plan Custodian:

Delaware Charter Guarantee & Trust Company doing business as Principal Trust Company (Principal Trust Company), the custodian of the Plan, has supplied the Plan administrator with certifications as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

4. Fair Value of Investments:

Financial Accounting Standards Board (FASB) Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

A description of the valuation methodologies used for assets measured at fair value follows. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual funds are valued at the unadjusted quoted prices for identical assets in active markets.

4. Fair Value of Investments (continued):

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in fair value levels – The availability of observable market data is monitored to assess the appropriate classifications of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2, or 3.

5. Risks and Uncertainties and Concentrations of Credit Risk:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

The Plan has a concentration of investments in Principal Lifetime 2045 Inst Fund and Principal Lifetime 2050 Inst Fund. A change in the value of these funds could cause the value of the Plan's net assets available for benefits to change due to this concentration. In addition, as a result of funds being selected by participants, certain other funds may individually represent a concentration of greater than 10 percent of the Plan's investments, at fair value in the statements of net assets available for benefits. Although these individual funds maintain a level of diversification by investing in multiple equity, debt, or other instruments, there may be a concentration of risk because the funds are invested at the direction of a single fund manager. At December 31, 2024, Principal Lifetime 2045 Inst Fund and Principal Lifetime 2050 Inst Fund each individually represented greater than 10 percent of the Plan's investments, at fair value.

6. Plan Tax Status:

The Plan is required to operate in conformity with the IRC to maintain the exclusion from tax for plan participants. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status; however, there are no audits for any tax periods in progress.

7. Party-in-interest Transactions:

The following transactions are considered party-in-interest transactions under ERISA regulations, but are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA:

- The Plan sponsor provides to the Plan certain accounting and administrative services for which no fees are charged to the Plan. The employees who provide these services are also participants in the Plan.
- Some plan investments are managed by Principal Trust Company. Principal Trust Company manages the individual participant accounts and provides bookkeeping services to the Plan and, therefore, the investment transactions qualify as party-in-interest transactions.
- The Plan auditor performs the required annual audit of the Plan.
- The Plan relies on a third-party service provider, Navia Benefit Solutions, to process the Plan's investment transactions, prepare the Plan's Form 5500, and manage the individual participant accounts of the Plan.
