### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matter**

#### **Supplemental Schedule Required by ERISA**

#### 1. DESCRIPTION OF PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of the Venture 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The sponsors of the Plan are Venture Design Services, Venture Electronics, Univac Precision Inc, VIPColor Technologies, and VM Services Inc. (collectively, the “Company”).

**General** – Effective January 1, 2006, the Company established the Plan for eligible employees of the Company. Employees of the Company are eligible to participate in the Plan upon completion of two months of service from their date of hire and attainment of age 18. Entry dates are on a monthly basis. The Company most recently restated the Plan effective August 24, 2021 and the Plan was most recently amended effective July 1, 2024 to change the small balance automatic force-out limit from \$5,000 to \$7,000.

The Plan is a defined contribution plan covering all full-time employees of the Company except for any employee: (1) who is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining, (2) who is a non-resident alien who does not receive any earned income, or 3) a resident of Puerto Rico. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Administration** - Under the terms of the Plan, certain designated officers of the Company act as the trustees. The Company has contracted with Transamerica Life Insurance Company (“Transamerica”) to act as the custodian. Expenses incurred for administering the Plan may be paid by either the Plan or the Company at its discretion. For the year ended December 31, 2024, most of the Plan’s administrative expenses were paid by the Plan.

**Basis of accounting** - The accounting records of the Plan are maintained on the accrual basis in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

**Use of estimates** - The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reported period. Actual results could differ from these estimates.

**Employee contributions** - Participants may elect to have the Company contribute a percentage of their pre-tax compensation to the Plan, up to the amount allowable under current income tax regulations. Participants who elect to have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Participants may also elect to have the Company contribute a portion of their

compensation post-tax in the form of a Roth deferral. Participants may also elect to contribute amounts representing distributions from other qualified plans.

***Employer contributions*** – The Plan allows for discretionary employer contributions in the form of matching contributions, and non-elective contributions which are allocated to participants based relative eligible compensation. The Company did not make any matching contributions or non-elective contributions for the year ended December 31, 2024.

***Participant accounts*** – A separate account is maintained for each participant. Each participant's account is credited with the participant's voluntary contributions, employer contributions and an allocation of Plan earnings, less withdrawals, distributions and administrative expenses, if any. The benefit to which a participant is entitled is limited to the benefit that may be provided from the participant's vested account balance.

***Forfeited accounts*** – In the event that a participant terminates employment prior to 100% vesting, the portion of Company's contributions which is not vested is forfeited at that time. The forfeited amounts may first be applied to the payment of the Plan's administrative expenses and any remaining amounts will be applied to reduce Company's contributions. No forfeitures were used to reduce employer contributions during the year ended December 31, 2024. Total unallocated forfeitures were \$8,959 and \$8,447 as of December 31, 2024 and 2023, respectively.

***Vesting*** – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in employer contributions accrues each year based on years of continuous service. A participant becomes fully vested after six years of credited service. To earn a year of service for vesting purposes, a participant must be credited with at least 1,000 hours of service during the Plan year.

***Investments*** – Investments of the Plan are held by the Plan's custodian and are invested based solely upon instructions from participants.

*Mutual funds* are recorded at fair market value as reported by Transamerica as determined by quoted market prices on an established exchange.

*Pooled separate accounts* are recorded at estimated fair market value as of the last day of the Plan year as quoted by Transamerica, which is determined daily based on the net asset value of shares of the underlying funds, dividends, and the pooled separate account charges.

*Insurance company general account* is an investment valued at contract value, which approximates fair value, on a daily basis as reported by Transamerica.

The Plan follows the guidance of GAAP for measuring fair value of investments. Those principles establish a framework for the measurement of fair value and provide a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The

hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level one measurements) and the lowest priority to unobservable inputs (level three measurements).

The three levels of the fair value hierarchy are described below:

Level One: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level Two: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level two input must be observable for substantially the full term of the asset or liability.

Level Three: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's method of valuing investments may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Investment income** – Realized gains or losses on investment transactions are recorded as the difference between the proceeds received and the fair value of the investment at the beginning of the Plan year, or cost if acquired during the Plan year. In accordance with the

Plan's policy of stating investments at fair value, net unrealized appreciation or depreciation is included in the statement of changes in net assets in the period in which the market change occurs. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

***Notes receivable from participants*** – The Plan provides a provision that allows a participant to borrow up to the lesser of \$50,000 or 50% of their vested account balance, with a minimum borrowing of \$1,000. Such loans shall bear interest at rates equivalent to available market financing rates. The term of the loans cannot exceed five years and a participant may not have more than two loans outstanding at any time. The loans are secured by the participant's vested balance. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are stated at their unpaid principal balances plus any accrued but unpaid interest.

***Payment of benefits*** – Upon termination of service or disability, age 59 ½, retirement, death, or hardship, the participants or beneficiaries receive, upon request, a lump-sum payment equal to the value of the vested funds in the participant's account. Benefits (which include rollover transfers to other plans) are recorded when paid. The Plan allows for an involuntary direct rollover distribution of participant vested account balances exceeding \$1,000, but not exceeding \$7,000, to an individual retirement account. Prior to July 1, 2024, the Plan allowed for an involuntary direct rollover distribution of participant vested account balances exceeding \$1,000, but not exceeding \$5,000, to an individual retirement account.

***Plan termination*** - The Company intends to continue the Plan indefinitely for the benefit of its employees. However, it reserves the right to terminate the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA. In the event the Plan is terminated in the future, participants would become fully vested in their accounts.

***Subsequent events*** – The Plan's management evaluates events or transactions occurring after the statement of net assets available for plan benefits date but before the financial statements are available to be issued for potential recognition or disclosure. The financial statements include all subsequent events considered necessary for a fair presentation. For the purposes of the accompanying financial statements, subsequent events have been evaluated through September 11, 2025, which represents the date the financial statements were available to be issued.

## **2. INCOME TAX STATUS**

The Company adopted a Prototype Standardized Profit Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with Section 401(a) of the Internal Revenue Code and, therefore, the underlying trust is not subject to tax under IRC 501(a). Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's

qualified status. Accordingly, no provision for state or federal income taxes has been provided.

#### **3. CERTIFIED INFORMATION**

In accordance with 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, Transamerica has certified the current value of assets held at December 31, 2024 and 2023, and transactions entered into during the year ended December 31, 2024, that were used in the preparation of the accompanying financial statements and supplemental schedule. #### **4. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Transamerica, the Plan's custodian, or their affiliates. Therefore, investment transactions involving these investments qualify as party-in-interest transactions as defined by ERISA. Any purchases and sales of these investment funds are open market transactions at fair market value. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transaction under ERISA.

#### **5. RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist principally of mutual funds and pooled separate accounts offered by Transamerica. As the portfolio is well diversified and issuers of the funds' underlying securities are dispersed throughout many industries and geographies, the concentrations of credit risk are limited.
