We have performed audits of the accompanying financial statements of Siouxland Surgery Center LP dba Surgical Dunes Center 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS**

**NOTE 1 PLAN DESCRIPTION**

The following brief description of the Siouxland Surgery Center LP dba Surgical Dunes Center 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

**General**

The Plan is a defined contribution plan covering all employees of Siouxland Surgery Center Limited Partnership (the Company or employer), the Plan sponsor, who meet the eligibility requirements. It is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility**

To be eligible, an employee must be twenty-one years or older and have completed ninety days of service. Employees may begin participating in the Plan on the first day of each Plan year quarter that coincides with or follows the date on which eligibility requirements have been met. Participants are auto-enrolled with a 4% elective deferral rate upon meeting the eligibility requirements.

**Contributions**

Participants may elect to contribute a portion of their compensation up to the maximum allowable which will not exceed the limitations of Code Section 401(k), and eligible catch-up deferrals. Participants have the option to contribute post-tax compensation through Roth contributions. The Plan includes a safe harbor provision under which the Company matches 100% of the first 4% of eligible compensation contributed to the Plan by the participant. The Company may also make a discretionary profit sharing contribution; no such contribution was made for the years ended December 31, 2024 and 2023. Contributions are subject to certain limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and an allocation of the employer's contribution and Plan earnings or losses and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting**

Participants are immediately vested in their elective deferrals plus actual earnings, or less losses, thereon. Vesting in the employer's contribution portion of their accounts plus actual earnings, or less losses, thereon is based on years of continuous service. A participant is vested in the Company's safe harbor matching contributions on a two-year cliff vesting schedule (0% after one year of credited service and 100% after two years of credited service). For all other employer contributions, a participant is 100% vested after three years of credited service.

**Payment of Benefits**

Benefits under the Plan begin when a participant retires, dies or ceases to be employed by the Company. Benefits are recorded when paid, and are normally paid in a lump sum. Benefit payments may be requested to be paid in installments, but the installments may not extend beyond the life expectancy of the participant or the participant's beneficiary. A participant whose vested account balance does not exceed \$5,000 on termination date will receive his or her vested account balance as a lump-sum distribution.

The Plan allows for hardship withdrawals to participants who meet an immediate and severe financial need, and are limited to a participant's vested account balance.

**NOTE 1 PLAN DESCRIPTION (continued)**

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have up to three loans at any given time. Principal and interest are paid ratably through payroll deductions over a period generally not exceeding five years. The loans are secured by the vested portion of the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator at the time of the loan, which range from 5.25% to 10.50%.

**Investment Options**

The amounts contributed by the employee and employer are deposited into one or more available investment options at the participant's discretion. Participants may change their investment options daily.

**NOTE 2 SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

The Plan has investments in Empower Annuity Insurance Company of America's (Empower) general account, referred to as the Key Guaranteed Portfolio Fund. The interest rate credited to investments in the fund is based on a current rate and is not dependent upon the length of time the assets are invested with Empower. Requests for withdrawal can be made at any time and are processed on the day that they are received by Empower, and are not dependent on the liquidation of securities in order to generate payment. The value of the fund investment reported by Empower is the redeemable value of the fund, and there are no changes or other adjustments that would affect liquidity and investment value as the result of a withdrawal request.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation from investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Administrative Expenses**

A portion of administrative expenses incurred on behalf of the Plan, including audit fees, are paid by the employer, which also provides certain administrative services that have not been charged to the Plan. The amount of such expenses and cost of such services have not been determined. Certain other administrative expenses, including the third party administrator fees, are paid by the Plan. During 2024 and 2023, fees totaling \$81,539 and \$78,257, respectively, paid to the Plan's 401(k) advisors and recordkeeper were charged equally to each participant's account on a quarterly basis.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based on the terms of the Plan document. During the years ended December 31, 2024 and 2023, there were no deemed distributions reported in the accompanying statements of changes in net assets available for benefits. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of Benefits**

Benefits are recorded when paid. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but had not yet been paid at December 31, 2024 and 2023.

**Uncertain Tax Positions**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has evaluated their material tax positions and determined there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 3 PLAN TERMINATION**

Although it has not expressed the intent to do so, the employer has the right to terminate the Plan at any time. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 5 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2—Inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly, such as:

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Registered investment companies*—Registered investment companies are valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Key Guaranteed Portfolio Fund*—The Plan has investment contracts with Empower. Deposits are invested in Empower's general account to which interest is added at the contractual rate. Deposits into these accounts are guaranteed the contract rate of return. The investment contract is stated at fair value.

The following tables set forth by level within the fair value hierarchy the Plan's investments at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement. The Plan has no Level 3 investments.

**Transfers between levels**

For the years ended December 31, 2024 and 2023, there were no transfers between Levels 1, 2, or 3.

**NOTE 6 INCOME TAX STATUS**

The Plan has adopted a prototype plan document and is relying on the prototype sponsor's opinion letter from the Internal Revenue Service dated June 30, 2020, that the prototype and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the prototype plan has been amended since receiving the opinion letter, the prototype sponsor and Plan Administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

**NOTE 7 FORFEITED ACCOUNTS**

Forfeited accounts may be used to reduce employer contributions or pay Plan expenses. In 2024 and 2023, forfeiture funds of \$57,968 and \$267, respectively, were used to reduce employer contributions and pay Plan expenses. At December 31, 2024 and 2023, forfeited unallocated invested accounts totaled \$6,358 and \$55,684, respectively.

**NOTE 8 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of subaccounts managed by Empower. Under a group annuity contract between Empower and the Plan, Empower has been designated as the custodian over the Plan's investments. Therefore, investment transactions between the Plan and the custodian's managed accounts qualify as party-in-interest transactions. Administrative expenses paid to Empower totaled \$43,750 and \$39,745 for the years ended December 31, 2024 and 2023, respectively.

Certain Plan Administrators are currently participants in the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 9 RISKS AND UNCERTAINTIES**

Participants invest their account balances in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
