Scope and Nature of the *ERISA* Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Gee Automotive Companies 401(k) Retirement Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974 (ERISA)*, as permitted by *ERISA* Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Gee Automotive Companies 401(k) Retirement Plan's financial statements performed in accordance with *ERISA* Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under *ERISA*. As permitted by *ERISA* Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under *ERISA* (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following brief description of the Gee Automotive Companies 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General. The Plan is a qualified defined contribution plan covering substantially all employees of the participating companies who have been an employee for 3 consecutive months of service for employee deferrals, and 1 year of service for matching, and are age 18 or older. It is subject to the provisions of the *Employee Retirement Income Security Act of 1974 (ERISA)*.

The Plan received its latest determination letter dated March 31, 2014, in which the Internal Revenue Service (IRS), stated that the Plan, as amended through April 2, 2012, was in compliance with the applicable requirements of the *Internal Revenue Code*. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the *Internal Revenue Code*. Therefore, they believe the Plan is qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

The Plan is a single-employer plan that covers all the employees of the Gee Automotive Holdings, LLC.

Plan Amendments. The adoption agreement was amended effective April 15, 2024, to include Cycle 3 restatements. The Plan was amended to include the participation of Westminster Automotive Group, dba Honda World.

Contributions. Voluntary contributions are made by each participant up to a maximum of 100 percent of the participant's salary or the annual limits published by the IRS, whichever is less. The Companies may make a discretionary matching contribution for elective deferrals. The Gee locations, including Elliot Bay, have a match of 25 percent of the first 6 percent of eligible participant contributions. The Tonkin locations, including the locations acquired by Gee, have a match of 50 percent of the first 6 percent of eligible participant contributions. The Lyle Pearson and Tucson Subaru locations acquired by Gee, have a match of 100 percent of the first 3 percent of participant contributions, and then 50 percent of the next 2 percent of participant contributions.

Participant Accounts. Each participant's account is credited each pay period with the participant's contribution. Plan investment income and unrealized gains or losses are allocated to participant accounts daily.

1. DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 3.25 percent to 6.00 percent, which is commensurate with local prevailing rates. Principal and interest are paid ratably through monthly payroll deductions. The Plan did allow participant loans under the provisions of the *CARES Act*. These provisions allowed participants to borrow from their fund accounts up to a maximum equal to the lesser of \$100,000 or 100 percent of their vested account balance.

Payment of Benefits. Upon retirement or termination of service, the balance of the participant's account will be distributed as an annuity or as a single lump-sum cash payment. The participant can elect the form of payment at any time before retirement. Benefits are recorded when paid. The Plan did allow distributions under the provisions of the *CARES Act*.

Vesting. Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting on the matching contributions is based on years of credited service where the participant accrued 1,000 or more hours of service. Participants are vested at 50 percent in year 1, 65 percent in year 2, 80 percent in year 3, 90 percent in year 4, and 100 percent vested in year 5.

The Plan has allocated \$21,212,559 in vested benefits to participants who have terminated participation in the Plan as of December 31, 2024.

Forfeited Accounts. At December 31, 2024, forfeited non-vested accounts totaled \$39,276. Forfeitures may be used to pay Plan expenses or may be used to reduce future employer contributions. Forfeitures of \$18,200 were used in 2024 to pay Plan expenses and \$21,076 to reduce employer matching contributions.

Expenses. Certain expenses of maintaining the Plan are paid directly by the participating companies and are, therefore, excluded from these financial statements.

Plan Termination. Although management has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of *ERISA*. In the event of Plan termination, participants will become 100 percent vested in their accounts.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting. The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

2. SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition. Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 6 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investments in Common Funds. The common funds may hold investments in units of other funds within the Trust or similar funds for which other unrelated entities are trustee. The trustee or an unrelated trustee estimates the fair value of investments in common funds that have calculated net asset value per unit in accordance with the specialized accounting guidance for investment companies. Accordingly, as a practical expedient, investments in other such funds are valued at their net asset value as reported by the investee funds. The funds have the ability to redeem their investments in the common funds at net asset value.

Net Asset Value (NAV). Units of each common fund are valued each day on which the New York Stock Exchange (NYSE) is open for trading in accordance with the valuation procedures established by the trustee. The NAV per unit is calculated as of the close of trading on the NYSE. The NAV per unit is computed by dividing the total fair value of the assets of each fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in each fund and included in the determination of unit values.

Use of Estimates. The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

3. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Standard Insurance Company (Standard). Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

3. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY (CONTINUED)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0 percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Standard. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under *ERISA*. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value.

Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

4. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under *ERISA*. Accordingly, Standard Insurance Company and Reliance Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of:

- Investments reflected on the accompanying statement of net assets available for benefits as of December 31, 2024 and 2023.
- Net depreciation in fair value of investments and interest and dividends reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, which such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

6. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

Level 2 Fair Value Measurements

The fair values of pooled separate accounts are valued daily using quoted prices.

8. SUBSEQUENT EVENTS

Management has evaluated subsequent events through August 15, 2025, the date the financial statements were available to be issued. There were no subsequent events identified.

9. RELATED PARTY TRANSACTIONS

Notes receivable from participants qualify as party-in-interest transactions and are disclosed on the financial statements. Plan fees for Plan administration, participant distributions, new participant loans, and Plan auditing qualify as party-in-interest transactions. Distributions and new participant loan fees are only charged to participants that received a distribution or a loan during the year. Fees paid by the Plan for these services in 2024 amounted to \$395,569.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of *ERISA*.



