### Note 1 - Description of Plan

The following description of the Gardner 401(k) Plan for AFSCME Local 101 Represented Employees (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

**General** - The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all the AFSCME Local 101 represented employees of Gardner Family Health Network, Inc. (the Employer), and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Under the terms of the Plan, a group of designated officers of the Employer act as the trustee. The Employer has contracted with Empower Annuity Insurance Company of America (EAICA) and Empower Trust Company, LLC (ETC) to act as the trustees/custodians, and a third-party administrator to process and maintain the records of participant data. Substantially all expenses incurred for administering the Plan are paid by the Employer.

**Eligibility** – Employees of the Employer who are covered under a collective bargaining agreement with AFSCME Local 101, are eligible to participate in the Plan upon completion of 1000 hours of service. Once the eligibility requirement is met, the employee will be enrolled in the plan during the quarterly scheduled entry date. Entry dates for plan participation are January 1st, April 1st, July 1st, and October 1st.

### Contributions

*Participant contributions* - Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

*Employer contributions* – The Employer may elect to make discretionary matching, discretionary nonelective and profit-sharing contributions to the Plan. The Employer will make a contribution equal to 2.16% of gross salary for each eligible employee in accordance with the terms of the plan document. The Employer agrees that effective after a worker's third (3<sup>rd</sup>) year of consecutive service, if the worker is making any contribution to the Plan, the Employer will contribute an additional amount equal to .5% of a worker's gross monthly wage. The Employer also agrees that effective after a worker's sixth (6<sup>th</sup>) year of consecutive service, if the worker is making any contribution to the Plan, the Employer will contribute an additional amount equal to 1% of the worker's gross monthly wage. The Plan made contributions totaling \$183,570 during the year ended December 31, 2024. All contributions are subject to regulatory limitations.

**Participant accounts** – Each participant's account is credited with the participant's contributions and allocations of the Employer's discretionary matching, nonelective and profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

### **Note 1 - Description of Plan (continued)**

**Vesting** - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service as follows: less than three years – 0% and three or more years – 100%.

**Notes receivable from participants** - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed fifteen years. Under the terms of the Plan agreement, plan loans will bear a reasonable rate of interest determined by the custodian. Principal and interest is paid ratably through biweekly payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans were 4.25% to 9.50% with various maturities through July 2029.

**Payment of benefits** - On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account; or monthly, quarterly, or annual installments if the participant is subject to lifetime Required Minimum Distributions. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Forfeitures** - Forfeitures are the non-vested portion of a participant's account that is lost upon termination of employment. Forfeitures must be used before year end and will first be used to pay plan administrative expenses; any remaining amount will be allocated to participant accounts as an additional Discretionary Non-elective Contribution. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,626 and \$15,963, respectively. For the year ended December 31, 2024, forfeitures in the amount of \$15,963 were used.

### **Note 2 - Accounting Policies**

**Basis of accounting** - The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

**Use of estimates** - The preparation of financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

### **Note 2 - Accounting Policies (continued)**

**Investment valuation** – The investments are reported at fair value and contract value. The Plan’s custodians, EAICA and ETC, certify the contract value of the guaranteed investment contract and the fair market value of all other investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net depreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

**Notes receivable from participants** - Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement.

**Payment of benefits** - Benefits are recorded when paid.

**Expenses** - General plan administrative expenses may be paid out of the forfeiture account or paid by the Employer. Investment management, distribution and loan transaction fees are paid by the Plan participants.

**Subsequent events** - Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are issued.

The Plan has evaluated subsequent events through July 1, 2025, which is the date the financial statements were issued.

### Note 3 - Fair Value Measurements

FASB ASC Topic 820, *Fair Value Measurements and Disclosures* (ASC 820) provides a framework for measuring fair value under U.S. generally accepted accounting principles. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The following provides a general description of the three levels of inputs that may be used to measure fair value under ASC 820:

Level 1 - Inputs to the valuation methodology are based on quoted prices available in active markets for identical assets or liabilities on the reporting date.

Level 2 - Inputs to the valuation methodology are other than quoted market prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology include significant inputs that are generally unobservable from objective sources. These inputs may be used with internally developed methodologies that result in management's best estimate of fair value including assumptions regarding risk. Level 3 instruments include those that may be more structured or otherwise tailored to the Plan's needs.

As required by ASC 820, financial assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Registered investment companies (mutual funds)* – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method are appropriate and consistent with other market participants, the use of different methodologies for assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. ### Note 4 – Guaranteed Investment Contract

The Plan has a fully benefit-responsive guaranteed investment contract (FBRIC) with EAICA. EAICA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than the rate established each period; the rate was 1.20% as of December 31, 2024. The crediting rate is reviewed on a semiannual basis for resetting. The FBRIC does not permit Principal Life to terminate the agreement prior to the scheduled maturity date.

The contract meets the FBRIC criteria and, therefore, is reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

### **Note 4 – Guaranteed Investment Contract (continued)**

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, and (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

### **Note 5 – Tax Status**

The Plan has adopted a prototype plan that has received an opinion letter from the Internal Revenue Service. The plan administrator believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the Code and related state statutes, and that the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

In accordance with guidance on accounting for uncertainty in income taxes (ASC 740-10), management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 6 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **Note 7 - Information Prepared and Certified by Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, EAICA and ETC, the custodians of the Plan, have certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends, and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

### **Note 8 – Party in Interest Transactions**

Certain Plan investments are managed by EAICA and ETC. EAICA and ETC are the custodians of the Plan and, therefore, transactions with this entity qualify as exempt party-in-interest transactions. Plan investments are managed by EAICA and ETC. EAICA ETC are the custodians and record keepers for the Plan and, therefore, these transactions qualify as party in interest transactions.

### **Note 9 – Plan Termination**

Although termination of the Plan is not presently contemplated, the Employer has the right to terminate the Plan at any time. In the event of Plan termination, each participant affected by the termination shall become 100% vested in their respective investments, including all employer contributions.
