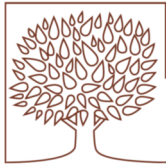

## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
the Regional Hospice and Home Care 401(k) Profit Sharing Plan and Trust

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Regional Hospice and Home Care 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. 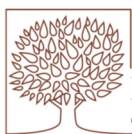

Note 1: DESCRIPTION OF PLAN

The following description of the Regional Hospice and Home Care 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General* — The Plan is a defined contribution plan covering all full-time employees of Regional Hospice and Home Care of Western Connecticut, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Empower Annuity Insurance Company of America and Empower Trust Company, LLC serves as the trustees of the Plan. WT3(16), LLC and Wells Thomas, LLC provide plan administrator and non-fiduciary third party administrator services, respectively, to the Plan.

*Eligibility* — The Plan is available to substantially all company employees. Participants are eligible to make elective deferrals and receive employer matching contributions after attaining age 18 and completing one month of service. Participants are eligible for the discretionary employer contribution after attaining age 18 and completing one year of service. To qualify for the discretionary employer contribution in any given plan year, the participant must be credited with at least 1,000 hours of service and be employed on the last day of the Plan year. Eligible employees may enter the Plan on the first day of each month following the satisfaction of the age and service requirements.

*Contributions* — Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. The maximum amount that a participant may contribute is limited by provisions of the Internal Revenue Code (the Code). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company provides a safe harbor matching contribution of 100% of salary deferrals up to the first 3% of plan compensation, plus 50% of salary deferrals up to the next 2% of plan compensation. The Company may also elect to make a discretionary profit sharing contribution in any plan year. There were no discretionary contributions made as of December 31, 2024 and 2023, respectively.

*Participant Accounts* — Individual accounts are maintained for each participant and are credited with the participant's contributions and the Company's contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of plan losses and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of their contributions and company contributions into various investment options offered by the Plan. The Plan currently offers investments in various mutual funds, a collective trust, and a group annuity contract.

*Vesting* — Participants are vested immediately in their elective deferrals and employer matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service as follows:

Note 1: DESCRIPTION OF PLAN (continued)

*Notes Receivable from Participants* — Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear fixed interest rates at 1% over the prime rate. For the year ended December 31, 2024, the interest rates ranged from 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions within 5 years unless the loan is used for the purchase of a primary residence which holds a maximum repayment of 30 years.

*Payment of Benefits* — Participants or their beneficiaries are entitled to receive the entire amount of their vested interest in the Plan upon retirement (normal retirement age is 65), death, disability, employment termination or proven financial hardship.

*Forfeited Accounts* — Participants who terminate their employment prior to becoming 100% vested forfeit their non-vested account balance. These benefits plus accumulated investment earnings are left in the Plan and can be used to pay plan expenses or allocated to plan participants in the year the forfeiture occurred. For the years ended December 31, 2024 and 2023, the balance in the forfeiture account totaled \$3,791 and \$260, respectively. No forfeitures were used to reduce the Company's contributions for the years ended December 31, 2024 and 2023, respectively.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting* — The financial statements of the Plan are prepared on the accrual basis of accounting.

*Investment Valuation and Income Recognition* — The Plan's investments are stated at fair value, except for the fully benefit-responsive group annuity contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of the collective trust are valued at the underlying net asset value (NAV) of units held by the Plan at year-end. See Note 3 for discussion of fair value measurement.

Contract value is the relevant measure for a fully benefit-responsive contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation in fair value for each type of investment held by the Plan, which includes gains and losses on investments bought and sold, as well as held during the year.

*Use of Estimates* — The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make certain estimates and assumptions that affect the reported amount of net assets available for benefits and contingent assets and liabilities at the date of the financial statements, and the stated amount of additions and deductions during the reporting period. Actual results could differ from those estimates.

*Notes Receivable from Participants* — Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the Plan document. No allowance for credit losses have been recorded for the years ended December 31, 2024 and 2023, respectively.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

*Risk and Uncertainties* — The Plan invests in various securities including mutual funds, and collective trusts. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Expenses* — Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

*Benefit Payments* — Benefit payments to participants are recorded upon distribution.

*Subsequent Events* — The Plan has evaluated subsequent events through August 22, 2025, the date the financial statements were available to be issued.

Note 3: FAIR VALUE MEASUREMENTS

The Plan values its assets and liabilities based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value into three broad levels as follows:

Level 1 - Quoted prices (unadjusted) in active markets that are accessible at the measurement date for identical assets or liabilities. The fair value hierarchy gives the highest priority to Level 1 inputs.

Level 2 - Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in inactive markets or model-derived valuations in which all significant inputs are observable or can be derived principally from or corroborated with observable market data.

Level 3 - Unobservable inputs are used when little or no market data is available. The fair value hierarchy gives the lowest priority to Level 3 inputs.

In determining fair value, the Plan utilizes valuation techniques that maximize the use of quoted and observable inputs and minimize the use of unobservable inputs to the extent possible as well as considers counterparty credit risk in its assessment of fair value.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies for the years ended December 31, 2024 and 2023, respectively.

*Mutual Funds* — Valued at the NAV of shares held by the Plan at year end using market prices on active markets (Level 1). Level 1 instrument valuations are obtained from real-time quotes for transactions in active exchange markets involving identical assets.

*Collective Trust* — Valued based on inputs that are derived principally from or corroborated by observable market data by correlation of the underlying assets and valued using the market approach based on the NAV of the units held by the Plan at year-end. The NAV is provided by Empower Retirement, LLC and is used as a practical expedient to estimate fair value. The collective trust requires advance written notice of five business days for withdrawals which will exceed \$1 million or 10% of the assets invested in the collective trust.

Note 3: FAIR VALUE MEASUREMENTS (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: GROUP ANNUITY CONTRACT

The Plan has a group annuity contract with Empower Annuity Insurance Company of America that invests contributions in the Empower Investments Fixed Account. The Empower Investments Fixed Account is a general account product with an insurance company. The group annuity contract pays interest at crediting rates which are announced in advance and guaranteed for a specific period of time as outlined in the contract. The contract meets the fully benefit-responsive investment contract criteria and therefore is included in the financial statements at contract value.

Since the contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. Contract value, as reported to the Plan by the custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Note 4: GROUP ANNUITY CONTRACT (continued)

Certain events limit the Plan's ability to transact at contract value with Empower Annuity Insurance Company of America. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition in competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

Note 5: INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)

The Plan management has elected the method of compliance permitted by 29 CFS 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, the trustees of the Plan, have certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule Form 5500, Schedule H, Part IV, Line 4i — Schedule of Assets (Held at End of Year) as of December 31, 2024; the related investment activity and interest income on notes receivable from participants reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

Note 6: RELATED-PARTY TRANSACTIONS

The Plan's investments managed by the trustee are considered exempt party-in-interest transactions. The Plan allows participants to take loans against their account balance which are also considered exempt party-in-interest transactions. The group annuity contract is managed by Empower Annuity Insurance Company of America, one of the Plan's custodians, and, therefore, these transactions qualify as party-in-interest. Recordkeeping, investment management, and contract administration fees paid by the Plan were \$29,210 and \$27,598 for the years ended December 31, 2024 and 2023, respectively. Empower Trust Company, LLC, one of the Plan's custodians, receives revenue from mutual fund service providers for services it provides to the funds. Empower Trust Company, LLC remits this revenue to the Plan's trust on a monthly basis. Such amounts were used to pay plan fees of \$14,110 and \$16,120 for the years ended December 31, 2024 and 2023, respectively. These revenue and fees qualify as party-in-interest transactions.

Note 7: PLAN TERMINATION

Although the Company has not expressed the intent to terminate the Plan, it expressly reserves the right to amend or terminate the Plan at any time subject to provisions set forth by ERISA. In the event the Plan is terminated, participants are entitled to the entire net asset value of their account.

Note 8: FEDERAL INCOME TAX STATUS

The sponsor adopted a prototype plan which received an Internal Revenue Service opinion letter dated June 30, 2020. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.
