## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

### 1. Description Of The Plan

The following description of the Danforth Center Defined Contribution Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

#### General

The Plan is a 403(b) defined contribution plan established by the Donald Danforth Plant Science Center (the “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. Teachers Insurance And Annuity Association (TIAA) serves as the recordkeeper of the Plan.

#### Contributions

Participants may defer any percentage of their annual compensation, subject to certain limitations on a pre-tax or Roth after-tax basis. At age 50 participants may make catchup contributions. Participants may also contribute transferred assets directly from any other qualified retirement plan (rollovers).

No employee groups are excluded from participating in Plan contributions. Employees working less than 30 hours a week and graduate students classified as employees are excluded from the employer matching and nonelective contributions.

There are no age or service requirements to participate in the Plan. Employees may make deferral contributions and receive the Employer contributions on the first day of the payroll period that follows their hire date.

For the years ended December 31, 2024 and 2023, the Employer non-elective contribution was equal to 3% of each participant’s eligible compensation.

The Plan contains an additional matching provision that requires the Employer to make a contribution ranging from 2% to 5% of the participant’s eligible compensation.

#### Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Employer’s contribution and an allocation of the Plan’s earnings and expenses. Allocations are based on account balances, as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### **Investment Options**

Upon enrollment in the Plan, a participant may direct elective contributions and Employer contributions in any of the available investment options. The investment options consist of guaranteed investment accounts, registered investment companies, variable annuity accounts, and a pooled separate account.

### **Notes Receivable From Participants**

A participant may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the participant's vested account balance and bear interest at a variable rate, adjusted on a quarterly basis, as defined by the Plan Document. Loans are for a period not to exceed five years, unless used to purchase a primary residence in which case the loan may not exceed ten years.

Prior to the 2019 Plan year, participants borrowed from TIAA directly. The amount of Plan assets serving as collateral for loans issued directly by TIAA at December 31, 2024 and 2023, was \$55,364 and \$54,347, respectively.

### **Vesting**

Participant and Employer contributions and earnings thereon are fully vested and nonforfeitable at all times. Prior to January 1, 2021, employer matching contributions and earnings thereon became fully vested and nonforfeitable after completing three years of service in which the employee worked at least 1,000 hours within each Plan year.

### **Forfeitures**

Forfeited non-vested accounts may be used to reduce future Employer contributions to the Plan and pay Plan administrative expenses. There were no forfeitures used for the year ended December 31, 2024 or 2023. As such, there were no forfeitures available for future use as of December 31, 2024 or 2023.

### **Payment Of Benefits**

Amounts in a participant's account, including rollovers and investment earnings, are distributed upon retirement, death, disability, or other termination of employment. Active participants may also elect to receive a distribution upon attainment of age 59 ½. The normal forms of retirement benefit are lump-sum payments, installment payments or the purchase of annuity contracts.

Active participants who experience a qualifying financial hardship may withdraw all or part of their vested account resulting from elective deferral contributions. Hardship withdrawals will be approved only if they conform to Plan provisions and established Internal Revenue Code (IRC) safe harbors.

### **Administrative Expenses**

Each participant will pay administrative and investment expenses based on the percentage of assets held in their vested accounts. The investment expenses are netted against earnings and are included in investment income, and the administrative expenses are shown in total deductions on the statements of changes in net assets available for benefits. Significant costs of administering the Plan are paid by the Employer.

## **2. Summary Of Significant Accounting Policies**

### **Basis Of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

### **Investment Valuation And Income Recognition**

The Plan's investments, other than fully benefit-responsive investment contracts, are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Investment contracts held by a defined contribution plan are generally reported at contract value except for those contracts that are non-fully benefit-responsive. In that instance, these contracts are required to be reported at fair value. A portion of the Plan's investment in the TIAA Traditional Annuity account is not a fully benefit-responsible investment contract and is reported at fair value in the statement of net assets available for benefits. The remainder of the balance in the TIAA Traditional Annuity is fully-benefit responsive and has been reported at contract value in the statement of net assets available for benefits in addition to the TIAA Stable Value account and the Plan Loan Default Fund.

The net change in fair value of investments represents the difference between the aggregate fair value of investments at year end and the values at the beginning of the year and includes any realized gains and losses in securities that were bought and sold during the year.

Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis.

#### **Payment Of Benefits**

Benefits are recorded when paid.

#### **Subsequent Events**

Management evaluates subsequent events through the date financial statements were available for issue, which is the date of the Independent Auditors' Report.

### **3. TIAA Traditional Annuity**

The TIAA Traditional Annuity is a guaranteed fixed annuity contract available as an investment option to Plan participants. The TIAA Traditional Annuity is offered through a variety of contract types, including: the Group Retirement Annuity (GRA); Retirement Choice Annuity (RC); Group Supplemental Retirement Annuity (GSRA); and the Retirement Choice Plus Annuity (RCP).

### **Group Retirement Annuity And Retirement Choice Annuity**

The GRA and RC are not fully benefit-responsive and reported at fair value, which approximates contract value as estimated by TIAA. The GRA and RC contain liquidity restrictions where lump-sum withdrawals are permitted within 120 days following termination of employment, are subject to a 2.5% surrender charge, and contain certain limitations on the number periodic installment payments.

### **Group Supplemental Retirement Annuity And Retirement Choice Plus Annuity**

The GSRA and RCP are fully benefit-responsive and are reported at contract value. The contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers, if any, less any withdrawals and transfers, if any.

The GSRA provides a guarantee of principal, a guaranteed minimum rate of interest of 3% and the potential for additional interest, if declared by TIAA. The RCP provides a guarantee of principal, a guaranteed minimum of interest between 1% and 3% redetermined annually each March 1, and the potential for additional interest, if declared by TIAA. Additional interest, when declared, remains in effect for the "declaration year", which begins each March 1. Additional interest is not guaranteed for future years. The crediting rate is supported by the investment performance of a large, diversified portfolio, is correlated with the highest quality debt security yields, and is adjusted for contract liability.

## **4. Certified Financial Information**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Teachers Insurance And Annuity Association and College Retirement Equities Fund (TIAA and CREF) has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of and for the years ended December 31, 2024 and 2023:

- Investments at fair value and contract value
- Net change in fair value of investments
- Interest and dividends
- Schedule of assets (held at end of year)
- Notes receivable from participants
- Interest income on notes receivable from participants

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**5. Fair Value Measurements**

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

#### **Registered Investment Companies**

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

#### **Pooled Separate Account**

TIAA Real Estate Account's fair value is based on the fund's daily NAV, which is considered by Plan management to be the best approximation of fair value. The unit value of the fund is calculated daily and available to Plan Administrators and client investors on TIAA and CREF's website. Underlying holdings are primarily valued using independent appraisals or independent pricing sources. Participant transactions (purchases and sales) may occur daily. There are no unfunded capital commitments or redemption notice period requirements.

#### **Variable Annuity Accounts**

Variable annuity accounts are valued at the daily closing price as reported by the investment. These variable annuity accounts held by the Plan are open-end registered investment companies that are registered with the Securities and Exchange Commission. These investments are required to publish their daily NAV and to transact at that price. These variable annuity accounts held by the Plan are deemed to be actively traded.

#### **Guaranteed Investment Accounts**

Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. While Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodologies used at December 31, 2024 or 2023.

### **6. Income Tax Status**

The Plan uses a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on August 7, 2017, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and as such is exempt from Federal income taxes.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

### **8. Related Party And Party In Interest Transactions**

Certain Plan investments are managed by TIAA and CREF. The related transactions with TIAA and CREF qualify as allowable party in interest transactions.

Certain employees have outstanding loans with the Plan as of December 31, 2024 and 2023. These loans are considered allowable party in interest transactions.

**9. Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
