INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Marine Military Academy, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Marine Military Academy, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above, related to assets held by and certified to by the qualified institutions agree to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Marine Military Academy, Inc. Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Marine Military Academy, Inc. NOTE 1: DESCRIPTION OF PLAN

The following description of the Marine Military Academy, Inc. Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

During the periods under audit, the Plan is a defined contribution plan for the employees of Marine Military Academy, Inc. (Plan Sponsor). The Plan allows for self-directed accounts through Principal, Fidelity Management Trust Company, TIAA, and USAA Investment Management Company. Employees may begin participating in the Plan upon employment commencement date or if later, upon satisfaction of eligibility conditions. This Plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor Board of Trustees is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Board of Trustees.

Some administrative functions are performed by employees of the Plan Sponsor. No compensation is remitted to the Plan Sponsor for these services. Plan assets are held by Principal, Fidelity Management Trust Company, TIAA, and USAA Investment Management Company, the custodians and the qualified institutions of the Plan, which invest contributions and Plan earnings, make investment transactions as directed by participants, and provide certain recordkeeping services. As of September 1, 2022, self-directed contributions through salary reductions are only remitted to Principal.

Eligibility

All employees who normally work more than 20 hours a week and are not student employees are eligible to participate in the Plan.

Contributions

Participants may contribute as much of their salary as they wish to the Plan, up to the dollar limit set by law. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. A matching contribution equal to 100% of each participant’s elective contribution but not to exceed 5% of the participant’s eligible compensation is made by the Plan Sponsor. Contributions are subject to certain Internal Revenue Service (IRS) limitations. The participant contribution limit for the 2024 plan year was \$23,000 and the catch-up contribution limit for employees aged 50 and over was \$7,500.

Marine Military Academy, Inc. Retirement Plan Notes to Financial Statements

NOTE 1: DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's elective contribution and the Plan Sponsor's matching contribution. Each participant's account is credited with the actual earnings of the participant's investments less an asset-based fee. Participant accounts with Fidelity Management Trust Company and Principal are charged with an allocation of administrative expenses paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Each participant is 100% vested in his or her contributions as well as the Plan Sponsor's contribution immediately upon entry into the Plan, plus actual earnings thereon.

Benefit Payments

The Plan allows for distributions of up to 100% of a participant's account balance upon retirement. The Plan also allows for distributions of up to 100% of a participant's account balance after the participant reaches age 59 1/2. The Plan is subject to the required minimum distribution provisions of the Internal Revenue Code (IRC).

The Plan provides that an amount of up to 100% of the participant's account balance may be distributed to the participant upon termination of service or to the participant's beneficiaries at the participant's death.

Hardship Withdrawals

As permitted by the IRC, and in accordance with the plan agreement, a participant may request a financial hardship withdrawal if they experience severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's salary deferral contributions (but not earnings on their salary deferral contributions), whichever is less if the withdrawal request is for a purpose delineated in the Plan document.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of U.S GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments generally are reported at fair value but may also be reported at contract value or net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for further discussion of fair value measurements, contract value, and NAV.

The Plan's valuation policies are based on valuation information reported by Principal, Fidelity Management Trust Company, TIAA, and USAA Investment Management Company, the custodians of the Plan's assets. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Distributions to participants are recorded when paid.

Administrative Expenses

Fidelity Management Trust Company expenses attributable to the general plan administration were paid by the Plan and allocated among the accounts of Fidelity Management Trust Company participants on a five dollars per calendar quarter basis. During the year ended December 31, 2024, Fidelity Management Trust Company general plan administration expenses of \$1,115 were paid by the Plan and allocated to participant accounts.

Principal expenses attributable to the general plan administration were paid by the Plan and allocated among the accounts of Principal participants based on 0.33% of the account balance. One-twelfth of the total administrative expenses are deducted from the account balance each month. During the year ended December 31, 2024, Principal general plan administration expenses of \$14,945 were paid by the Plan and allocated to participant accounts.

Other general plan administration fees paid by the Plan Sponsor were not allocated to participant accounts and are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation of the value of investments.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, September 16, 2025 and determined there were no events that occurred that required disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

NOTE 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTIONS

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Principal, Fidelity Management Trust Company, and TIAA, the qualified institutions:

- a) Total investments, at fair value and contract value, included in the statements of net assets available for benefits at December 31, 2024 and 2023, except for the uncertified investments of \$8,727 and \$8,296, respectively.
- b) Investment income and net appreciation in the value of investments information included in the statement of changes in net assets available for benefits for the year ended December 31, 2024, except for investment income related to the uncertified investments of \$8,727.
- c) All amounts included in Note 4, *Fair Value Measurements*, except for the uncertified investments of \$8,727 and \$8,296 at December 31, 2024 and 2023, respectively.
- d) All amounts included in Note 5, *Fully Benefit Responsive Investment Contracts*.
- e) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024, except for uncertified investments of \$8,727.

NOTE 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

- Level 1 Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

- Level 2 Significant other observable inputs other than Level 1 prices, such as:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs, other than quoted prices, that are:
 - Observable; or
 - Can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation of methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds, money market funds, and pooled separate accounts: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed investment contract- Non-benefit responsive traditional annuity: Valued at fair value based on risk-adjusted discounted cash flow and theoretical transfer (exit value).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value of Level 3 Assets

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

The significance of transfers between levels is evaluated on the nature of the financial instruments and the size of the transfer relative to total net assets available for benefits.

The Plan's Level 3 investments reported purchases of \$13,631, sales of \$289,418, a realized gain of \$79,518, an unrealized loss of \$52,144, an interfund transfer in of \$49,988, and an interfund transfer out of \$5,807 for the year ending December 31, 2024. The interfund transfers are due to participant investment decisions made during the plan year.

NOTE 5: FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Principal Fixed Income Guaranteed Option is a guaranteed general account backed group annuity contract that has been issued by Principal Life Insurance Company (Principal Life) to Principal Trust Company as custodian.

Principal Fixed Income Guaranteed Option is considered a fully benefit-responsive investment contract and is reflected at contract value within the statements of net assets available for benefits. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals. The rate credited to participant accounts is a composite weighted average of underlying guarantees provided in the contract. The crediting rate is reset every 6 months based on the changing weighted average of the underlying guarantees and applies prospectively. The crediting rate on December 31, 2024, was 4.75% and on December 31, 2023 was 4.65%. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the fully benefit-responsive annuity contract at contract value. The contract value of the investment contract on December 31, 2024 and 2023 was \$59,068 and \$67,807, respectively.

NOTE 6: TAX STATUS

The Plan operated under a prototype plan document sponsored by Principal. The prototype plan document is intended to conform to and qualify under Section 403(b) of the IRC. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity Management Trust Company. Any purchases and sales of these funds are performed in the open market at fair value. Administrative expenses paid by the Plan to Fidelity Management Trust Company for the year ended December 31, 2024 amounted to \$1,115. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Certain Plan investments held by Principal, Fidelity Management Trust Company, and TIAA report eligible indirect compensation (EIC) which includes fee or expense payments charged to investment funds and reflected in the value of the investment or return on investment of the Plan. Such transactions are agreed to by the Plan Sponsor in the custodial agreement and are not considered to be paid by the Plan assets. The expense ratio charged to investment funds held by Principal for the year ended December 31, 2024 ranged from 0.02% to 0.99% based on an estimated annualized formula. The expense ratio charged to investment funds held by Fidelity Management Trust Company for the year ended December 31, 2024 ranged from 0.02% to 1.03% based on an estimated annualized formula. Fees or expense payments charged to investment funds held by TIAA for the year ended December 31, 2024 amounted to \$12,168.

The Plan Sponsor enters into other transactions for professional and legal services related to the Plan. Such transactions are paid directly by the Plan Sponsor and are not paid by Plan assets.

NOTE 8: PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right, under the Plan, to change, amend, or discontinue the Plan at any time, subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as provided by the Plan document.
