Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of CB Nichols Egg Ranch 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Note 1: Description of the Plan

The following description of the CB Nichols Egg Ranch 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

C.B. Nichols Egg Ranch, Inc., Chino Valley Ranchers, Inc., Idalou Egg Ranch, LP, and MCM Poultry Farm, a division of C.B. Nichols Egg Ranch, Inc. (collectively the Company) established the Plan effective January 1, 2008.

The Plan is a defined contribution plan covering all employees of the Company who are at least 21 years of age and have completed one year of eligible service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Plan participants can elect to defer part of their earnings on a pre-tax or after-tax basis. Each year, participants may contribute for the years ended December 31, 2024 and 2023, up to \$23,000 and \$22,500, respectively, of pre-tax annual compensation. In addition, participants may not have total contributions of more than \$69,000 for the year ended December 31, 2024 and \$66,000 for the year ended December 31, 2023, or an amount more than 100% of their compensation, whichever is less, allocated to the Plan for their benefit each year. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes a provision for an auto-enrollment feature beginning at 1% with annual increases of 1% thereafter, up to 3%. Participants can decline enrollment by filing a Retirement Plan Decline Enrollment Form.

The Plan is a safe-harbor matching contribution plan. To be eligible for the safe-harbor matching contributions, employees must be at least 21 years of age and have completed one year of eligible service during the plan year.

Contributions (continued)

The Company contributes 100% of the participant's contribution on the first 3% of eligible earnings and 50% of the next 2% of eligible earnings. Matching contributions are allocated to investments per the participant's direction.

The Plan also allows for a discretionary profit-sharing contribution. To be eligible for the discretionary profit-sharing contributions, employees must meet the criteria of 21 years of age and one year of eligible service in the plan year. For the years ended December 31, 2024 and 2023, the Company did not make profit-sharing contributions.

Participant Accounts

Each participant's account is created with the participant's contributions plus an allocation of the Company's contributions and Plan's earnings. The Plan's earnings and investment expenses are allocated according to the participant's relative account balance in the investment options. Certain participant fees, if applicable, are also charged to participant accounts.

Vesting

Participants are immediately vested in their contributions, safe-harbor matching contributions, and rollover contributions plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contribution portion of their accounts is based on years of continuous service and is outlined as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a maximum equal to \$50,000 or 50% of their vested account balance, whichever is less. The minimum loan amount is \$1,000 and participants are permitted to have one loan at a time. The loans are secured by the balance in the participant's account and bear interest at prime rate as published in the Wall Street Journal plus one percentage point. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant or beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a single-sum cash payment or have it rolled over into an individual retirement account (IRA) or another qualified plan that accepts transfers.

Hardship Withdrawals

The Plan allows for hardship distributions in accordance with IRS regulations. A participant may withdraw any part of their vested account in the event of undue financial hardship.

Forfeited Accounts

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan, per the vesting schedule. These forfeited amounts are used to reduce the Company's discretionary matching contributions or plan expenses. For the years ended December 31, 2024 and 2023, the Plan's participants forfeited \$46 and \$214, respectively. For the years ended December 31, 2024 and 2023, forfeited nonvested amounts totaling \$107 and \$158, respectively, were used to pay for plan expenses. Forfeitures available for plan use as of December 31, 2024 and 2023 are \$0 and \$61, respectively.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan is treated as distributed based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the plan sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distribution fees are charged directly to the participant's account and are included in the administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

Note 3: Investments (Unaudited)

The December 31, 2024 and 2023 statements of net assets available for benefits, the investment activities included in the statements of changes in net assets available for benefits for the years then ended, and the accompanying notes and supplemental schedule to the financial statements, were prepared in part or entirely from information certified by the trustee, Ascensus Trust Company, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

The information certified includes total investments of \$13,914,094 and \$12,151,165 as of December 31, 2024 and 2023, respectively.

The Plan's investments are held in trust by Ascensus Trust Company as of December 31, 2024 and 2023. All investments held by Ascensus Trust Company are participant directed.

The Plan's investments (including investments bought, sold and held during the year) appreciated in value by \$1,036,137 and \$1,346,203 for the years ended December 31, 2024 and 2023, respectively. Interest income from the Plan's investments for the years ended December 31, 2024 and 2023, is \$14,364 and \$12,104, respectively. Dividend income from the Plan's investments for the years ended December 31, 2024 and 2023, is \$334,298 and \$284,053, respectively.

Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There has been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at the market value of shares held by the Plan at year end. Money market funds keep their net asset value constant at \$1.00 per share for fair market value. Their yield changes based on the earnings they derive from investments.

The preceding methods described may produce a fair value calculation that may not be indicative of Net Realizable Value (NRV) or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, benefits provided under this Plan are neither insured nor guaranteed by the Company, by the Pension Benefit Guaranty Corporation, a federal governmental agency, nor under any state or federal law.

Note 7: Tax Status

The prototype plan obtained a determination letter on June 30, 2020, which the Internal Revenue Service stated that the prototype plan is qualified under section 401(a) of the Internal Revenue code (the Code). Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified, and the related trust was tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

Note 8: Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9: Related Party and Party in Interest Transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. The Plan issues notes to participants which are secured by the balances in the participants' accounts, therefore these transactions qualify as party in interest transactions for which a statutory exception exemption exists.

Certain plan investments are mutual funds and money market funds that are issued by the Vanguard Group, Inc., the Plan's third-party administrator. These transactions qualify as party in interest transactions for which a statutory exception exemption exists.

Certain administrative fees related to the administration of the Plan were paid by the Plan. Fees paid to the Vanguard Group, Inc., the Plan's third-party administrator, for the years ended December 31, 2024 and 2023, amounted to \$34,015 and \$32,595, respectively. Fees paid to Pacific Capital Co., the Plan's investment advisors, for the years ended December 31, 2024 and 2023, amounted to \$38,405 and \$31,166, respectively. These transactions qualify as party in interest transactions for which a statutory exception exemption exists.

Note 10: Operational Defects

During the year ended December 31, 2024, it was discovered that the plan sponsor made an administrative error in which the auto-enrollment of several affected participants was not placed into effect. The plan sponsor determined the participants affected by this error and prior to the date the financial statements were available to be issued, made corrective employer contributions to make the affected participants and the Plan whole. For the auto-enrollment failure stemming from the plan years ended December 31, 2024 and 2023, the plan sponsor contributed \$20,993 and \$3,134, respectively, in employer matching contributions and qualified non-elective contributions, which are included with employer corrective contributions receivable as of December 31, 2024. In addition, lost earnings amounts for the affected plan years ended December 31, 2024 and 2023 of \$1,439 and \$539, respectively, were contributed by the plan sponsor to the affected participants. Such corrective contributions were received by the Plan as of the date the financial statements were available to be issued.

Subsequent to December 31, 2024, it was discovered that the plan sponsor made an administrative error in which the auto-enrollment of one participant was placed into effect in an untimely manner. The plan sponsor determined the affected period during the year ended December 31, 2024, in which the participant should have been enrolled. As a response, the plan sponsor will make employer matching contributions and qualified non-elective contributions with the applicable lost earning to the affected participant's account to make the participant and the Plan whole.

Note 11: Prohibited Transactions

During the year ended December 31, 2024, it was discovered that the plan sponsor, in one instance, failed to remit participant contributions of \$467 to the respective participant accounts within the period prescribed by the Department of Labor regulations due to an administrative error. The plan administrator identified the affected participants and on August 18, 2025, made the necessary corrections, including the deposit of lost earnings amounting to \$2, to make the participants and the Plan whole.

Note 12: Subsequent Events

The Plan has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued.

Effective February 6, 2025, the Plan was amended to increase its cashout level for terminated participants from \$1,000 to \$5,000. The cashout level was subsequently increased to \$7,000 as permitted by the SECURE 2.0 Act.
