### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of CPS Puerto Rico, Inc. 1165(e) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits (modified cash basis) as of December 31, 2024, and the related statement of changes in net assets available for benefits (modified cash basis) for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ## **NOTE 1 - Description of the Plan**

---

The following description of the CPS Puerto Rico, Inc. 1165(e) Plan ("the Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### *General*

The Plan is a defined contribution plan sponsored by CPS Puerto Rico, Inc. ("the Company") under the laws of Puerto Rico. Employees who are age twenty-one or older (excluding leased and nonresidents of Puerto Rico) are eligible for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA) and Section 1081.01 of the Puerto Rico Internal Revenue Code (PR Code). Banco Popular De Puerto Rico is the trustee of the Plan ("the Trustee") and State Street Bank and Trust Company is the custodian of the Plan ("the Custodian").

Effective February 21, 2024, the Company delegated its rights and responsibilities as plan administrator, except with respect to plan investments, to the UnitedHealth Group Employee Benefits Plans Administrative Committee ("Plan Administrator"). The Company delegated its rights and responsibilities for investment authority and oversight of the Plan's assets to the UnitedHealth Group Employee Benefits Plans Investment Committee ("Investment Committee"). The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

### *Contributions*

Each year, participants may contribute an amount up to the maximum dollar amount permissible under the PR Code. Participant contributions include pre-tax deferrals, after-tax deferrals, and rollover contributions. Eligible employees are automatically enrolled in the Plan as soon as administratively feasible after satisfying eligibility requirements at an employee pre-tax contribution rate of 3% of their eligible pay, unless they opt out within a prescribed time limit or elect a different pre-tax contribution rate. Participants who have attained age 50 before the end of the plan year may make additional catch-up contributions, subject to limitations imposed by the PR Code.

The Company makes a matching contribution equal to 100% of applicable contributions up to 3% of eligible compensation, plus 50% of the next 2% of eligible compensation for a maximum contribution of 4% per payroll period as defined in the Plan document. All participants are eligible to receive matching contributions. The Company may also make a discretionary profit-sharing contribution to be distributed among eligible participants pro rata based upon eligible compensation within limitations as determined by the PR Code. Participants who have completed 1,000 hours of service and are employed on the last day of the plan year are eligible for discretionary profit-sharing contributions to the Plan. There were no discretionary profit-sharing contributions made by the Company for the year ended December 31, 2024.

### *Participant Accounts*

Each participant's account is credited with the participant's deferral contributions, rollover contributions, the Company's matching contributions, discretionary profit-sharing contributions, if any, and pro-rata allocation of plan's earnings or losses (net of administrative expenses). Allocations are based on the participant's eligible compensation or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Investments Classification*

All investments are participant directed. The Plan is intended to comply with ERISA section 404(c). Participants have the right to individually select the percentage of their accounts to be invested among different classifications of investments made available to them.

#### *Vesting*

Participants are immediately vested in their salary deferral contributions, rollover contributions, employer matching contributions, discretionary profit-sharing contributions, if any, and earnings thereon.

#### *Payment of Benefits*

Benefits may be paid to the participant or beneficiary upon death, disability, retirement, or termination of employment as defined in the Plan document. The total vested portion of a participant's account balance may be distributed in the form of a lump-sum or periodic installments. Participants may withdraw all or part of their employee and employer contributions in the event of financial hardship.

There are no amounts owed to participants who had elected to withdraw from the Plan, but had not been paid as of December 31, 2024 and 2023.

#### *Notes Receivable from Participants*

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 (subject to reduction for certain loan balances in the prior 12 months) or 50% of their vested account balances. These loans are secured by the balance in the participant's account and bear interest based on the Prime Rate. Any changes in the Prime Rate shall be reflected on the following business day. The maximum term for a loan is 60 months, except if the loan is used to acquire the participant's principal residence, in which case the term of the loan may not exceed 120 months. Principal and interest are paid ratably through payroll deductions. Participants are permitted to have one outstanding loan at a time.

---

### **NOTE 2 - Summary of Significant Accounting Policies**

---

#### *Basis of Accounting*

The accompanying financial statements have been prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America and is an acceptable method under ERISA. Under the modified cash basis of accounting, the Plan records administrative expenses and interest and dividend income on a cash basis, and purchases and sales of investments on a trade date basis. Had the Plan prepared the accompanying financial statements on the accrual basis of accounting, the Plan would have recorded an adjustment for the aforementioned items in an amount insignificant to the overall financial position of the Plan.

#### *Use of Estimates*

The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded when received. Net appreciation in fair value of investments includes the gains and losses on investments bought and sold as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

#### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### **NOTE 4 - Fair Value of Financial Instruments**

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Unadjusted quoted prices for identical assets in active markets that the Plan can access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs for the asset.

### **NOTE 4 - Fair Value of Financial Instruments (cont.)**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Common collective trusts:* Valued at the net asset value ("NAV") of units held. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay the withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Mutual funds:* Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### **NOTE 5 - Related Party and Party-in-interest Transactions**

---

Certain of the Plan's investments are managed by the Custodian and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation in fair value of investments. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as exempt party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

---

### **NOTE 6 - Plan Termination**

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. As discussed in Note 1, participants are 100% vested in their accounts.

---

### **NOTE 7 - Tax Status**

---

The Plan is maintained on a master plan document sponsored by the Trustee. The Puerto Rico Treasury Department ("PR Treasury") has determined and informed the Trustee by a letter dated September 6, 2013, that the master plan document and the related trust are designed in accordance with the applicable sections of the PR Code, as amended. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and being operated in compliance with the applicable provisions of the PR Code, and therefore believe the Plan is qualified and the related trust is tax exempt.

The modified cash basis of accounting requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the PR Treasury. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

---

### **NOTE 8 - Risks and Uncertainties**

---

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits (Modified Cash Basis).

As of December 31, 2024 and 2023, the Plan had investments of \$4,888,554 and \$5,020,174, respectively, concentrated in four investments that each accounted for more than 10% of plan investments.
