## **Independent Auditors' Report**

To the Plan Administrator of the  
Certus Pest, Inc. 401(k) Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of Certus Pest, Inc. 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

## Notes to Financial Statements

December 31, 2024 and 2023

### (1) Description of Plan

The following description of the Certus Pest, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the plan administrator.

#### (a) General

The Plan is a defined contribution plan sponsored by Certus Pest, Inc. (the “Company”) for the benefit of all of its employees who have at least 3 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On December 7, 2023, the Company signed an adoption agreement to change the recordkeeper and custodian of the Plan from ADP Retirement Services to Principal Life Insurance Company effective January 1, 2024. ADP Retirement Services liquidated all investments prior to December 31, 2023 and moved the funds into a non-interest bearing cash account in preparation for the transfer of assets that occurred after January 1, 2024.

The Company acquired Donovan’s Pest Control in 2021. During 2024, participant accounts and loans totaling approximately \$184,000 were transferred from the Donovan’s Pest Control 401(k) Plan to the Plan and is included in plan transfers on the statement of changes in net assets available for benefits.

#### (b) Contributions

Each year, participants may contribute up to 90% of annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. Prior to January 1, 2024 the Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The automatic deferral percentage will increase by 1% per year up to a maximum of 10% of eligible compensation. The Company contributes 100% of the first 4% of base compensation that a participant contributes to the Plan. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

#### (c) Participant Investment Account Options

The Plan currently offers various mutual funds, a pooled separate account and common collective trusts as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

#### (1) Description of Plan - Continued

##### (d) Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company matching contributions and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### (e) Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in their employer matching contributions due to the Plan electing for Safe Harbor contributions.

##### (f) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Participant note interest rates ranged from 5.25% - 10.5% as of December 31, 2024. Principal and interest are paid ratably through payroll deductions. Loan terms range from 1 year to 5 years unless used to purchase a principal residence.

##### (g) Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

#### (2) Summary of Significant Accounting Policies

##### (a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

##### (b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### Notes to Financial Statements - Continued

#### (2) Summary of Significant Accounting Policies - Continued

##### (c) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### (d) Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

##### (e) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

##### (f) Payment of Benefits

Benefits are recorded when paid.

##### (g) Administrative Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

#### (3) Information Prepared and Certified by the Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee & Trust Company, d/b/a Principal Trust Company, the Plan's trustee, has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate with respect to investments:

- Investments at fair value
- Notes receivable from participants
- Net appreciation in fair value of investments

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

#### (4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Common Collective Trusts:* Valued at the net asset value ("NAV") as determined by the trustee of each investment. The NAV, as provided by the trustees, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily.

#### (4) Fair Value Measurements - Continued

*Stable Value Common Collective Trust:* Valued at the net asset value (“NAV”) as determined by the trustee. The NAV, as provided by the trustees, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Pooled Separate Account:* Valued based upon the net asset value of shares held by the Plan at year-end and are classified as Level 2 investments. The unit value for each separate account investment is based on the underlying assets, which include a mix of common stocks. All underlying investment options are valued each day the principal market is open.

The plan did not hold any investments as of December 31, 2023. The following tables set forth by level, within the fair value hierarchy, the Plan’s investments at fair value as of December 31, 2024:

#### (5) Related Party Transactions and Party-in-Interest Transactions

As described in Note 2, the Plan made direct payments to Principal for recordkeeping services of approximately \$86,000 for the year ended December 31, 2024. Notes receivable from participants transactions are also considered to be party-in-interest transactions, because they are transacted with plan participants. While these transactions qualify as party-in interest transactions as defined in Section 3(14) of ERISA, they are expressly exempted from the prohibited transaction rules.

#### (6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**(7) Tax Status**

Prior to January 1, 2024, the Plan adopted a pre-approved plan provided by ADP. The Internal Revenue Service (“IRS”) determined that the pre-approved plan was designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”) and informed ADP of such in a letter dated October 6, 2020. Although the Plan had been amended since receiving the opinion letter, the plan administrator believes that the Plan and related trust was designed and operated in compliance with the applicable requirements of the Internal Revenue Code.

Effective January 1, 2024, the Company adopted a pre-approved plan document provided by Principal Life Insurance Company that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(9) Risks, Uncertainties and Concentrations**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**(10) Delinquent Participant Contributions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. The Company remitted delinquent contributions of \$146,108 for the year ended December 31, 2024, in the same year. While the Company has remitted the principal amount of these delinquent contributions, as of December 31, 2024, the Company was still in the process of remitting the lost earnings owed to the Plan as a result.

**(11) Subsequent Events**

The Plan has evaluated subsequent events through September 16, 2025, which is the date the financial statements were available to be issued.
