### **NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Rani Therapeutics 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### General

The Plan was established on April 1, 2022 by Rani Therapeutics (the “Company” or “Employer”) to provide benefits to eligible employees as defined in the Plan document. The Plan allows participation of the eligible employees of Rani Management Services, Inc. and Rani Therapeutics, LLC. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (“IRC”), and the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

#### Administration

The Company has appointed a Plan Administrator to manage the operation and administration of the Plan. The Company has contracted with Fidelity Management Trust Company (“Fidelity”) to act as the trustee and custodian, and Fidelity Workplace Services as the recordkeeper and third-party administrator. The Company has contracted Glaze Siddiqi Group to act as their investment advisors. The 401(k) Plan Committee provides fiduciary oversight and reviews investment performance.

#### Eligibility

Employees of the Company who are over the age of 18 are eligible to participate in the Plan. The Plan excludes any employees who are part of a collectively bargained unit, non-resident aliens who receive no compensation from the Employer which constitutes U.S. source income and leased employees.

#### Participant Contributions

The Plan includes an automatic enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan thirty-five days after their date of hire unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of the participants’ eligible pre-tax compensation with their contributions invested in a designated balanced fund until changed by the participant. The deferral rate increases 1% each year automatically unless the employees elect a different rate. Participants can contribute 100% of their pre-tax compensation up to the IRS limits. Participants are also allowed to contribute their eligible Roth after-tax compensation to the Plan up to the amount allowable under the Plan document and current income tax regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants can make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans.

#### **NOTE 1 – DESCRIPTION OF THE PLAN (Continued)**

##### Employer Contributions

The Company may make discretionary Employer contributions and discretionary matching contributions to the Plan. There were no discretionary Employer contributions or discretionary matching contributions made for the year ended December 31, 2024.

##### Vesting

Participants are immediately vested in their contributions, including actual earnings thereon, and are subject to a 6-year cliff vesting period before they become 100% vested in any discretionary Employer contributions and discretionary matching contributions.

##### Forfeited Accounts

Forfeited non-vested accounts may be utilized to pay Plan expenses and/or used to reduce Employer matching contributions under the Plan or used to restore previously forfeited accounts. Forfeitures shall be used in accordance with the terms of the Plan no later than the end of the Plan year following the Plan year in which the forfeiture occurs. The balance of forfeited accounts was \$209 and \$178 as of December 31, 2024 and 2023, respectively.

##### Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, Employer contributions (if any), rollovers and allocations of the Plan's earnings and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Investment Options

Participants direct their salary deferral contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options any time throughout the year via the Internet website or by using the automated telephone system offered by the trustee.

##### Payment of Benefits

Upon termination of employment, death or disability, the participants or beneficiaries may elect to leave their account balance in the Plan or receive their total benefits in a lump-sum amount equal to the value of the participant's vested interest in their account. The Plan allows for the automatic distribution of participant account balances under \$1,000. Additionally, the Plan allows for an automatic rollover provision for any balances between \$1,000 and \$5,000 into an Individual Retirement Account.

##### Financial Hardship Distributions

The Plan allows hardship withdrawals in accordance with Internal Revenue Service ("IRS") regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes.

### NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Participants may not have more than one loan outstanding at any time. The notes are secured by the participant's account balance. Notes receivable from participants bear a reasonable rate of interest as determined by the Plan Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The interest rate shall remain fixed throughout the duration of the loans. Notes receivable from participants must be repaid to the Plan within a five-year period, unless the note is used for the purchase of a principal residence, in which case the maximum repayment period may be longer. The specific terms and conditions of such notes are established by the Company. Outstanding notes receivable from participants at December 31, 2024 and 2023, carried interest rates ranging from 4.25% to 9.5%, and mature through 2029.

#### Administrative Expenses

The Company currently pays for most of the Plan's expenses. Expenses that are paid by the Company are excluded from these financial statements. Plan expenses not paid by the Company, will be charged on a pro-rata basis to the value of the participants account balances.

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments in interest bearing cash and registered investment companies are stated at fair value. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

#### Investment Valuation and Income Recognition (Continued)

Management fees charged to the Plan for investments in registered investment companies are based on assets invested and are deducted on a daily basis. Management fees are reflected as a reduction of investment return for such investments.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document. There were no delinquent notes receivable from participants as of December 31, 2024 and 2023. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### Benefit Payments

Benefit payments are recorded when paid.

### NOTE 3 – INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee and custodian, has certified the completeness and accuracy of:

- Investments and notes receivable from participants reflected in the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, dividend and interest income and interest income on notes receivable from participants reflected in the statement of changes in net assets available for plan benefits for the year ended December 31, 2024;
- Assets reflected in the supplemental Schedule H, line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024;

### NOTE 4 – FAIR VALUE MEASUREMENTS

FASB ASC Topic No. 820, "*Fair Value Measurements and Disclosures*" ("ASC 820"), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

#### NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)

The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted, quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets,
- Quoted prices for identical or similar assets or liabilities in inactive markets,
- Inputs other than quoted prices that are observable for the asset or liability and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of valuation methodologies used for assets measured at fair value.

#### *Interest bearing cash*

Valued at the carrying value, which approximates fair value due to the short-term nature of such investments.

#### *Registered investment companies (mutual funds)*

Valued at the daily closing price as reported by the fund. Mutual funds invested in by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – FEDERAL INCOME TAX STATUS**

The Plan has adopted a volume submitter plan sponsored by Fidelity Management & Research Co. The volume submitter plan provider has received an opinion letter from the Internal Revenue Service as to the volume submitter plan’s qualified status. The volume submitter plan opinion letter has been relied upon by the Plan. The Plan has been amended since the volume submitter plan received the advisory letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability, asset, or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by Fidelity Investments, a related party to Fidelity Management Trust Company, the trustee and custodian of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. The Plan also holds notes receivables from participants. These transactions qualify as party-in-interest transactions.

#### **NOTE 7 – RISK AND UNCERTAINTIES**

The Plan provides for various fund investment options in which participants can invest in a combination of interest-bearing cash and registered investment companies. Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Plan Benefits.

#### **NOTE 8 – PLAN TERMINATION OR MODIFICATION**

The Company intends to continue the Plan indefinitely for the benefit of its participants; however, it reserves the right to terminate or modify the Plan at any time by resolution of its Board of Directors and is subject to the provisions of ERISA. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination shall become 100% vested. Net assets available for Plan benefits would be distributed to the participants based on each participant's interest in the Plan.

#### **NOTE 9 – NON-EXEMPT TRANSACTIONS**

During the Plan year ended December 31, 2023, the Plan sponsor failed to deposit \$1,245 of participants' contributions and notes receivable repayments within the required timeframe as stated by the United States Department of Labor's regulations. The delay in remitting the contributions to the custodian was caused by administrative errors. The Company deposited the lost earnings into the affected participant's account in 2024 to correct the error outside of the VFCP.

The delay in remitting the contributions to the custodian was caused by administrative errors. The Company will deposit the lost earnings into the affected participant's account in 2025 to correct the error outside of the VFCP.
