## Notes to Financial Statements

December 31, 2024

### 1. Description of Plan

The following description of the Potpourri Group, Inc. 401(k) Retirement and Savings Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description and the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan, established July 1, 1989, and most recently amended and restated October 1, 2022, is a defined contribution plan covering all eligible employees age 18 and older of Potpourri Group, Inc. and subsidiaries (the Company) who have met the service requirement of six months of service effective October 1, 2022. Employees enter the Plan on the first day of the month following completion of the eligibility requirements.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions and Funding

Each year, participants may contribute up to 100% of their respective pretax annual compensation, subject to limitations established by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan offers three guaranteed investment contracts and various pooled separate accounts as investment options for participants.

Effective June 25, 2025, the Plan also permits Roth elective deferrals. Roth elective deferrals shall be treated in the same manner as participant elective deferrals, except that Roth elective deferrals are not "pre-tax" deferrals as defined in the Code.

The Company matching contribution is discretionary. The Company quarterly discretionary matching contribution is 50% of the first 6% of eligible compensation that a participant contributes to the Plan for the years ended December 31, 2024 and 2023.

## Notes to Financial Statements (continued)

### 1. Description of Plan (continued)

#### Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution, Plan earnings (losses), and charged with applicable loan and/or withdrawal charges. Allocations are based on participant salary deferrals or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution and discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 20% vested after one year of credited service, 40% after two years, 60% after three years, 80% after four years, and is 100% vested after the completion of five years of credited service.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. One loan per participant can be outstanding at any time, unless more than one loan is rolled over from another qualified plan. Loan terms range from 1-5 years or up to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participants' account and bear interest at the prime rate plus 2%. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

Upon separation of employment due to termination, death, disability or retirement, a participant may receive the value of the vested interest in his or her account as a lump-sum amount or a partial distribution, as defined. Prior to termination of employment, a participant can withdraw their deferred compensation balance in the event of certain hardship circumstances or upon reaching 59 1/2 years of age.

## Notes to Financial Statements (continued)

### 1. Description of Plan (continued)

#### Forfeited Accounts

Participants who leave the employment of the Company forfeit the nonvested portion of their accounts. Forfeitures are used to offset future Company contributions to the Plan. At December 31, 2024 and 2023, forfeitures available totaled \$1,203 and \$7,447, respectively. Forfeitures used to reduce employer contributions during the years ended December 31, 2024 and 2023 amounted to \$5,884 and \$14,767, respectively.

#### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### 2. Summary of Accounting Policies

#### Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for the management of investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, certain management fees and operating expenses are reflected as a reduction of investment return for such investments.

## Notes to Financial Statements (continued)

### 2. Summary of Accounting Policies (continued)

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

#### Administrative Expenses/Revenue Credit

Effective October 1, 2022, the Plan entered into a fixed pricing with Fidelity Workplace Services, LLC for recordkeeping services. The fee is fixed at \$21.25 per participant per quarter for all active participant accounts greater than \$1,000. The recordkeeping fees paid to Fidelity for the years ended December 31, 2024 and 2023 was \$23,721 and \$25,288, respectively.

In addition, excess revenue generated from the various mutual fund investments above this amount is credited to participant accounts and/or added to the ERISA budget account. The ERISA budget account can be used to cover plan expenses, such as auditing, legal and consultant fees as outlined in the amendment. These amounts are not available to reduce Company contributions. The amount of excess revenue allocated to participant accounts was \$4,432 and \$3,930, respectively, for the years ended December 31, 2024 and 2023. The amount added to the ERISA budget account was \$3,726 and \$2,245, respectively, for the years ended December 31, 2024 and 2023. The balance in the ERISA budget account at December 31, 2024 and 2023 was \$6,259 and \$2,296, respectively.

There is also an annual investment advisor fee of \$30,000 and a third-party administration fee of \$15,000, which is deducted per capita on a quarterly basis from all active participant accounts greater than \$1,000. Investment advisor and third-party administration fees of \$44,995 and \$44,993 were charged to participant accounts for the years ended December 31, 2024 and 2023, respectively.

Certain other administrative expenses such as participant loan processing fees and other participant specific fees are deducted directly from participant accounts. Participant specific fees of \$3,700 and \$3,169, were charged to participant accounts for the years ended December 31, 2024 and 2023, respectively.

The total amounts deducted from participant accounts in 2024 and 2023 amounted to \$64,258 and \$67,275, respectively.

#### Return of Excess Contribution

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability. The Plan distributed the excess contribution from the applicable participants' accounts prior to March 15, 2025 and 2024, respectively.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of mutual funds, interest, dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

### 4. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

The following is a description of the valuation methodologies used by the Plan. There have been no changes in the valuation methodologies at December 31, 2024 and 2023.

*Mutual funds* are valued daily at the closing price per share, as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The valuation methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All mutual fund investments held at December 31, 2024 and 2023 are Level 1 within the fair value hierarchy.

#### **5. Investment Contract with Insurance Company**

The Plan entered into an unallocated group annuity contract effective October 1, 2022 (contract) with The Lincoln National Life Insurance Company (Lincoln). Lincoln maintains the contributions in a separate account. This contract meets the fully benefit responsive investment contract criteria and therefore is reported at contract value. Contract value is the relative measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the contract. Contract value, as reported by Lincoln to Fidelity, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than one percent before investment expenses. Such interest rates are reviewed and reset on a quarterly basis. The average interest rate for the years ended December 31, 2024 and 2023 was 2.45% and 2.50%, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events, as defined in the contract, include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) participant-initiated withdrawal to a competing fund amongst other restrictions.

In the event of a discontinuance of the contract with Lincoln, the contract may be paid in six annual installments over five years. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

#### **6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **7. Income Tax Status**

The Plan has adopted the non-standardized pre-approved profit-sharing plan of Fidelity Management & Research LLC. The non-standardized pre-approved profit-sharing plan sponsor received an advisory letter from the IRS dated June 30, 2020 in which the Internal Revenue Service stated that the form of the non-standardized pre-approved profit sharing plan was in compliance with the applicable requirements of the Internal Revenue Code (Code). Although the Plan has been amended since receiving the advisory letter, the plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting standards require recording uncertain income tax positions that exist in the Plan's financial statements. Plan management has determined there are no uncertain tax positions and believes there is no adjustment or disclosure required in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. Parties-In-Interest**

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, notes receivable from participants and the management of investments held by the trustee and custodian are considered party-in-interest transactions.

Certain plan investments are shares of mutual funds managed by an affiliate of Fidelity Management Trust Company, the plan trustee. In addition, Fidelity Workplace Services, LLC is the plan recordkeeper and, therefore, these transactions qualify as party-in-interest transactions. These investments and transactions are considered to be party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.
