## INDEPENDENT AUDITORS' REPORT

To the 401(k) Committee of Wescast Industries, Inc. 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Wescast Industries, Inc. 401(k) Plan ("the Plan"), an employee benefit Plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

NOTES TO FINANCIAL STATEMENTS

**NOTE A - Description of Plan:**

The following brief description of the Wescast Industries, Inc. 401(k) Plan ("the Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

1. **General** - The Plan is a defined contribution Plan covering substantially all employees of United Machining Inc. and Wescast Holdings USA, Inc. ("Company") who are age twenty-one or older and who have six months of service. Collectively bargained, leased and contract employees are not eligible. Entry dates are the first of the month coinciding with or following eligibility requirements being met. The Plan has a safe harbor matching contribution. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is currently provided as a pre-approved plan by ADP, LLC.
2. **Contributions** - Eligible employee participants may authorize the Company to withhold from 1% to 90% of their compensation, as defined in the Plan, as a pre-tax elective deferral contribution. Eligible participants may also make after-tax Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from another retirement plan. Segregated accounts are maintained for each participant. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers 17 mutual funds and 5 collective investment trusts as investment options for participants. The Plan includes an automatic salary deferral feature. After meeting the eligibility requirements, 2% of an employee's pay will be automatically withheld unless the employee elects out. The Company provides an employer safe harbor matching contribution of 100% of the first 6% of base compensation that a participant contributed to the Plan. The employer may make matching contributions or profit sharing on a discretionary basis. There were no discretionary employer contributions for 2024. Contributions are subject to certain limitations.
3. **Participant Accounts** - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. **Vesting** - Participants are immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon. Accounts funded by the employer's safe harbor matching are 100% vested. Vesting in the portion of their accounts funded by discretionary employer's matching and profit sharing contributions plus earnings thereon is based on years of continuous service according to the following schedule. An employee's vesting percentage increases to 100% if, while employed, the employee dies or becomes disabled.

**NOTE A - Description of Plan (continued):**

5. Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of 4.50% to 9.50%, which is commensurate with local prevailing rates as determined by the Trustee. Only one loan may be outstanding at a time. As of December 31, 2024 and 2023, the balances of outstanding loans were \$114,831 and \$105,890, respectively. Principal and interest is paid ratably through monthly payroll deductions.
6. Forfeited Accounts - At December 31, 2024 and 2023, forfeited unallocated accounts totaled \$2,790 and \$242, respectively. These accounts may be used at the employer's discretion to reduce employer fees and future employer contributions. In 2024, employer contributions were reduced by none.
7. Payment of Benefits - On termination of service due to any reason, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in partial withdrawals for certain distributions. If a participant's vested account balance is \$5,000 or less, the vested account balance is automatically paid out to a participant on termination, or for vested accounts greater than \$1,000, rolled into an IRA account for the participant. In addition, in-service distributions are permitted if the individual is at least 59 ½ years of age or cites a financial hardship as defined by the Plan.

**NOTE B - Summary of Significant Accounting Policies:**

1. Basis of Accounting - The financial statements of the Plan are maintained on the accrual basis.
2. Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.
3. Investments Valuation – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements. Participant loans are valued at their outstanding balances, which approximate fair value.

On each Statement Date, a proportionate share of the investment earnings (or losses, if any) of a participant's selected investment funds will be allocated to their account(s).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

4. Administrative Expenses - Certain administrative expenses of the Plan are paid directly by the Company, and are therefore excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

**NOTE B - Summary of Significant Accounting Policies (continued):**

5. Uses of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.
6. Payment of Benefits - Benefits are recorded when paid.
7. Subsequent Events - Subsequent events were evaluated through September 3, 2025, which is the date the financial statements were available to be issued.

**NOTE C - Fair Value Measurements:**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the period presented.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts: The fair value of collective investment trusts for which quoted market prices are not available are based on the underlying securities less its liabilities. The investments are measured at fair value using net asset value per share (or its equivalent) as a practical expedient; and therefore is not categorized in the fair value hierarchy.

The preceding method used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - Tax Status:**

ADP, LLC, the pre-approved Plan provider for the Plan, obtained an opinion letter dated October 6, 2020, in which the IRS stated that the restated pre-approved Plan documents were in compliance with applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related Trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE F - Information Certified by Custodian/Trustee:**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Reliance Trust Company, the trustee of the Plan has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and December 31, 2023, and the Supplemental Schedule H, line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

**NOTE G - Related-Party/Party-In-Interest Transactions:**

Certain Plan investments included in the investment contract are managed by Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan. ADP, Inc. is the Plan's third-party administrator/recordkeeper. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the administrative services amount to \$15,351 for the year ended December 31, 2024.

Secure Asset Management, LLC is the Plan's investment advisor. Fees paid by the Plan for investment advisory services amount to \$18,547 for the year ended December 31, 2024.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE H - Risks and Uncertainties:**

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.
