Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Devs Foods, LLC 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets (modified cash basis) available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Devs Foods, LLC 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Devs Foods, LLC 401(K) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Devs Foods, LLC 401(K) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

1. Description of Plan

The following description of the Devs Foods, LLC 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Devs Foods, LLC, Airmont Rest NY, LLC, Bethel Rest 3189, LLC, Brookfield Rest 14, LLC, Chester Rest NY, LLC, Closter Rest 1165, LLC, Danbury Rest 1101, LLC, Danbury Rest 3614, LLC, Devs Foods 2, LLC, Devs Foods 3, LLC, Devs Foods 4, LLC, Franklin Rest 2011, LLC, Goshen Rest 3282, LLC, Highland Rest, 3551 LLC, Liberty Rest 13136, LLC, Lodi Rest 3027, LLC, Middletown Rest 107, LLC, Monroe Rest 2876, LLC, Monticello Rest 14398, LLC, New City Rest 2125, LLC, New Milford Rest 20388, LLC, Newark Rest 730, LLC, NP Rest 5994, LLC, PA Rest 13000, LLC, PA Rest 2471, LLC, Park Ridge Rest 550, LLC, Poughkeepsie Rest NY, LLC, Union City Rest 2660, LLC, Vernon Rest 12267, LLC, Ventnor Rest NJ, LLC, Waldwick Rest 1364, LLC, Ramsey Rest 14020, LLC, and PWY Chicken Rest NJ, LLC (the Company). Employees become eligible to participate for purposes of salary deferrals when they have completed three months of service, are 21 years old, and reach the entry date. The entry date is the first day of the month coinciding with or the next month following the date an employee satisfies the eligibility requirements. The Plan is subject to the provisions of ERISA. The Plan's trustees are responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's trustees.

SECURE Act

The Plan has adopted certain provisions under the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act). The Plan intends to formally execute the required Plan amendments for these provisions by the last day of the Plan year beginning on or after January 1, 2026.

Contributions

Each eligible employee may elect to make pretax contributions by authorizing his or her compensation to be reduced by any percentage up to 90%, not to exceed the current year's statutory limits. Each year participants may contribute up to the maximum allowed under the Internal Revenue Code (the Code), as defined in the Plan. For participants age 50 or older, an additional catch-up contribution is allowed up to limits established by the IRS. Participants may also make after-tax Roth contributions and roll over amounts representing distributions from other qualified defined benefit or contribution plans. Employer matching contributions are contributed for the plan at the option of the Company's Board of Directors. No matching contributions were made during the year ended December 31, 2024.

Employer match contributions to the Plan are made at the discretion of the members of the sponsor. There were no such contributions to the Plan for the year ended December 31, 2024.

Participants' accounts

Each participant's account is credited with the employee's contribution and an allocation of plan earnings and expenses. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

A participant's credited service shall be the number of Plan years in which he or she is credited with at least 1,000 hours of service. Participants are immediately vested in their voluntary contributions to the Plan plus actual earnings thereon. The schedule below determines the vesting percentage for employer contributions:

Less than 1 year	0%
1 year	25%
2 years	50%
3 years	75%
4 years	100%

Participants become fully vested upon attaining their normal retirement date or in the event of death or disability.

Forfeited accounts

Forfeited non-vested accounts are used to reduce the employer's contributions. At December 31, 2024, there were no forfeitures.

Notes receivable from participants

The Plan only allows for loans needed as a result of a financial hardship. Financial hardship means hardship due to immediate and heavy financial need. Federal rules are used in order to determine the qualifications for financial hardship. Loans are limited to the amount needed for the financial hardship. Loans must be paid to a party-in-interest who is a participant or beneficiary. Loans are limited to the lesser of 50% of the vested account balance or \$50,000. The minimum loan is \$1,000 and only one loan may be outstanding at a time. The interest rate will be based on the rates available for similar loans from commercial lending institutions, as determined by the Plan administrator, and will not change once granted. Principal and interest are paid ratably through semi-monthly payroll deductions. The loans are secured by the balance in the participant's account.

Payment of benefits

Upon retirement or termination of service, a participant may elect to receive either a lump sum amount equal to the value of his or her vested account, or annual installments over a fixed reasonable period of time, not exceeding the life expectancy of the participant and his or her spouse. Participants may also withdraw their contributions upon demonstrating hardship or attaining age 59½.

2. Summary of accounting policies

Basis of accounting

These financial statements have been prepared using a modified cash basis of accounting which is a comprehensive basis of accounting other than generally accepted accounting principles. Under the modified cash basis of accounting, other than recognizing unrealized gains and losses on investments, revenue is recognized when received rather than when earned and expenses when paid rather than when incurred. If the financial statements of the Plan were prepared under the accrual basis of accounting, the reported participant contributions would have been \$286,450 as of December 31, 2024.

Use of estimates

The preparation of financial statements requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisors, custodians and insurance company. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Contributions from Plan participants and the matching contributing from the Employer are recorded in the year which the employee contributions are withheld from compensation.

Notes receivable from participants

Note receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Expenses

All administrative expenses shall be paid out of the Plan unless paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Tax status

The IRS has determined and informed the Company by a letter dated May 1, 2021, that the Plan and related trust are designated in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore believe that the Plan is qualified, and the related trust is tax-exempt.

3. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

4. Certified investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

5. Investment contract with insurance company

The Invesco Stable Asset is a benefit-responsive group annuity contract issued by Invesco. By definition, the Invesco Stable Asset group annuity contract is an insurance contract. The account is credited with contributions and actual earnings and charged for participant withdrawals. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The Invesco Stable Asset is a single group annuity contract with a fixed rate of interest. It is not a portfolio of contracts whose yields are based on changes in fair value of underlying assets as would be found in a Stable Value Fund. As a result, the average yield earned by the Plan is the yield earned (i.e. interest credited) on the group annuity contract.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Invesco, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment contract.

There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on an agreed-upon formula with the issuer but cannot be less than zero. Under the terms of the existing contract, the crediting rate is currently reset on a semi-annual basis.

Certain events limit the Plan's ability to transact at contract value with Invesco. Such events include the following: (a) amendments to the Plan document (including complete or partial Plan termination or a merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974, or (e) premature termination of the contract. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with the Plan participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Investment contracts with the insurance company for the years ended December 31, 2024 and 2023 were \$23,328 and \$11,419, respectively.

6. Fair value measurement of investments

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs that reflect unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date;

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable.

Inputs are used in applying the various valuation techniques and broadly refer to the assumptions that market participants use to make valuation decisions, including assumptions about risk. Inputs may include price information, volatility statistics, specific and broad criteria data, liquidity statistics, and other factors. An investment's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. However, the determination of what constitutes "observable" requires significant judgment by the Plan. The Plan considers observable data to be that market data which is readily available, regularly distributed or updated, reliable and verifiable, not proprietary, provided by multiple, independent sources that are actively involved in the relevant market. The categorization of an investment within the hierarchy is based upon the pricing transparency of the investment and does not necessarily correspond to the Plan's perceived risk of that investment.

Registered investment company mutual fund investments are valued at quoted market prices that represent the net asset value of shares held by the Plan at year end. The change in market value of these investments is reflected in the statement of changes in net assets available for benefits as net appreciation or depreciation in fair value. The mutual funds held by the Plan are deemed to be actively traded.

7. Plan termination

Although it has not expressed any intent to do so, the Plan Administrator has the right under the Plan to discontinue its contributions at any time and to entirely terminate the Plan subject to the provisions of ERISA, which would result in the participants becoming 100% vested before receiving a final distribution from their accounts.

8. Transactions with parties-in-interest

Certain Plan investments are managed by ADP Retirement Services. Reliance is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

Indirect fees paid by the Plan for said services are included as a reduction in the net change in fair value of investments. Investment advisory and administrative expenses relating to the maintenance of the Plan are paid from the Plan assets. Direct fees paid by the Plan during the year ended December 31, 2024 were \$58,483.

The Plan Sponsor also pays for professional fees relating to services provided to the Plan. The Company paid \$10,000 in fees on behalf of the Plan for the year ended December 31, 2024. The Company also provides certain accounting and administrative services to the Plan for which no fees are charged.

9. Subsequent events

Subsequent events have been evaluated through September 16, 2025, which is the date the report was available to be issued. The Plan is not aware of any other material subsequent events.
